3 inserting in lieu thereof the following:

5 "Senate Bill No. 72, Page 10, Section 67.145, Line 10, by inserting after said section and line the
6 following:

8 "67.1850. 1. As used in this section, the following terms mean:

9 (1) "Community", any municipality or county as defined in this section;

10 (2) "County", any county form of government;

11 (3) "Geographical information system", a computerized, spatial coordinate mapping and
12 relational database technology which:

13 (a) Captures, assembles, stores, converts, manages, analyzes, amalgamates and records, in
14 the digital mode, all kinds and types of information and data;

15 (b) Transforms such information and data into intelligence and subsequently retrieves,
16 presents and distributes that intelligence to a user for use in making the intelligent decisions
17 necessary for sound management;

18 (4) "Municipality", any city located in any county.

19 2. The development of geographical information systems has not been undertaken in any
20 large-scale and useful way by private enterprise. The use of modern technology can enhance the
21 planning and decision-making processes of communities. The development of geographical
22 information systems is a time-consuming and expensive activity. In the interest of maintaining
23 community governments open and accessible to the public, information gathered by communities
24 for use in a geographical information system, unless properly made a closed record, should be
25 available to the public. However, access to the information in a way by which a person could render
26 the investment of the public in a geographical information system a special benefit to that person,
27 and not to the public, should not be permitted.

28 3. Any community as defined in this section may create a geographical information system
29 for the community. The scope of the geographical information system shall be determined by the

1 governing body of the community. The method of creation, maintenance, use and distribution of the
 2 geographical information system shall be determined by the governing body of the community. A
 3 community shall not mandate the use of this system or allocate the costs of the system to nonusers.

4 4. The information collected or assimilated by a community for use in a geographical
 5 information system shall not be withheld from the public, unless otherwise properly made a closed
 6 record of the community as provided by section 610.021. The information collected or assimilated
 7 by a community for use in a geographical information system need not be disclosed in a form which
 8 may be read or manipulated by computer, absent a license agreement between the community and
 9 the person requesting the information.

10 5. Information collected or assimilated by a community for use in a geographical
 11 information system and disclosed in any form, other than in a form which may be read or
 12 manipulated by computer, shall be provided for a reasonable fee, as established by section 610.026.
 13 A community maintaining a geographical information system shall make maps and other products
 14 of the system available to the public. The cost of the map or other product shall not exceed a
 15 reasonable fee representing the replacement cost ~~[to the community of time, equipment and~~
 16 ~~personnel in the production of the map or other product]~~ of the materials provided. A community
 17 may license the use of a geographical information system. The total cost of licensing a geographical
 18 information system may not exceed the cost, as established by section 610.026, of the:

19 (1) Cost to the community ~~[of time, equipment and personnel]~~ in the production of the
 20 information in a geographical information system or the production of the geographical information
 21 system; and

22 (2) Cost to the community of the creation, purchase, or other acquisition of the information
 23 in a geographical information system or of the geographical information system.

24 6. The provisions of this section shall not hinder the daily or routine collection of data from
 25 the geographical information system by real estate brokers and agents, title collectors, developers,
 26 surveyors, utility companies, banks, news media or mortgage companies, nor shall the provisions
 27 allow for the charging of fees for the collection of such data exceeding that allowed pursuant to
 28 section 610.026 or the reasonable replacement costs of the materials provided, whichever is less.
 29 The provisions of this section, however, shall allow a community maintaining a geographical
 30 information system to license and establish costs for the use of the system's computer program and
 31 computer software, and may also establish costs for the use of computer programs and computer
 32 software that provide access to information aggregated with geographic information system
 33 information.

34 7. A community distributing information used in a geographical information system or
 35 distributing a geographical information system shall not be liable for any damages which may arise
 36 from any error which may exist in the information or the geographical information system."; and
