"Page 3, Section 115.123, Line, 22, by inserting after all of said section and line the following:

6 "115.127. 1. Except as provided in subsection 4 of this section, upon receipt of notice of a 7 special election to fill a vacancy submitted pursuant to subsection 2 of section 115.125, the election 8 authority shall cause legal notice of the special election to be published in a newspaper of general 9 circulation in its jurisdiction. The notice shall include the name of the officer or agency calling the election, the date and time of the election, the name of the office to be filled and the date by which 10 11 candidates must be selected or filed for the office. Within one week prior to each special election to 12 fill a vacancy held in its jurisdiction, the election authority shall cause legal notice of the election to 13 be published in two newspapers of different political faith and general circulation in the jurisdiction. 14 The legal notice shall include the date and time of the election, the name of the officer or agency 15 calling the election and a sample ballot. If there is only one newspaper of general circulation in the jurisdiction, the notice shall be published in the newspaper within one week prior to the election. If 16 there are two or more newspapers of general circulation in the jurisdiction, but no two of opposite 17 18 political faith, the notice shall be published in any two of the newspapers within one week prior to 19 the election.

20 2. Except as provided in subsections 1 and 4 of this section and in sections 115.521, 115.549 21 and 115.593, the election authority shall cause legal notice of each election held in its jurisdiction to 22 be published. The notice shall be published in two newspapers of different political faith and qualified pursuant to chapter 493 which are published within the bounds of the area holding the 23 24 election. If there is only one so-qualified newspaper, then notice shall be published in only one newspaper. If there is no newspaper published within the bounds of the election area, then the 25 26 notice shall be published in two qualified newspapers of different political faith serving the area. 27 Notice shall be published twice, the first publication occurring in the second week prior to the 28 election, and the second publication occurring within one week prior to the election. Each such legal notice shall include the date and time of the election, the name of the officer or agency calling 29

1 the election and a sample ballot; and, unless notice has been given as provided by section 115.129,

the second publication of notice of the election shall include the location of polling places. The
election authority may provide any additional notice of the election it deems desirable.

3. The election authority shall print the official ballot as the same appears on the sample
ballot, and no candidate's name or ballot issue which appears on the sample ballot or official printed
ballot shall be stricken or removed from the ballot except on death of a candidate or by court order,
but in no event shall a candidate or issue be stricken or removed from the ballot less than eight
weeks before the date of the election.

9 4. In lieu of causing legal notice to be published in accordance with any of the provisions of 10 this chapter, the election authority in jurisdictions which have less than seven hundred fifty 11 registered voters and in which no newspaper qualified pursuant to chapter 493 is published, may 12 cause legal notice to be mailed during the second week prior to the election, by first class mail, to 13 each registered voter at the voter's voting address. All such legal notices shall include the date and 14 time of the election, the location of the polling place, the name of the officer or agency calling the 15 election and a sample ballot.

16 5. If the opening date for filing a declaration of candidacy for any office in a political 17 subdivision or special district is not required by law or charter, the opening filing date shall be 8:00 18 a.m., the [seventeenth] sixteenth Tuesday prior to the election. If the closing date for filing a 19 declaration of candidacy for any office in a political subdivision or special district is not required by 20 law or charter, the closing filing date shall be 5:00 p.m., the [fourteenth] thirteenth Tuesday prior to 21 the election or, if the thirteenth Tuesday prior to the election is a state or federal holiday, the closing 22 filing date shall be 5:00 p.m. on the next day that is not a state or federal holiday. The political 23 subdivision or special district calling an election shall, before the [seventeenth] sixteenth Tuesday, prior to any election at which offices are to be filled, notify the general public of the opening filing 24 date, the office or offices to be filled, the proper place for filing and the closing filing date of the 25 26 election. Such notification may be accomplished by legal notice published in at least one newspaper 27 of general circulation in the political subdivision or special district.

28 6. Except as provided for in sections 115.247 and 115.359, if there is no additional cost for 29 the printing or reprinting of ballots or if the candidate agrees to pay any printing or reprinting costs, 30 a candidate who has filed for an office or who has been duly nominated for an office may, at any 31 time after the certification of the notice of election required in subsection 1 of section 115.125 but 32 no later than 5:00 p.m. on the eighth Tuesday before the election, withdraw as a candidate pursuant 33 to a court order, which, except for good cause shown by the election authority in opposition thereto, 34 shall be freely given upon application by the candidate to the circuit court of the area of such 35 candidate's residence.

115.205. 1. No person shall be paid or otherwise compensated for soliciting voter
registration applications, other than a governmental entity or a person who is paid or compensated
by a governmental entity for such solicitation. A voter registration solicitor, other than a
governmental entity or a person who is paid or compensated by a governmental entity for such

1	solicitation, who solicits more than ten voter registration applications shall register for every
2	election cycle that begins on the day after the general election and ends on the day of the general
3	election two years later. A voter registration solicitor shall be at least eighteen years of age and shall

18	procured the applications fails to register with or submits false information to the secretary of state.
19	115.284. 1. There is hereby established an absentee voting process to assist persons with
20	permanent disabilities in the exercise of their voting rights.
21	2. The local election authority shall send an application to participate in the absentee voting
22	process set out in this section to any registered voter residing within the election authority's
23	jurisdiction upon request.

 provisional ballot envelope to indicate that the voter's identity was not verified.
- (2) No person shall be entitled to receive a provisional ballot until such person has
 completed a provisional ballot affidavit on the provisional ballot envelope. All provisional ballots
 shall be marked with a conspicuous stamp or mark that makes them distinguishable from other
 ballots.
- (3) The provisional ballot envelope shall be completed by the voter for use in determiningthe voter's eligibility to cast a ballot.
- 17 3. The provisional ballot envelope shall provide a place for the voter's name, address, date
- 18 of birth, and last four digits of his or her Social Security number, followed by a certificate in
- 19 substantially the following form:

I do solemnly swear that I am the person identified above and the information provided is correct. I understand that my vote will not be counted unless:

(1) (a) I return to this polling place today between 6:00 a.m. and 7:00 p.m. and provide one of the following forms of identification:

a. Nonexpired Missouri driver's license;

b. Nonexpired or nonexpiring Missouri nondriver's license;

c. A document that satisfies all of the following requirements:

(i) The document contains my name, in substantially the same form as the most recent signature on my voter registration record;

(ii) The document contains my photograph;

(iii) The document contains an expiration date and is not expired, or if expired, the document expired after the date of the most recent general election; and

(iv) The document was issued by the United States or the state of Missouri; or

d. Identification containing my photograph issued to me by the Missouri

National Guard, the United States Armed Forces, including Space Force, or the United States Department of Veteran Affairs as a member or former member of the Missouri National Guard or the United States Armed Forces that is not expired or does not have an expiration date; or

(b) The election authority verifies my identity by comparing my signature on this envelope to the signature on file with the election authority and determines that I was eligible to cast a ballot at this polling place; and

(2) This provisional ballot otherwise qualifies to be counted under the laws of the State of Missouri.

20	charge, if needed by an individual seeking to obtain a form of personal photo identification
21	described in subsection 1 of this section in order to vote:

- (d) A certificate of decree of adoption;
 - (e) A court order changing the person's name;
 - (f) A Social Security card reflecting an updated name; and

Any individual seeking one of the above documents in order to obtain a form of personal photo
identification described in subsection 1 of this section for voting may request the secretary of state
to facilitate the acquisition of such documents. The secretary of state shall pay any fee or fees
charged by another state or its agencies, or any court of competent jurisdiction in this state or any
other state, or the federal government or its agencies, in order to obtain any of the above documents
from such state or the federal government.

- (3) Any applicant who requests a nondriver's license for voting shall not be required to pay a
 fee. The state of Missouri shall pay the legally required fees for any such applicant. The
 department of revenue and a local election authority may enter into a contract that allows the local
 election authority to assist the department in issuing nondriver's license photo identifications.
- 17 7. The director of the department of revenue shall, by January first of each year, prepare and18 deliver to each member of the general assembly a report documenting the number of individuals
- 19 who have requested and received a nondriver's license photo identification for the purposes of
- 20 voting under this section. The report shall also include the number of persons requesting a
- 21 nondriver's license for purposes of voting under this section, but not receiving such license, and the
- 22 reason for the denial of the nondriver's license.

9. The secretary of state shall promulgate rules to effectuate the provisions of this section.

10. Any rule or portion of a rule, as that term is defined in section 536.010, that is created 1 2 under the authority delegated in this section shall become effective only if it complies with and is 3 subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and 4 chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to 5 chapter 536 to review, to delay the effective date or to disapprove and annul a rule are subsequently 6 held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after 7 August 28, 2002, shall be invalid and void.

If any voter is unable to sign his name at the appropriate place on the certificate or 9 computer printout, an election judge shall print the name and address of the voter in the appropriate 10 place on the precinct register, the voter shall make his mark in lieu of signature, and the voter's mark 11 shall be witnessed by the signature of an election judge.

12 115.430. 1. This section shall apply to [primary and general elections where candidates for 13 federal or statewide offices are nominated or elected and any election where statewide issue or 14 issues are submitted to the voters] any public election.

15 2. (1) A voter claiming to be properly registered in the jurisdiction of the election authority and eligible to vote in an election, but whose eligibility at that precinct cannot be immediately 16 17 established upon examination of the precinct register, shall be entitled to vote a provisional ballot 18 after providing a form of personal identification required pursuant to section 115.427 or upon 19 executing an affidavit under section 115.427, or may vote at a central polling place as established in 20 section 115.115 where the voter may vote his or her appropriate ballot for his or her precinct of 21 residence upon verification of eligibility or vote a provisional ballot if eligibility cannot be 22 determined. The provisional ballot provided to a voter under this section shall be the ballot 23 provided to a resident of the voter's precinct determined by reference to the affidavit provided for in 24 this section. If the voter declares that the voter is eligible to vote and the election authority 25 determines that the voter is eligible to vote at another polling place, the voter shall be directed to the 26 correct polling place or a central polling place as established by the election authority pursuant to 27 subsection 5 of section 115.115. If the voter refuses to go to the correct polling place or a central 28 polling place, the voter shall be permitted to vote a provisional ballot at the incorrect polling place, 29 but such ballot shall not be counted if the voter was not eligible to vote at that polling place. 30 (2) The following steps shall be taken to establish a voter's eligibility to vote at a polling

31 place:

32 (a) The election judge shall examine the precinct register as provided in section 115.425. If 33 the voter is registered and eligible to vote at the polling place, the voter shall receive a regular 34 ballot;

35 (b) If the voter's eligibility cannot be immediately established by examining the precinct 36 register, the election judge shall contact the election authority. If the election authority cannot 37 immediately establish that the voter is registered and eligible to vote at the polling place upon 38 examination of the Missouri voter registration system, or if the election judge is unable to make

contact with the election authority immediately, the voter shall be notified that the voter is entitled to
 a provisional ballot.

3 (3) The voter shall have the duty to appear and vote at the correct polling place. If an 4 election judge determines that the voter is not eligible to vote at the polling place at which a voter 5 presents himself or herself, and if the voter appears to be eligible to vote at another polling place, the voter shall be informed that he or she may cast a provisional ballot at the current polling place or 6 7 may travel to the correct polling place or a central polling place, as established by the election 8 authority under subsection 5 of section 115.115, where the voter may cast a regular ballot or 9 provisional ballot if the voter's eligibility still cannot be determined. Provisional ballots cast at a 10 polling place shall be counted only if the voter was eligible to vote at such polling place as provided 11 in subsection 5 of this section.

(4) For a voter requesting an absentee ballot in person, such voter shall be entitled to cast a
 provisional ballot when the voter's eligibility cannot be immediately established upon examination
 of the precinct registers or the Missouri voter registration system.

(5) Prior to accepting any provisional ballot at the polling place, the election judges shall
determine that the information provided on the provisional ballot envelope by the provisional voter
is consistent with the identification provided by such person under section 115.427.

18 3. (1) No person shall be entitled to receive a provisional ballot until such person has19 completed a provisional ballot affidavit on the provisional ballot envelope.

(2) (2) The secretary of state shall produce appropriate sizes of provisional ballot envelopes and distribute them to each election authority according to their tabulating system. All provisional ballot envelopes shall be printed on a distinguishable color of paper that is different from the color of the regular ballot. The provisional ballot envelope shall be in the form required by subsection 4 of this section. All provisional ballots shall be marked with a conspicuous stamp or other distinguishing mark that makes them readily distinguishable from the regular ballots.

26 (3) Once voted, the provisional ballot shall be placed and sealed in a provisional ballot27 envelope.

4. The provisional ballot in its envelope shall be deposited in the ballot box. The

29 provisional ballot envelope shall be completed by the voter for use in determining eligibility. The

30 provisional ballot envelope specified in this section shall contain a voter's certificate which shall be

- 5. (1) Prior to counting any provisional ballot, the election authority shall determine if the
 voter is registered and eligible to vote and if the vote was properly cast. The eligibility of
 provisional votes shall be determined according to the requirements for a voter to cast a ballot in the
 election as set forth in sections 115.133 and 115.135. A provisional [voter] ballot shall not be
 eligible to be counted until the election authority has determined that:
 (a) The voter cast such provisional ballot at a polling place established for the voter or the
 central polling place established by the election authority under subsection 5 of section 115.115;
- (b) The individual who cast the provisional ballot is an individual registered to vote in the
 respective election at the polling place where the ballot was cast;
- 13 (c) The voter did not otherwise vote in the same election by regular ballot, absentee ballot,
 14 or otherwise; and
- 15 (d) The information on the provisional ballot envelope is found to be correct, complete, andaccurate.
- 17 (2) When the ballot boxes are delivered to the election authority from the polling places, the 18 receiving teams shall separate the provisional ballots from the rest of the ballots and place the sealed 19 provisional ballot envelopes in a separate container. Teams of election authority employees or 20 teams of election judges with each team consisting of one member of each major political party 21 shall photocopy each provisional ballot envelope, such photocopy to be used by the election 22 authority to determine provisional voter eligibility. The sealed provisional ballot envelopes shall be
- 23 placed by the team in a sealed container and shall remain therein until tabulation.

- (3) To determine whether a provisional ballot is valid and entitled to be counted, the election 1 2 authority shall examine its records and verify that the provisional voter is properly registered and 3 eligible to vote in the election. If the provisional voter has provided information regarding the 4 registration agency where the provisional voter registered to vote, the election authority shall make 5 an inquiry of the registration agency to determine whether the provisional voter is properly 6 registered and eligible to vote in the election.
- 7 (4) If the election authority determines that the provisional voter is registered and eligible to 8 vote in the election, the election authority shall provide documentation verifying the voter's 9 eligibility. Such documentation shall be noted on the copy of the provisional ballot envelope and 10 shall contain substantially the following information:

Such documentation shall be noted on the copy of the provisional ballot envelope and 20 shall contain substantially the following information:

- (7) The local election authority shall record on a provisional ballot acceptance/rejection list 25 26 the provisional ballot identification number and notation marking it as rejected.

27 (8) If rejected, a photocopy of the envelope shall be made and used by the election authority 28 as a mail-in voter registration. The actual provisional ballot envelope shall be kept as ballot

29 material, and the copy of the envelope shall be used by the election authority for registration record 30 keeping.

31 6. All provisional ballots cast by voters whose eligibility has been verified as provided in 32 this section shall be counted in accordance with the rules governing ballot tabulation. Provisional 33 ballots shall not be counted until all provisional ballots are determined either eligible or ineligible 34 and all provisional ballots must be processed before the election is certified. The provisional ballot shall be counted only if the election authority determines that the voter is registered and eligible to 35 36 vote. Provisional ballots voted in the wrong polling place shall not be counted. If the voter is not 37 registered but is qualified to register for future elections, the affidavit shall be considered a mail-in

38 application to register to vote pursuant to this chapter.

7. (1) After the election authority completes its review of the provisional voter's eligibility 1 2 under subsection 5 of this section, the election authority shall deliver the provisional ballots and 3 copies of the provisional ballot envelopes that include eligibility information to bipartisan counting 4 teams, which may be the board of verification, for review and tabulation. The election authority 5 shall maintain a record of such delivery. The record shall include the number of ballots delivered to 6 each team and shall include a signed receipt from two judges, one from each major political party. 7 The election authority shall provide each team with a ballot box and material necessary for 8 tabulation.

9 (2) If the person named on the provisional ballot affidavit is found to have been properly 10 qualified and registered to cast a ballot in the election and the provisional ballot otherwise qualifies 11 to be counted under the provisions of this section, the envelope shall be opened, and the ballot shall 12 be placed in a ballot box to be counted.

13 (3) If the person named on the provisional ballot affidavit is found not to have been properly 14 gualified and registered to cast a ballot in the election or if the election authority is unable to 15 determine such person's right to vote, the envelope containing the provisional ballot shall not be 16 opened, and the person's vote shall not be counted. The members of the team shall follow the 17 procedures set forth in subsection 5 of this section for rejected provisional ballots.

18 (4) The votes shall be tallied and the returns made as provided in sections 115.447 to 19 115.525 for paper ballots. After the vote on all ballots assigned to a team have been counted, the 20 ballots, ballot envelopes, and copies of ballot envelopes with the eligibility information provided by 21 the election authority shall be enclosed in sealed containers marked "Voted provisional ballots and 22 ballot envelopes from the election held , 20 ". All rejected provisional ballots, ballot 23 envelopes, and copies of ballot envelopes with the eligibility information provided by the election 24 authority shall be enclosed in sealed containers marked "Rejected provisional ballots and ballot envelopes from the election held , 20 ". On the outside of each voted ballot and 25 26 rejected ballot container, each member of the team shall write their name and all such containers 27 shall be returned to the election authority. Upon receipt of the returns and ballots, the election 28 authority shall tabulate the provisional votes.

29 8. Challengers and watchers, as provided by sections 115.105 and 115.107, may be present 30 during all times that the bipartisan counting teams are reviewing or counting the provisional ballots, 31 the provisional ballot envelopes, or copies of the provisional ballot envelopes that include eligibility 32 information provided by the election authority. Challengers and watchers shall be permitted to 33 observe the determination of the eligibility of all provisional ballots. The election authority shall 34 notify the county chair of each major political party of the time and location when bipartisan 35 counting teams will be reviewing or counting the provisional ballots, the provisional ballot 36 envelopes, or the copies of the provisional ballot envelopes that include the eligibility information provided by the election authority. 37

(1) Reflect the number of provisional envelopes delivered; and

1 (2) Reflect the number of sealed provisional envelopes with voted ballots deposited in the 2 ballot box.

3 10. In counties where the voting system does not utilize a paper ballot, the election authority4 shall provide the appropriate provisional ballots to each polling place.

11. The secretary of state may promulgate rules for purposes of ensuring the uniform
application of this section. No rule or portion of a rule promulgated pursuant to the authority of this
section shall become effective unless it has been promulgated pursuant to chapter 536.

8 12. The secretary of state shall design and provide to the election authorities the envelopes9 and forms necessary to carry out the provisions of this section.

10 13. Pursuant to the Help America Vote Act of 2002, the secretary of state shall ensure a free 11 access system is established, such as a toll-free number or an internet website, that any individual 12 who casts a provisional ballot may access to discover whether the vote of that individual was 13 counted, and, if the vote was not counted, the reason that the vote was not counted. At the time an 14 individual casts a provisional ballot, the election authority shall give the voter written information 15 that states that any individual who casts a provisional ballot will be able to ascertain under such free 16 access system whether the vote was counted, and if the vote was not counted, the reason that the 17 vote was not counted.

18 14. In accordance with the Help America Vote Act of 2002, any individual who votes in an 19 election as a result of a court order or any other order extending the time established for closing the 20 polls in section 115.407 may vote only by using a provisional ballot, and such provisional ballot 21 shall be separated and held apart from other provisional ballots cast by those not affected by the 22 order. Such ballots shall not be counted until such time as the ballots are determined to be valid. 23 No state court shall have jurisdiction to extend the polling hours established by law, including 24 section 115.407.

(12) On the part of any election authority or official, willfully neglecting, refusing, or

(14) On the part of any voter, except as otherwise provided by law, allowing his or her ballot
to be seen by any person with the intent of letting it be known how he or she is about to vote or has
voted, or knowingly making a false statement as to his or her inability to mark a ballot;

10 (15) On the part of any election judge, disclosing to any person the name of any candidate11 for whom a voter has voted;

(16) Interfering, or attempting to interfere, with any voter inside a polling place;

(17) On the part of any person at any registration site, polling place, counting location or
 verification location, causing any breach of the peace or engaging in disorderly conduct, violence, or
 threats of violence whereby such registration, election, count or verification is impeded or interfered
 with;

17 (18) Exit polling, surveying, sampling, circulating initiative or referendum petitions, 18 electioneering, distributing election literature, posting signs or placing vehicles bearing signs with 19 respect to any candidate or question to be voted on at an election [on election day] inside the building in which a polling place is located on election day or during the absentee voting period or 20 21 within twenty-five feet of the building's outer door closest to the polling place on election day or 22 during the absentee voting period, or, on the part of any person, refusing to remove or permit 23 removal from property owned or controlled by such person, any such election sign or literature located within such distance on such day after request for removal by any person; 24

(19) Stealing or willfully defacing, mutilating, or destroying any campaign yard sign on private property, except that this subdivision shall not be construed to interfere with the right of any private property owner to take any action with regard to campaign yard signs on the owner's property and this subdivision shall not be construed to interfere with the right of any candidate, or the candidate's designee, to remove the candidate's campaign yard sign from the owner's private property after the election day."; and
