The policy shall require that any portion 5 of a student's individualized education program that is related to demonstrated or potentially violent 6 7 behavior shall be provided to any teacher and other school district employees who are directly 8 responsible for the student's education or who otherwise interact with the student on an educational 9 basis while acting within the scope of their assigned duties. The policy shall also contain the 10 consequences of failure to obey standards of conduct set by the local board of education, and the 11 importance of the standards to the maintenance of an atmosphere where orderly learning is possible 12 and encouraged.

3. The policy shall provide that any student who is on suspension for any of the offenses listed in subsection 2 of this section or any act of violence or drug-related activity defined by school district policy as a serious violation of school discipline pursuant to subsection 9 of this section shall have as a condition of his or her suspension the requirement that such student is not allowed, while on such suspension, to be within one thousand feet of any school property in the school district where such student attended school or any activity of that district, regardless of whether or not the activity takes place on district property unless:

 custodian and the superintendent or the superintendent's designee has authorized the student to be on
 school property;

(2) Such student is under the direct supervision of another adult designated by the student's
parent, legal guardian, or custodian, in advance, in writing, to the principal of the school which
suspended the student and the superintendent or the superintendent's designee has authorized the
student to be on school property;

(3) Such student is enrolled in and attending an alternative school that is located within onethousand feet of a public school in the school district where such student attended school; or

(4) Such student resides within one thousand feet of any public school in the school district
where such student attended school in which case such student may be on the property of his or her
residence without direct adult supervision.

32 4. Any student who violates the condition of suspension required pursuant to subsection 3 of 33 this section may be subject to expulsion or further suspension pursuant to the provisions of sections 34 167.161, 167.164, and 167.171. In making this determination consideration shall be given to 35 whether the student poses a threat to the safety of any child or school employee and whether such student's unsupervised presence within one thousand feet of the school is disruptive to the 36 educational process or undermines the effectiveness of the school's disciplinary policy. 12 (2) This section shall not prevent the school district from providing educational services in13 an alternative setting to a student suspended under the provisions of this section.

14 6. For the purpose of this section, the term "weapon" shall mean a firearm as defined under 15 18 U.S.C. Section 921 and the following items, as defined in section 571.010: a blackjack, a 16 concealable firearm, an explosive weapon, a firearm, a firearm silencer, a gas gun, a knife, knuckles, 17 a machine gun, a projectile weapon, a rifle, a shotgun, a spring gun or a switchblade knife; except 18 that this section shall not be construed to prohibit a school board from adopting a policy to allow a 19 Civil War reenactor to carry a Civil War era weapon on school property for educational purposes so 20 long as the firearm is unloaded. property of the school, on any school bus going to or returning from school, during schoolsponsored activities, or during intermission or recess periods.

Teachers and other authorized district personnel in public schools responsible for the care, 28 supervision, and discipline of schoolchildren, including volunteers selected with reasonable care by 29 the school district, shall not be civilly liable when acting in conformity with the established policies 30 developed by each board, including but not limited to policies of student discipline or when 31 reporting to his or her supervisor or other person as mandated by state law acts of school violence or 32 threatened acts of school violence, within the course and scope of the duties of the teacher, 33 authorized district personnel or volunteer, when such individual is acting in conformity with the 34 established policies developed by the board. Nothing in this section shall be construed to create a 35 new cause of action against such school district, or to relieve the school district from liability for the

shall include but not be limited to exertion of physical force by a student with the intent to do

serious bodily harm to another person while on school property, including a school bus in service on 1 2 behalf of the district, or while involved in school activities. School districts shall for each student 3 enrolled in the school district compile and maintain records of any serious violation of the district's 4 discipline policy. Such records shall be made available to teachers and other school district 5 employees with a need to know while acting within the scope of their assigned duties, and shall be 6 provided as required in section 167.020 to any school district in which the student subsequently 7 attempts to enroll. 8 10. Spanking, when administered by certificated personnel and in the presence of a witness

9 who is an employee of the school district, or the use of reasonable force to protect persons or
10 property, when administered by personnel of a school district in a reasonable manner in accordance
11 with the local board of education's written policy of discipline, is not abuse within the meaning of
12 chapter 210.

13 11. Upon receipt of any reports of child abuse by the children's division pursuant to sections 14 210.110 to 210.165 which allegedly involve personnel of a school district, the children's division 15 shall notify the superintendent of schools of the district or, if the person named in the alleged 16 incident is the superintendent of schools, the president of the school board of the school district 17 where the alleged incident occurred.

In order to ensure the safety of all students, should a student be expelled for bringing a 19 weapon to school, violent behavior, or for an act of school violence, that student shall not, for the 20 purposes of the accreditation process of the Missouri school improvement plan, be considered a 21 dropout or be included in the calculation of that district's educational persistence ratio.

160.263. 1. As used in this section, the following terms mean:

(1) "Mechanical restraint", the use of any device or equipment to restrict a student's freedom
 of movement. Mechanical restraint shall not include devices implemented by trained personnel or
 used by a student with a prescription for such devices from an appropriate medical or related
 services professional and that are used for specific and approved purposes for which such devices
 were designed, such as the following:

(a) Adaptive devices or mechanical supports used to achieve proper body position, balance,
or alignment to allow greater freedom of mobility than would be possible without the use of such
devices or mechanical supports;

31 (b) Vehicle safety restraints when used as intended during the transport of a student in a
 32 moving vehicle;

- (c) Restraints for medical immobilization; or

34 (d) Orthopedically prescribed devices that permit a student to participate in activities
35 without risk;

36 (2) "Physical restraint", a personal restriction such as person-to-person physical contact that 37 immobilizes, reduces, or restricts the ability of a student to move the student's torso, arms, legs, or

38 head freely. Physical restraint shall not include:

1	(a) A physical escort, which is a temporary touching or holding of the hand, wrist, arm,
2	shoulder, or back for the purpose of inducing a student to walk to a safe location;
3	(b) Comforting or calming a student;
4	(c) Holding a student's hand to transport the student for safety purposes;
5	(d) Intervening in a fight; or
6	(e) Using an assistive or protective device prescribed by an appropriately trained
7	professional or professional team;
8	(3) "Prone restraint", using mechanical or physical restraint or both to restrict a student's
9	movement while the student is lying with the student's front or face downward;
10	(4) "Restraint" includes, but is not limited to, mechanical restraint, physical restraint, and
11	prone restraint;
12	(5) "Seclusion", the involuntary confinement of a student alone in a room or area that the
13	student is physically prevented from leaving and that complies with the building code in effect in the
14	school district. Seclusion shall not include the following:
15	(a) A timeout, which is a behavior management technique that is part of an approved
16	program, involves the monitored separation of the student in a nonlocked setting, and is
17	implemented for the purpose of calming;
18	(b) In-school suspension;
19	(c) Detention; or
20	(d) Other appropriate disciplinary measures.
21	2. The school discipline policy under section 160.261 shall reserve confining a student in
22	seclusion for situations or conditions in which there is imminent danger of physical harm to self or
23	others.
24	3. For all school years beginning on or after July 1, 2022, no school district, charter school,
25	or publicly contracted private provider shall use any mechanical, physical, or prone restraint
26	technique that:
27	(1) Obstructs views of the student's face;
28	(2) Obstructs the student's respiratory airway, impairs the student's breathing or respiratory
29	capacity, or restricts the movement required for normal breathing to cause positional or postural
30	asphyxia;
31	(3) Places pressure or weight on or causes the compression of the student's chest, lungs,
32	sternum, diaphragm, back, abdomen, or genitals;
33	(4) Obstructs the student's circulation of blood;
34	(5) Involves pushing on or into the student's mouth, nose, eyes, or any part of the face or
35	involves covering the face or body with anything including, but not limited to, soft objects such as
36	pillows, blankets, or washcloths;
37	(6) Endangers the student's life or significantly exacerbates the student's medical condition;
38	(7) Is purposely designed to inflict pain;

1 (8) Restricts the student from communicating. If an employee physically restrains a student 2 who uses sign language or an augmentative mode of communication as the student's primary mode 3 of communication, the student shall be permitted to have the student's hands free of restraint for 4 brief periods unless an employee determines that such freedom appears likely to result in harm to 5 self or others.

4. (1) By July 1, 2011, the local board of education of each school district shall adopt a
written policy that comprehensively addresses the use of restrictive behavioral interventions as a
form of discipline or behavior management technique. The policy shall be consistent with
professionally accepted practices and standards of student discipline, behavior management, health
and safety, including the safe schools act. The policy shall include but not be limited to:

(a) Definitions of restraint, seclusion, and time-out and any other terminology necessary to
 describe the continuum of restrictive behavioral interventions available for use or prohibited in the
 district, consistent with the provisions of this section;

(b) Description of circumstances under which a restrictive behavioral intervention is
 allowed and prohibited, consistent with the provisions of this section, and any unique application
 requirements for specific groups of students such as differences based on age, disability, or
 environment in which the educational services are provided;

(c) Specific implementation requirements associated with a restrictive behavioral
 intervention such as time limits, facility specifications, training requirements or supervision
 requirements; and

(d) Documentation, notice and permission requirements associated with use of a restrictive
 behavioral intervention.

(2) Before July 1, 2022, each written policy adopted under this subsection shall be updated
 to prohibit the school district, charter school, or publicly contracted private provider from using any
 restraint that employs any technique listed in subsection 3 of this section.

(3) Before July 1, 2022, each written policy adopted under this subsection shall be updated
to state that the school district, charter school, or publicly contracted private provider will reserve
restraint or seclusion for situations or conditions in which there is imminent danger of physical harm
to self or others.

5. Before July 1, 2022, each school district, charter school, and publicly contracted private
provider shall ensure that the policy adopted under subsection 4 of this section requires the
following:

(1) Any student placed in seclusion or restraint shall be removed from such seclusion or
 restraint as soon as the school district, charter school, or publicly contracted private provider
 determines that the student is no longer an imminent danger of physical harm to self or others;
 (2) All school district, charter school, and publicly contracted private provider personnel

21	h. The name of an employee to contact if the parent or guardian wishes to file a complaint;
22	and
23	i. A statement directing parents and legal guardians to a sociological, emotional, or
24	behavioral support organization and a hotline number to report child abuse and neglect.
25	(b) The school district, charter school, or publicly contracted private provider shall maintain
26	the report as an education record of the student, provide a copy to the parent or legal guardian within
27	five school days, and a copy of each incident report shall be given to the department of elementary
28	and secondary education within thirty days of the incident;
29	(4) The school district, charter school, or publicly contracted private provider shall attempt
30	to notify the parents or legal guardians as soon as possible but no later than one hour after the end of

33	contracted private provider will provide the parents or legal guardians a copy of the report described

"Bullying" means intimidation, unwanted aggressive behavior, or harassment that is 19 repetitive or is substantially likely to be repeated and causes a reasonable student to fear for his or 20 her physical safety or property; substantially interferes with the educational performance, 21 opportunities, or benefits of any student without exception; or substantially disrupts the orderly 22 operation of the school. Bullying may consist of physical actions, including gestures, or oral, 23 cyberbullying, electronic, or written communication, and any threat of retaliation for reporting of 24 such acts. Bullying of students is prohibited on school property, at any school function, or on a 25 school bus. "Cyberbullying" means bullying as defined in this subsection through the transmission 26 of a communication including, but not limited to, a message, text, sound, or image by means of an 27 electronic device including, but not limited to, a telephone, wireless telephone, or other wireless 28 communication device, computer, or pager. 29 3. Each district's antibullying policy shall be founded on the assumption that all students 30 need a safe learning environment. Policies shall treat all students equally and shall not contain 31 specific lists of protected classes of students who are to receive special treatment. Policies may 32 include age-appropriate differences for schools based on the grade levels at the school. Each such 33 policy shall contain a statement of the consequences of bullying. 34 4. Each district's antibullying policy shall be included in the student handbook and shall 35 require, at a minimum, the following components: 36 (1) A statement prohibiting bullying, defined no less inclusively than in subsection 2 of this 37 section; 38 (2) A statement requiring district employees to report any instance of bullying of which the 39 employee has firsthand knowledge. The policy shall require a district employee who witnesses an

1	incident of bullying to report the incident to the district's designated individual at the school within
2	two school days of the employee witnessing the incident;
3	(3) A procedure for reporting an act of bullying. The policy shall also include a statement

control. The provisions of this paragraph shall not be construed to contradict or limit any other
provision of this section; and

6 (e) The administration of the school district shall implement programs and other initiatives 7 to address bullying, to respond to such conduct in a manner that does not stigmatize the victim, and 8 to make resources or referrals available to victims of bullying.

9 5. Notwithstanding any other provision of law to the contrary, any school district shall have jurisdiction to prohibit cyberbullying that originates on a school's campus or at a district activity if the electronic communication was made using the school's technological resources, if there is a sufficient nexus to the educational environment, or if the electronic communication was made on the school's campus or at a district activity using the student's own personal technological resources. The school district may discipline any student for such cyberbullying to the greatest extent allowed by law.

6. Each district shall review its antibullying policy and revise it as needed. The district's
school board shall receive input from school personnel, students, and administrators when reviewing
