[Each applicant for a license to practice funeral directing shall furnish 6 evidence to establish to the satisfaction of the board that he or she is at least eighteen years of age, 7 and possesses a high school diploma, a general equivalency diploma, or equivalent thereof, as 8 determined, at its discretion, by the board. 9 2. Every person desiring to enter the profession of embalming dead human bodies within the 10 state of Missouri and who is enrolled in a program accredited by the American Board of Funeral 11 Service Education, any successor organization, or other accrediting entity as approved by the board 12 shall register with the board as a practicum student upon the form provided by the board. After such 13 registration, a student may assist, under the direct supervision of Missouri licensed embalmers and 14 funeral directors, in Missouri licensed funeral establishments, while serving his or her practicum. The form for registration as a practicum student shall be accompanied by a fee in an amount 15 established by the board. 16 17 3.] Each applicant for a student license to practice embalming shall submit an application to the state board of embalmers and funeral directors, pay all application fees, and furnish evidence to 18 establish to the satisfaction of the board that he or she: 19 20 (1) Is at least eighteen years of age, and possesses a high school diploma, a general 21 equivalency diploma, or equivalent thereof, as determined, at its discretion, by the board; and 22 (2) Is currently enrolled in a funeral service education program or has completed a funeral 23 service education program accredited by the American Board of Funeral Service Education, any successor organization, or other accrediting entity as approved by the board. [If an applicant does 24 25 not complete all requirements for licensure within five years from the date of his or her completion 26 of an accredited program, his or her registration as an apprentice embalmer shall be automatically 27 cancelled. The applicant shall be required to file a new application and pay applicable fees. No previous apprenticeship shall be considered for the new application; 28 29 (3)Upon due examination administered by the board, is possessed of a knowledge of the 30 subjects of embalming, anatomy, pathology, bacteriology, mortuary administration, chemistry,

1 restorative art, together with statutes, rules and regulations governing the care, custody, shelter and 2 disposition of dead human bodies and the transportation thereof or has passed the national board 3 examination of the Conference of Funeral Service Examining Boards. If any applicant fails to pass 4 the state examination, he or she may retake the examination at the next regular examination 5 meeting. The applicant shall notify the board office of his or her desire to retake the examination at 6 least thirty days prior to the date of the examination. Each time the examination is retaken, the 7 applicant shall pay a new examination fee in an amount established by the board; 8 (4)Has been employed full time in funeral service in a licensed funeral establishment and has personally embalmed at least twenty-five dead human bodies under the personal supervision of an 9 10 embalmer who holds a current and valid Missouri embalmer's license during an apprenticeship of not less than twelve consecutive months. "Personal supervision" means that the licensed embalmer 11 12 shall be physically present during the entire embalming process in the first six months of the 13 apprenticeship period and physically present at the beginning of the embalming process and 14 available for consultation and personal inspection within a period of not more than one hour in the 15 remaining six months of the apprenticeship period. All transcripts and other records filed with the board shall become a part of the board files. 16 17 2. After a student's application has been approved by the board, student licensees who are 18 enrolled in a funeral service education program may assist, under the direct supervision of an 19 embalmer licensed under this chapter, in an establishment licensed for embalming under this chapter. Student licensees shall not assist when not under such supervision. 20 21 3. In order to be eligible for full licensure, a student licensee shall, after completing a 22 funeral service education program accredited by the American Board of Funeral Service Education 23 or any successor organization or any other accrediting entity as approved by the board: 24 (1) Demonstrate that he or she has completed a qualifying apprenticeship of no less than six 25 months and has personally embalmed at least twenty-five dead human bodies under the direct 26 supervision of an embalmer who is licensed under this chapter; and 27 (2) Pass the National Board or State Board Science examination and the Missouri law 28 examination. 29 4. If the applicant does not complete the application process within the five years after his or 30 her completion of an approved program, then he or she must file a new application and no fees paid 31 previously shall apply toward the license fee. 32 5. Examinations required by this section and section 333.042 shall be held at least twice a 33 year at times and places fixed by the board. The board shall by rule and regulation prescribe the 34 standard for successful completion of the examinations. 35 6. (1) Upon establishment of his or her qualifications as specified by this section [or section 36 333.042], the board shall issue to the applicant a license to practice funeral [directing or] embalming[, as the case may require,] and shall register the applicant as a [duly licensed funeral 37 38 director or a] duly licensed embalmer. Any person having the qualifications required by this section

and section 333.042 may be granted both a license to practice funeral directing and to practice 1 2 embalming. 3 (2) Any person licensed under this subsection may, at his or her election, at any time, sit for the National Board or State Board Arts examination for the purpose of potential reciprocity with any 4 5 other state that may require such examination. 6 7. [The board shall, upon request, waive any requirement of this chapter and issue a 7 temporary funeral director's license, valid for six months, to the surviving spouse or next of kin or 8 the personal representative of a licensed funeral director, or to the spouse, next of kin, employee or conservator of a licensed funeral director disabled because of sickness, mental incapacity or injury] 9 10 For purposes of this section, the following terms mean: (1) "Direct supervision", supervision in which the licensed embalmer is physically present 11 12 with the apprentice and the dead human body at the beginning of the embalming and within the 13 same building in which the embalming is taking place for the entire embalming; (2) "Qualifying apprenticeship", an apprenticeship in which the applicant devotes at least 14 thirty hours each week to his or her duties as an apprentice under the direct supervision of an 15 embalmer licensed under this chapter in a funeral establishment licensed to embalm dead human 16 17 bodies. 18 333.042. 1. [Every person desiring to enter the profession of funeral directing in this state 19 shall make application with the state board of embalmers and funeral directors and pay the current 20 application and examination fees. Except as otherwise provided in section 41.950, applicants not 21 entitled to a license pursuant to section 333.051 or 324.009 shall serve an apprenticeship for at least 22 twelve consecutive months in a funeral establishment licensed for the care and preparation for burial 23 and transportation of the human dead in this state or in another state which has established standards for admission to practice funeral directing equal to, or more stringent than, the requirements for 24 25 admission to practice funeral directing in this state. The applicant shall devote at least fifteen hours 26 per week to his or her duties as an apprentice under the supervision of a Missouri licensed funeral director. Such applicant shall submit proof to the board, on forms provided by the board, that the 27 28 applicant has arranged and conducted ten funeral services during the applicant's apprenticeship under the supervision of a Missouri licensed funeral director. Upon completion of the 29 30 apprenticeship, the applicant shall appear before the board to be tested on the applicant's legal and 31 practical knowledge of funeral directing, funeral home licensing, preneed funeral contracts and the 32 care, custody, shelter, disposition and transportation of dead human bodies. Upon acceptance of the 33 application and fees by the board, an applicant shall have twenty-four months to successfully 34 complete the requirements for licensure found in this section or the application for licensure shall be 35 cancelled. 36 2. If a person applies for a limited license to work only in a funeral establishment which is licensed only for cremation, including transportation of dead human bodies to and from the funeral 37 38 establishment, he or she shall make application, pay the current application and examination fee and 39 successfully complete the Missouri law examination. He or she shall be exempt from the twelve-

month apprenticeship required by subsection 1 of this section and the practical examination before 1 2 the board. If a person has a limited license issued pursuant to this subsection, he or she may obtain a 3 full funeral director's license if he or she fulfills the apprenticeship and successfully completes the 4 funeral director practical examination. 5 3. If an individual is a Missouri licensed embalmer or has completed a program accredited 6 by the American Board of Funeral Service Education, any successor organization, or other 7 accrediting entity as approved by the board or has successfully completed a course of study in 8 funeral directing offered by an institution accredited by a recognized national, regional or state accrediting body and approved by the state board of embalmers and funeral directors, and desires to 9 10 enter the profession of funeral directing in this state, the individual shall comply with all the requirements for licensure as a funeral director pursuant to subsection 1 of section 333.041 and 11 12 subsection 1 of this section; however, the individual is exempt from the twelve-month 13 apprenticeship required by subsection 1 of this section] Every person desiring to engage in the 14 practice of funeral directing as an apprentice in this state shall obtain a provisional funeral director license from the board. To apply for a provisional license, the applicant shall submit an application 15 to the state board of embalmers and funeral directors, pay the current application fees, and furnish 16 17 evidence to establish to the satisfaction of the board that he or she: 18 (1) Is at least eighteen years of age; and 19 (2) Will work as an apprentice funeral director under personal supervision of a funeral director licensed under this chapter. The applicant shall provide to the board the name and license 20 21 number of the funeral director who will perform his or her supervision and the location where the 22 applicant will practice. 23 2. An applicant for a provisional funeral director license under subsection 1 of this section 24 shall have twenty-four months to complete the requirements for licensure under this section. If the 25 applicant fails to complete the requirements within such period, the application for licensure shall be 26 cancelled. If the application is cancelled, the applicant shall be required to file a new application and pay applicable fees. No previous apprenticeship shall be considered for the new application. 27 28 3. Every person desiring to enter the profession of funeral directing in this state shall submit 29 an application to the state board of embalmers and funeral directors, pay the current application fees, 30 and furnish evidence to establish to the satisfaction of the board that he or she: (1) Is at least eighteen years of age and possesses a high school diploma, a general 31 32 equivalency diploma, or equivalent thereof, as determined, at its discretion, by the board; 33 (2) Has passed the Missouri law examination; and 34 (3) Has: 35 (a) Passed the National Board or State Board Arts examination and successfully completed 36 a program accredited by the American Board of Funeral Service Education or any successor 37 organization or any other accrediting entity as approved by the board; 38 (b) Passed the National Board or State Board Arts examination and successfully completed 39 a course of study in funeral directing offered by an institution accredited by a recognized national,
