9 ~~2. Every person desiring to enter the profession of embalming dead human bodies within the~~
10 ~~state of Missouri and who is enrolled in a program accredited by the American Board of Funeral~~
11 ~~Service Education, any successor organization, or other accrediting entity as approved by the board~~
12 ~~shall register with the board as a practicum student upon the form provided by the board. After such~~
13 ~~registration, a student may assist, under the direct supervision of Missouri licensed embalmers and~~
14 ~~funeral directors, in Missouri licensed funeral establishments, while serving his or her practicum.~~
15 ~~The form for registration as a practicum student shall be accompanied by a fee in an amount~~
16 ~~established by the board.~~

17 ~~3.] Each applicant for a student license to practice embalming shall submit an application to
18 the state board of embalmers and funeral directors, pay all application fees, and furnish evidence to
19 establish to the satisfaction of the board that he or she:~~

20 (1) Is at least eighteen years of age, and possesses a high school diploma, a general
21 equivalency diploma, or equivalent thereof, as determined, at its discretion, by the board; and

22 (2) Is currently enrolled in a funeral service education program or has completed a funeral
23 service education program accredited by the American Board of Funeral Service Education, any
24 successor organization, or other accrediting entity as approved by the board. [~~If an applicant does~~
25 ~~not complete all requirements for licensure within five years from the date of his or her completion~~
26 ~~of an accredited program, his or her registration as an apprentice embalmer shall be automatically~~
27 ~~cancelled. The applicant shall be required to file a new application and pay applicable fees. No~~

 4 ~~the state examination, he or she may retake the examination at the next regular examination~~

 6 ~~least thirty days prior to the date of the examination. Each time the examination is retaken, the~~
 7 ~~applicant shall pay a new examination fee in an amount established by the board;~~

8 ~~(4) Has been employed full time in funeral service in a licensed funeral establishment and has~~
 9 ~~personally embalmed at least twenty-five dead human bodies under the personal supervision of an~~
 10 ~~embalmer who holds a current and valid Missouri embalmer's license during an apprenticeship of~~
 11 ~~not less than twelve consecutive months. "Personal supervision" means that the licensed embalmer~~
 12 ~~shall be physically present during the entire embalming process in the first six months of the~~
 13 ~~apprenticeship period and physically present at the beginning of the embalming process and~~
 14 ~~available for consultation and personal inspection within a period of not more than one hour in the~~
 15 ~~remaining six months of the apprenticeship period. All transcripts and other records filed with the~~
 16 ~~board shall become a part of the board files. -]~~

17 2. After a student's application has been approved by the board, student licensees who are
 18 enrolled in a funeral service education program may assist, under the direct supervision of an
 19 embalmer licensed under this chapter, in an establishment licensed for embalming under this
 20 chapter. Student licensees shall not assist when not under such supervision.

21 3. In order to be eligible for full licensure, a student licensee shall, after completing a
 22 funeral service education program accredited by the American Board of Funeral Service Education
 23 or any successor organization or any other accrediting entity as approved by the board:

24 (1) Demonstrate that he or she has completed a qualifying apprenticeship of no less than six
 25 months and has personally embalmed at least twenty-five dead human bodies under the direct
 26 supervision of an embalmer who is licensed under this chapter; and

27 (2) Pass the National Board or State Board Science examination and the Missouri law
 28 examination.

29 4. If the applicant does not complete the application process within the five years after his or
 30 her completion of an approved program, then he or she must file a new application and no fees paid
 31 previously shall apply toward the license fee.

32 5. Examinations required by this section and section 333.042 shall be held at least twice a
 33 year at times and places fixed by the board. The board shall by rule and regulation prescribe the
 34 standard for successful completion of the examinations.

35 6. (1) Upon establishment of his or her qualifications as specified by this section [~~or section~~
 36 ~~333.042~~], the board shall issue to the applicant a license to practice funeral [~~directing or~~
 37 ~~embalming~~], ~~as the case may require,~~ and shall register the applicant as a [~~duly licensed funeral~~
 38 ~~director or a~~] duly licensed embalmer. Any person having the qualifications required by this section

1 and section 333.042 may be granted both a license to practice funeral directing and to practice
2 embalming.

3 (2) Any person licensed under this subsection may, at his or her election, at any time, sit for
4 the National Board or State Board Arts examination for the purpose of potential reciprocity with any
5 other state that may require such examination.

6 ~~7. [The board shall, upon request, waive any requirement of this chapter and issue a~~
7 ~~temporary funeral director's license, valid for six months, to the surviving spouse or next of kin or~~
8 ~~the personal representative of a licensed funeral director, or to the spouse, next of kin, employee or~~
9 ~~conservator of a licensed funeral director disabled because of sickness, mental incapacity or injury]~~
10 For purposes of this section, the following terms mean:

11 (1) "Direct supervision", supervision in which the licensed embalmer is physically present
12 with the apprentice and the dead human body at the beginning of the embalming and within the
13 same building in which the embalming is taking place for the entire embalming;

14 (2) "Qualifying apprenticeship", an apprenticeship in which the applicant devotes at least
15 thirty hours each week to his or her duties as an apprentice under the direct supervision of an
16 embalmer licensed under this chapter in a funeral establishment licensed to embalm dead human
17 bodies.

18 ~~333.042. 1. [Every person desiring to enter the profession of funeral directing in this state~~
19 ~~shall make application with the state board of embalmers and funeral directors and pay the current~~
20 ~~application and examination fees. Except as otherwise provided in section 41.950, applicants not~~
21 ~~entitled to a license pursuant to section 333.051 or 324.009 shall serve an apprenticeship for at least~~
22 ~~twelve consecutive months in a funeral establishment licensed for the care and preparation for burial~~
23 ~~and transportation of the human dead in this state or in another state which has established standards~~
24 ~~for admission to practice funeral directing equal to, or more stringent than, the requirements for~~
25 ~~admission to practice funeral directing in this state. The applicant shall devote at least fifteen hours~~
26 ~~per week to his or her duties as an apprentice under the supervision of a Missouri licensed funeral~~
27 ~~director. Such applicant shall submit proof to the board, on forms provided by the board, that the~~
28 ~~applicant has arranged and conducted ten funeral services during the applicant's apprenticeship~~
29 ~~under the supervision of a Missouri licensed funeral director. Upon completion of the~~
30 ~~apprenticeship, the applicant shall appear before the board to be tested on the applicant's legal and~~
31 ~~practical knowledge of funeral directing, funeral home licensing, preneed funeral contracts and the~~
32 ~~care, custody, shelter, disposition and transportation of dead human bodies. Upon acceptance of the~~
33 ~~application and fees by the board, an applicant shall have twenty-four months to successfully~~
34 ~~complete the requirements for licensure found in this section or the application for licensure shall be~~
35 ~~cancelled.~~

36 ~~2. If a person applies for a limited license to work only in a funeral establishment which is~~
37 ~~licensed only for cremation, including transportation of dead human bodies to and from the funeral~~
38 ~~establishment, he or she shall make application, pay the current application and examination fee and~~
39 ~~successfully complete the Missouri law examination. He or she shall be exempt from the twelve-~~

~~month apprenticeship required by subsection 1 of this section and the practical examination before the board. If a person has a limited license issued pursuant to this subsection, he or she may obtain a full funeral director's license if he or she fulfills the apprenticeship and successfully completes the funeral director practical examination.~~

~~3. If an individual is a Missouri licensed embalmer or has completed a program accredited by the American Board of Funeral Service Education, any successor organization, or other accrediting entity as approved by the board or has successfully completed a course of study in funeral directing offered by an institution accredited by a recognized national, regional or state accrediting body and approved by the state board of embalmers and funeral directors, and desires to enter the profession of funeral directing in this state, the individual shall comply with all the requirements for licensure as a funeral director pursuant to subsection 1 of section 333.041 and subsection 1 of this section; however, the individual is exempt from the twelve-month apprenticeship required by subsection 1 of this section]~~ Every person desiring to engage in the practice of funeral directing as an apprentice in this state shall obtain a provisional funeral director license from the board. To apply for a provisional license, the applicant shall submit an application to the state board of embalmers and funeral directors, pay the current application fees, and furnish evidence to establish to the satisfaction of the board that he or she:

(1) Is at least eighteen years of age; and

(2) Will work as an apprentice funeral director under personal supervision of a funeral director licensed under this chapter. The applicant shall provide to the board the name and license number of the funeral director who will perform his or her supervision and the location where the applicant will practice.

2. An applicant for a provisional funeral director license under subsection 1 of this section shall have twenty-four months to complete the requirements for licensure under this section. If the applicant fails to complete the requirements within such period, the application for licensure shall be cancelled. If the application is cancelled, the applicant shall be required to file a new application and pay applicable fees. No previous apprenticeship shall be considered for the new application.

3. Every person desiring to enter the profession of funeral directing in this state shall submit an application to the state board of embalmers and funeral directors, pay the current application fees, and furnish evidence to establish to the satisfaction of the board that he or she:

(1) Is at least eighteen years of age and possesses a high school diploma, a general equivalency diploma, or equivalent thereof, as determined, at its discretion, by the board;

(2) Has passed the Missouri law examination; and

(3) Has:

(a) Passed the National Board or State Board Arts examination and successfully completed a program accredited by the American Board of Funeral Service Education or any successor organization or any other accrediting entity as approved by the board;

(b) Passed the National Board or State Board Arts examination and successfully completed a course of study in funeral directing offered by an institution accredited by a recognized national,

1 regional, or state accrediting body and approved by the state board of embalmers and funeral
2 directors;

3 (c) Passed the National Board or State Board Arts examination and successfully completed
4 a qualifying apprenticeship for at least twelve months, during which the applicant establishes to the
5 satisfaction of the board that he or she conducted and arranged at least ten funerals; or

6 (d) Successfully completed a qualifying apprenticeship for at least twelve months, during
7 which the applicant establishes to the satisfaction of the board that he or she has conducted and
8 arranged at least twenty-five funerals.

9 4. (1) Upon establishment of his or her qualifications as specified by this section, the board
10 shall issue to the applicant a license to practice funeral directing and shall register the applicant as a
11 duly licensed funeral director. Any person having the qualifications required by this section and
12 section 333.041 may be granted both a license to practice funeral directing and to practice
13 embalming.

14 (2) Any person licensed under this subsection without passing the National Board or State
15 Board Arts examination may, at his or her election, at any time, sit for the National Board or State
16 Board Arts examination for the purpose of potential reciprocity with any other state that may require
17 such examination.

18 5. Every person desiring to obtain a funeral director limited license in this state shall submit
19 an application to the state board of embalmers and funeral directors, pay the current application fees,
20 and furnish evidence to establish to the satisfaction of the board that he or she:

21 (1) Is at least eighteen years of age; and

22 (2) Has successfully completed the Missouri law examination.

23 6. A person holding a funeral director limited license shall not be authorized to practice
24 funeral directing in the state, except as follows:

25 (1) He or she may work in a funeral establishment licensed only for cremation, including
26 transportation of dead human bodies to and from the funeral establishment; and

27 (2) He or she may perform cremations and duties relating to cremation.

28 7. If a person has a funeral director limited license issued under this section, he or she may
29 obtain a full funeral director's license by fulfilling the apprenticeship requirements of paragraph (d)
30 of subdivision (3) of subsection 3 of this section or by successfully completing a program accredited
31 by the American Board of Funeral Service Education or any successor organization or any other
32 accrediting entity as approved by the board.

33 8. The board shall, upon request, waive any requirement of this chapter and issue a
34 temporary funeral director's license, valid for six months, to the surviving spouse or next of kin or
35 the personal representative of a licensed funeral director, or to the spouse, next of kin, employee, or
36 conservator of a licensed funeral director disabled because of sickness, mental incapacity, or injury.

37 9. For purposes of this section, the following terms mean:

38 (1) "Personal supervision", supervision in which a licensed funeral director shall be
39 physically present during any arrangement conferences but shall not be required to be physically

1 present at the location where the apprentice performs any other functions relating to the practice of
2 funeral directing;

3 (2) "Qualifying apprenticeship", an apprenticeship in which the applicant devotes at least
4 fifteen hours each week to his or her duties as an apprentice under the personal supervision of a
5 funeral director licensed under this chapter in a funeral establishment licensed for the care and
6 preparation for burial and transportation of the human dead."; and
