2 Senate Committee Substitute for Senate Bill No. 157, Page 1, Line 22, by inserting after all of said  
3 line the following:

5 "Further amend said bill, Page 12, Section 329.280, Line 33, by inserting after all of said section and  
6 line the following:

8 "332.071. A person or other entity "practices dentistry" within the meaning of this chapter  
9 who:

10 (1) Undertakes to do or perform dental work or dental services or dental operations or oral  
11 surgery, by any means or methods, including the use of lasers, gratuitously or for a salary or fee or  
12 other reward, paid directly or indirectly to the person or to any other person or entity;

13 (2) Diagnoses or professes to diagnose, prescribes for or professes to prescribe for, treats or  
14 professes to treat, any disease, pain, deformity, deficiency, injury or physical condition of human  
15 teeth or adjacent structures or treats or professes to treat any disease or disorder or lesions of the oral  
16 regions;

17 (3) Attempts to or does replace or restore a part or portion of a human tooth;

18 (4) Attempts to or does extract human teeth or attempts to or does correct malformations of  
19 human teeth or jaws;

20 (5) Attempts to or does adjust an appliance or appliances for use in or used in connection  
21 with malposed teeth in the human mouth;

22 (6) Interprets or professes to interpret or read dental radiographs;

23 (7) Administers an anesthetic in connection with dental services or dental operations or  
24 dental surgery;

25 (8) Undertakes to or does remove hard and soft deposits from or polishes natural and  
26 restored surfaces of teeth;

27 (9) Uses or permits to be used for the person's benefit or for the benefit of any other person  
28 or other entity the following titles or words in connection with the person's name: "Doctor",  
29 "Dentist", "Dr.", "D.D.S.", or "D.M.D.", or any other letters, titles, degrees or descriptive matter

1 which directly or indirectly indicate or imply that the person is willing or able to perform any type  
2 of dental service for any person or persons, or uses or permits the use of for the person's benefit or  
3 for the benefit of any other person or other entity any card, directory, poster, sign or any other means  
4 by which the person indicates or implies or represents that the person is willing or able to perform  
5 any type of dental services or operation for any person;

6 (10) Directly or indirectly owns, leases, operates, maintains, manages or conducts an office  
7 or establishment of any kind in which dental services or dental operations of any kind are performed  
8 for any purpose; but this section shall not be construed to prevent owners or lessees of real estate  
9 from lawfully leasing premises to those who are qualified to practice dentistry within the meaning of  
10 this chapter;

11 (11) Controls, influences, attempts to control or influence, or otherwise interferes with the  
12 dentist's independent professional judgment regarding the diagnosis or treatment of a dental disease,  
13 disorder, or physical condition except that any opinion rendered by any health care professional  
14 licensed under this chapter or chapter 330, 331, 334, 335, 336, 337, or 338 regarding the diagnosis,  
15 treatment, disorder, or physical condition of any patient shall not be construed to control, influence,  
16 attempt to control or influence or otherwise interfere with a dentist's independent professional  
17 judgment;

18 (12) Constructs, supplies, reproduces or repairs any prosthetic denture, bridge, artificial  
19 restoration, appliance or other structure to be used or worn as a substitute for natural teeth, except  
20 when one, not a registered and licensed dentist, does so pursuant to a written uniform laboratory  
21 work order, in the form prescribed by the board, of a dentist registered and currently licensed in  
22 Missouri and which the substitute in this subdivision described is constructed upon or by use of  
23 casts or models made from an impression furnished by a dentist registered and currently licensed in  
24 Missouri;

25 (13) Attempts to or does place any substitute described in subdivision (12) of this section in  
26 a human mouth or attempts to or professes to adjust any substitute or delivers any substitute to any  
27 person other than the dentist upon whose order the work in producing the substitute was performed;

28 (14) Advertises, solicits, or offers to or does sell or deliver any substitute described in  
29 subdivision (12) of this section or offers to or does sell the person's services in constructing,  
30 reproducing, supplying or repairing the substitute to any person other than a registered and licensed  
31 dentist in Missouri;

32 (15) Undertakes to do or perform any physical evaluation of a patient in the person's office  
33 or in a hospital, clinic, or other medical or dental facility prior to or incident to the performance of  
34 any dental services, dental operations, or dental surgery;

35 (16) Reviews examination findings, x-rays, or other patient data to make judgments or  
36 decisions about the dental care rendered to a patient in this state;

37 (17) Prescribes and administers vaccines for diseases related to care within the practice of  
38 dentistry; or

1           (18) Prescribes and administers vaccines in accordance with section 332.368 when deployed  
2 under section 44.045 to provide care as necessitated by an emergency.

3           332.368. 1. A dentist may:

4           (1) Prescribe and administer vaccines to a person with whom the dentist has established a  
5 patient relationship; and

6           (2) Prescribe and administer vaccines to any person when the dentist is deployed under  
7 section 44.045 to provide care as necessitated by an emergency.

8           2. A dentist shall not be required to prescribe or administer vaccines.

9           3. Before prescribing or administering any vaccine under this section, a dentist shall  
10 complete a training course recognized by the board under subsection 4 of this section and obtain a  
11 certificate of successful completion from the agency or organization that offered the course. A  
12 dentist shall produce the certificate upon request of the board.

13           4. The board shall recognize for purposes of this section any training course that:

14           (1) Includes training on appropriate vaccine storage and proper vaccine administration;

15           (2) Addresses contraindications and adverse reactions to vaccines; and

16           (3) Is offered by the Centers for Disease Control and Prevention, the American Dental  
17 Association or its successor organization, or any other similar federal or state agency or professional  
18 organization deemed qualified by the board.

19           5. A dentist who administers a vaccine under this section shall inform the patient that the  
20 administration of the vaccine will be entered into the ShowMeVax system, as administered by the  
21 department of health and senior services. The patient shall attest to the inclusion of such  
22 information in the system by signing a form provided by the dentist.

23           6. Prior to administering a vaccine under this section, a dentist shall review the patient's  
24 vaccination history in the ShowMeVax system.

25           7. A dentist shall not administer a vaccine under this section to a child under seven years of  
26 age or under the minimum age recommended by the Centers for Disease Control and Prevention.

27           8. A dentist who prescribes or administers a vaccine under this section shall comply with  
28 any applicable patient of care record-keeping requirements.

29           9. A dentist shall not delegate the administration of a vaccine under this section.

30           10. All individual and group health insurance policies providing coverage for vaccinations  
31 shall also provide coverage for vaccinations administered under this section.

32           11. The board shall promulgate rules for the purpose of recognizing entities qualified to  
33 offer the training course required under this section. Any rule or portion of a rule, as that term is  
34 defined in section 536.010, that is created under the authority delegated in this section shall become  
35 effective only if it complies with and is subject to all of the provisions of chapter 536 and, if  
36 applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers  
37 vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to  
38 disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking

1 authority and any rule proposed or adopted after August 28, 2023, shall be invalid and void."; and";
