AMEND House Committee Substitute for Senate Substitute for Senate Bill No. 198, Page 49,
Section 568.050, Line 27, by inserting after said section and line the following:

"579.065. 1. A person commits the offense of trafficking drugs in the first degree if, except
as authorized by this chapter or chapter 195, such person knowingly distributes, delivers,
manufactures, produces or attempts to distribute, deliver, manufacture or produce:

(1) More than thirty grams of a mixture or substance containing a detectable amount of
heroin;

(2) More than one hundred fifty grams of a mixture or substance containing a detectable
amount of coca leaves, except coca leaves and extracts of coca leaves from which cocaine,
ecgonine, and derivatives of ecgonine or their salts have been removed; cocaine salts and their
optical and geometric isomers, and salts of isomers; ecgonine, its derivatives, their salts, isomers,
and salts of isomers; or any compound, mixture, or preparation which contains any quantity of any
of the foregoing substances;

(3) ~~More than eight grams of a mixture or substance described in subdivision (2) of this
subsection which contains cocaine base;~~

(4) More than five hundred milligrams of a mixture or substance containing a detectable
amount of lysergic acid diethylamide (LSD);

~~(5)~~ (4) More than thirty grams of a mixture or substance containing a detectable amount of
phencyclidine (PCP);

~~(6)~~ (5) More than four grams of phencyclidine;

~~(7)~~ (6) More than thirty kilograms of a mixture or substance containing marijuana;

~~(8)~~ (7) More than thirty grams of any material, compound, mixture, or preparation
containing any quantity of the following substances having a stimulant effect on the central nervous

methylphenidate;

 5 offense was within two thousand feet of real property comprising a public or private elementary,
 6 vocational, or secondary school, college, community college, university, or any school bus, in or on
 7 the real property comprising public housing or any other governmental assisted housing, within a
 8 motor vehicle, or in any structure or building which contains rooms furnished for the
 9 accommodation or lodging of guests, and kept, used, maintained, advertised, or held out to the

18 579.068. 1. A person commits the offense of trafficking drugs in the second degree if,
 19 except as authorized by this chapter or chapter 195, such person knowingly possesses or has under
 20 his or her control, purchases or attempts to purchase, or brings into this state:

21 (1) More than thirty grams of a mixture or substance containing a detectable amount of
 22 heroin;

23 (2) More than one hundred fifty grams of a mixture or substance containing a detectable
 24 amount of coca leaves, except coca leaves and extracts of coca leaves from which cocaine,
 25 ecgonine, and derivatives of ecgonine or their salts have been removed; cocaine salts and their
 26 optical and geometric isomers, and salts of isomers; ecgonine, its derivatives, their salts, isomers,
 27 and salts of isomers; or any compound, mixture, or preparation which contains any quantity of any
 28 of the foregoing substances;

3. The offense of trafficking drugs in the second degree is a class B felony if the quantity involved is:

(1) Ninety grams or more of a mixture or substance containing a detectable amount of heroin; or

(2) Four hundred fifty grams or more of a mixture or substance containing a detectable amount of coca leaves, except coca leaves and extracts of coca leaves from which cocaine, ecgonine, and derivatives of ecgonine or their salts have been removed; cocaine salts and their optical and geometric isomers, and salts of isomers; ecgonine, its derivatives, their salts, isomers, and salts of isomers; or any compound, mixture, or preparation which contains any quantity of any of the foregoing substances; or

~~(3) [Twenty-four grams or more of a mixture or substance described in subdivision (2) of this subsection which contains cocaine base; or~~

~~(4)]~~ One gram or more of a mixture or substance containing a detectable amount of lysergic acid diethylamide (LSD); or

~~[(5)]~~ (4) Ninety grams or more of a mixture or substance containing a detectable amount of phencyclidine (PCP); or

~~[(6)]~~ (5) Twelve grams or more of phencyclidine; or

~~[(7)]~~ (6) One hundred kilograms or more of a mixture or substance containing marijuana; or

~~[(8)]~~ (7) More than five hundred marijuana plants; or

~~[(11)]~~ (10) Twenty milligrams or more of fentanyl or carfentanil, or any derivative thereof, or any combination thereof, or any compound, mixture, or substance containing a detectable amount of fentanyl or carfentanil, or their optical isomers or analogues.

1 4. The offense of trafficking drugs in the second degree is a class A felony if the quantity
2 involved is four hundred fifty grams or more of any material, compound, mixture or preparation
3 which contains:

4 (1) Any quantity of the following substances having a stimulant effect on the central
5 nervous system: amphetamine, its salts, optical isomers and salts of its optical isomers;
6 methamphetamine, its salts, isomers and salts of its isomers; phenmetrazine and its salts; or
7 methylphenidate; or

8 (2) Any quantity of 3,4-methylenedioxymethamphetamine.

9 5. The offense of drug trafficking in the second degree is a class C felony for the first
10 offense and a class B felony for any second or subsequent offense for the trafficking of less than one
11 gram of flunitrazepam."; and
