1 AMEND House Amendment No. _____ to House Committee Substitute for House Bill No. 424,
2 Page 1, Line 4, by deleting said line and inserting in lieu thereof the following:

4 "301.469. 1. Any vehicle owner may receive license plates as prescribed in this section,
5 for any motor vehicle such person owns, either solely or jointly, other than an apportioned motor
6 vehicle or a commercial motor vehicle licensed in excess of twenty-four thousand pounds gross
7 weight, after an annual payment of an emblem-use authorization fee to the Missouri conservation
8 heritage foundation. The foundation hereby authorizes the use of its official emblems to be affixed
9 on multiyear license plates as provided in this section. Any vehicle owner may annually apply for
10 the use of the emblems.

11 2. Upon annual application and payment of a twenty-five dollar emblem-use authorization
12 fee to the Missouri conservation heritage foundation, the foundation shall issue to the vehicle owner,
13 without further charge, an emblem-use authorization statement, which shall be presented to the
14 director of the department of revenue at the time of registration of a motor vehicle.

15 3. Upon presentation of the annual statement, payment of a fifteen dollar fee in addition to
16 the regular registration fees and documents which may be required by law, the director of the
17 department of revenue shall issue a license plate, which shall bear an emblem of the Missouri
18 conservation heritage foundation in a form prescribed by the director, to the vehicle owner. Such
19 license plates shall be made with fully reflective material with a common color scheme and design,
20 shall be clearly visible at night, and shall be aesthetically attractive, as prescribed by section
21 301.130. Notwithstanding the provisions of section 301.144, no additional fee shall be charged for
22 the personalization of license plates pursuant to this section.

23 4. Application for the emblem-use authorization and payment of the twenty-five-dollar
24 contribution may also be made at the time of registration to the director of the department of
25 revenue, who shall deposit the contribution to the credit of the Missouri conservation heritage
26 foundation.

27 5. A vehicle owner, who was previously issued a plate with a Missouri conservation heritage
28 foundation emblem authorized by this section but who does not provide an emblem-use

1 authorization statement at a subsequent time of registration, shall be issued a new plate which does
2 not bear the foundation emblem, as otherwise provided by law.

3 ~~[5.]~~ 6. The director of the department of revenue may promulgate rules and regulations for
4 the administration of this section. Any rule or portion of a rule, as that term is defined in section
5 536.010, that is promulgated under the authority delegated in this section shall become effective
6 only if it has been promulgated pursuant to the provisions of chapter 536. All rulemaking authority
7 delegated prior to August 28, 1999, is of no force and effect; however, nothing in this section shall
8 be interpreted to repeal or affect the validity of any rule filed or adopted prior to August 28, 1999, if
9 it fully complied with the provisions of chapter 536. This section and chapter 536 are nonseverable
10 and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to
11 delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional,
12 then the grant of rulemaking authority and any rule proposed or adopted after August 28, 1999, shall
13 be invalid and void.
