1 AMEND House Committee Substitute for Senate Substitute for Senate Bill No. 24, Page 1, Section  
2 A, Line 3, by inserting after all of said section and line the following:

4 "67.145. 1. No political subdivision of this state shall prohibit any first responder from  
5 engaging in any political activity while off duty and not in uniform, being a candidate for elected or  
6 appointed public office, or holding such office unless such political activity or candidacy is  
7 otherwise prohibited by state or federal law.

8 2. As used in this section, "first responder" means any person trained and authorized by law  
9 or rule to render emergency medical assistance or treatment. Such persons may include, but shall  
10 not be limited to, emergency first responders, telecommunicator first responders, police officers,  
11 sheriffs, deputy sheriffs, firefighters, ~~[ambulance attendants and attendant drivers,]~~ emergency  
12 medical technicians, ~~[mobile emergency medical technicians, emergency medical technician-~~  
13 ~~paramedics,]~~ registered nurses, or physicians.

14 70.631. 1. Each political subdivision may, by majority vote of its governing body, elect to  
15 cover ~~[emergency telecommunicators]~~ telecommunicator first responders, jailors, and emergency  
16 medical service personnel as public safety personnel members of the system. The clerk or secretary  
17 of the political subdivision shall certify an election concerning the coverage of ~~[emergency~~  
18 ~~telecommunicators]~~ telecommunicator first responders, jailors, and emergency medical service  
19 personnel as public safety personnel members of the system to the board within ten days after such  
20 vote. The date in which the political subdivision's election becomes effective shall be the first day  
21 of the calendar month specified by such governing body, the first day of the calendar month next  
22 following receipt by the board of the certification of the election, or the effective date of the political  
23 subdivision's becoming an employer, whichever is the latest date. Such election shall not be  
24 changed after the effective date. If the election is made, the coverage provisions shall be applicable  
25 to all past and future employment with the employer by present and future employees. If a political  
26 subdivision makes no election under this section, no ~~[emergency]~~ telecommunicator first responder,  
27 jailor, or emergency medical service personnel of the political subdivision shall be considered public  
28 safety personnel for purposes determining a minimum service retirement age as defined in section  
29 70.600.

2. If an employer elects to cover ~~[emergency telecommunicators]~~ telecommunicator first responders, jailors, and emergency medical service personnel as public safety personnel members of the system, the employer's contributions shall be correspondingly changed effective the same date as the effective date of the political subdivision's election.

3. The limitation on increases in an employer's contributions provided by subsection 6 of section 70.730 shall not apply to any contribution increase resulting from an employer making an election under the provisions of this section.

105.500. For purposes of sections 105.500 to 105.598, unless the context otherwise requires, the following words and phrases mean:

(1) "Bargaining unit", a unit of public employees at any plant or installation or in a craft or in a function of a public body that establishes a clear and identifiable community of interest among the public employees concerned;

(2) "Board", the state board of mediation established under section 295.030;

(3) "Department", the department of labor and industrial relations established under section 286.010;

(4) "Exclusive bargaining representative", an organization that has been designated or selected, as provided in section 105.575, by a majority of the public employees in a bargaining unit as the representative of such public employees in such unit for purposes of collective bargaining;

(5) "Labor organization", any organization, agency, or public employee representation committee or plan, in which public employees participate and that exists for the purpose, in whole or in part, of dealing with a public body or public bodies concerning collective bargaining, grievances, labor disputes, wages, rates of pay, hours of employment, or conditions of work;

(6) "Public body", the state of Missouri, or any officer, agency, department, bureau, division, board or commission of the state, or any other political subdivision or special district of or within the state. Public body shall not include the department of corrections;

(7) "Public employee", any person employed by a public body;

(8) "Public safety labor organization", a labor organization wholly or primarily representing persons trained or authorized by law or rule to render emergency medical assistance or treatment, including, but not limited to, firefighters, ~~[ambulance attendants, attendant drivers,]~~ emergency medical technicians, ~~[emergency medical technician paramedics,]~~ dispatchers, registered nurses and physicians, and persons who are vested with the power of arrest for criminal code violations including, but not limited to, police officers, sheriffs, and deputy sheriffs.

170.310. 1. For school year 2017-18 and each school year thereafter, upon graduation from high school, pupils in public schools and charter schools shall have received thirty minutes of cardiopulmonary resuscitation instruction and training in the proper performance of the Heimlich maneuver or other first aid for choking given any time during a pupil's four years of high school.

2. Beginning in school year 2017-18, any public school or charter school serving grades nine through twelve shall provide enrolled students instruction in cardiopulmonary resuscitation. Students with disabilities may participate to the extent appropriate as determined by the provisions

of the Individuals with Disabilities Education Act or Section 504 of the Rehabilitation Act. Instruction shall be included in the district's existing health or physical education curriculum. Instruction shall be based on a program established by the American Heart Association or the American Red Cross, or through a nationally recognized program based on the most current national evidence-based emergency cardiovascular care guidelines, and psychomotor skills development shall be incorporated into the instruction. For purposes of this section, "psychomotor skills" means the use of hands-on practicing and skills testing to support cognitive learning.

3. The teacher of the cardiopulmonary resuscitation course or unit shall not be required to be a certified trainer of cardiopulmonary resuscitation if the instruction is not designed to result in certification of students. Instruction that is designed to result in certification being earned shall be required to be taught by an authorized cardiopulmonary instructor. Schools may develop agreements with any local chapter of a voluntary organization of first responders to provide the required hands-on practice and skills testing. For purposes of this subsection, "first responders" shall include telecommunicator first responders as defined in section 650.320.

4. The department of elementary and secondary education may promulgate rules to implement this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2012, shall be invalid and void.

190.091. 1. As used in this section, the following terms mean:

(1) "Bioterrorism", the intentional use of any microorganism, virus, infectious substance, or biological product that may be engineered as a result of biotechnology or any naturally occurring or bioengineered component of any microorganism, virus, infectious substance, or biological product to cause death, disease, or other biological malfunction in a human, an animal, a plant, or any other living organism to influence the conduct of government or to intimidate or coerce a civilian population;

(2) "Department", the Missouri department of health and senior services;

(3) "Director", the director of the department of health and senior services;

(4) "Disaster locations", any geographical location where a bioterrorism attack, terrorist attack, catastrophic or natural disaster, or emergency occurs;

(5) "First responders", state and local law enforcement personnel, telecommunicator first responders, fire department personnel, and emergency medical personnel who will be deployed to bioterrorism attacks, terrorist attacks, catastrophic or natural disasters, and emergencies;

(6) "Missouri state highway patrol telecommunicator", any authorized Missouri state highway patrol communications division personnel whose primary responsibility includes directly

1 responding to emergency communications and who meet the training requirements pursuant to  
2 section 650.340.

3       2. The department shall offer a vaccination program for first responders and Missouri state  
4 highway patrol telecommunicators who may be exposed to infectious diseases when deployed to  
5 disaster locations as a result of a bioterrorism event or a suspected bioterrorism event. The  
6 vaccinations shall include, but are not limited to, smallpox, anthrax, and other vaccinations when  
7 recommended by the federal Centers for Disease Control and Prevention's Advisory Committee on  
8 Immunization Practices.

9       3. Participation in the vaccination program shall be voluntary by the first responders and  
10 Missouri state highway patrol telecommunicators, except for first responders or Missouri state  
11 highway patrol telecommunicators who, as determined by their employer, cannot safely perform  
12 emergency responsibilities when responding to a bioterrorism event or suspected bioterrorism event  
13 without being vaccinated. The recommendations of the Centers for Disease Control and  
14 Prevention's Advisory Committee on Immunization Practices shall be followed when providing  
15 appropriate screening for contraindications to vaccination for first responders and Missouri state  
16 highway patrol telecommunicators. A first responder and Missouri state highway patrol  
17 telecommunicator shall be exempt from vaccinations when a written statement from a licensed  
18 physician is presented to their employer indicating that a vaccine is medically contraindicated for  
19 such person.

20       4. If a shortage of the vaccines referred to in subsection 2 of this section exists following a  
21 bioterrorism event or suspected bioterrorism event, the director, in consultation with the governor  
22 and the federal Centers for Disease Control and Prevention, shall give priority for such vaccinations  
23 to persons exposed to the disease and to first responders or Missouri state highway patrol  
24 telecommunicators who are deployed to the disaster location.

25       5. The department shall notify first responders and Missouri state highway patrol  
26 telecommunicators concerning the availability of the vaccination program described in subsection 2  
27 of this section and shall provide education to such first responders, [and] their employers, and  
28 Missouri state highway patrol telecommunicators concerning the vaccinations offered and the  
29 associated diseases.

30       6. The department may contract for the administration of the vaccination program described  
31 in subsection 2 of this section with health care providers, including but not limited to local public  
32 health agencies, hospitals, federally qualified health centers, and physicians.

33       7. The provisions of this section shall become effective upon receipt of federal funding or  
34 federal grants which designate that the funding is required to implement vaccinations for first  
35 responders and Missouri state highway patrol telecommunicators in accordance with the  
36 recommendations of the federal Centers for Disease Control and Prevention's Advisory Committee  
37 on Immunization Practices. Upon receipt of such funding, the department shall make available the  
38 vaccines to first responders and Missouri state highway patrol telecommunicators as provided in this  
39 section.

1           190.100. As used in sections 190.001 to 190.245 and section 190.257, the following words  
2 and terms mean:

3           (1) "Advanced emergency medical technician" or "AEMT", a person who has successfully  
4 completed a course of instruction in certain aspects of advanced life support care as prescribed by  
5 the department and is licensed by the department in accordance with sections 190.001 to 190.245  
6 and rules and regulations adopted by the department pursuant to sections 190.001 to 190.245;

7           (2) "Advanced life support (ALS)", an advanced level of care as provided to the adult and  
8 pediatric patient such as defined by national curricula, and any modifications to that curricula  
9 specified in rules adopted by the department pursuant to sections 190.001 to 190.245;

10          (3) "Ambulance", any privately or publicly owned vehicle or craft that is specially designed,  
11 constructed or modified, staffed or equipped for, and is intended or used, maintained or operated for  
12 the transportation of persons who are sick, injured, wounded or otherwise incapacitated or helpless,  
13 or who require the presence of medical equipment being used on such individuals, but the term does  
14 not include any motor vehicle specially designed, constructed or converted for the regular  
15 transportation of persons who are disabled, handicapped, normally using a wheelchair, or otherwise  
16 not acutely ill, or emergency vehicles used within airports;

17          (4) "Ambulance service", a person or entity that provides emergency or nonemergency  
18 ambulance transportation and services, or both, in compliance with sections 190.001 to 190.245, and  
19 the rules promulgated by the department pursuant to sections 190.001 to 190.245;

20          (5) "Ambulance service area", a specific geographic area in which an ambulance service has  
21 been authorized to operate;

22          (6) "Basic life support (BLS)", a basic level of care, as provided to the adult and pediatric  
23 patient as defined by national curricula, and any modifications to that curricula specified in rules  
24 adopted by the department pursuant to sections 190.001 to 190.245;

25          (7) "Council", the state advisory council on emergency medical services;

26          (8) "Department", the department of health and senior services, state of Missouri;

27          (9) "Director", the director of the department of health and senior services or the director's  
28 duly authorized representative;

29          (10) "Dispatch agency", any person or organization that receives requests for emergency  
30 medical services from the public, by telephone or other means, and is responsible for dispatching  
31 emergency medical services;

32          (11) "Emergency", the sudden and, at the time, unexpected onset of a health condition that  
33 manifests itself by symptoms of sufficient severity that would lead a prudent layperson, possessing  
34 an average knowledge of health and medicine, to believe that the absence of immediate medical care  
35 could result in:

36           (a) Placing the person's health, or with respect to a pregnant woman, the health of the  
37 woman or her unborn child, in significant jeopardy;

38           (b) Serious impairment to a bodily function;

39           (c) Serious dysfunction of any bodily organ or part;

2 (12) "Emergency medical dispatcher", a person who receives emergency calls from the  
3 public and has successfully completed an emergency medical dispatcher course~~[-meeting or~~  
4 ~~exceeding the national curriculum of the United States Department of Transportation and any~~  
5 ~~modifications to such curricula specified by the department through rules adopted pursuant to~~  
6 ~~sections 190.001 to 190.245]~~ and any ongoing training requirements under section 650.340;

7 (13) "Emergency medical responder", a person who has successfully completed an  
8 emergency first response course meeting or exceeding the national curriculum of the U.S.  
9 Department of Transportation and any modifications to such curricula specified by the department  
10 through rules adopted under sections 190.001 to 190.245 and who provides emergency medical care  
11 through employment by or in association with an emergency medical response agency;

12 (14) "Emergency medical response agency", any person that regularly provides a level of  
13 care that includes first response, basic life support or advanced life support, exclusive of patient  
14 transportation;

15 (15) "Emergency medical services for children (EMS-C) system", the arrangement of  
16 personnel, facilities and equipment for effective and coordinated delivery of pediatric emergency  
17 medical services required in prevention and management of incidents which occur as a result of a  
18 medical emergency or of an injury event, natural disaster or similar situation;

19 (16) "Emergency medical services (EMS) system", the arrangement of personnel, facilities  
20 and equipment for the effective and coordinated delivery of emergency medical services required in  
21 prevention and management of incidents occurring as a result of an illness, injury, natural disaster or  
22 similar situation;

23 (17) "Emergency medical technician", a person licensed in emergency medical care in  
24 accordance with standards prescribed by sections 190.001 to 190.245, and by rules adopted by the

22       190.103. 1. One physician with expertise in emergency medical services from each of the  
23 EMS regions shall be elected by that region's EMS medical directors to serve as a regional EMS  
24 medical director. The regional EMS medical directors shall constitute the state EMS medical  
25 director's advisory committee and shall advise the department and their region's ambulance services  
26 on matters relating to medical control and medical direction in accordance with sections 190.001 to  
27 190.245 and rules adopted by the department pursuant to sections 190.001 to 190.245. The regional  
28 EMS medical director shall serve a term of four years. The southwest, northwest, and Kansas City  
29 regional EMS medical directors shall be elected to an initial two-year term. The central, east  
30 central, and southeast regional EMS medical directors shall be elected to an initial four-year term.  
31 All subsequent terms following the initial terms shall be four years. The state EMS medical director  
32 shall be the chair of the state EMS medical director's advisory committee, and shall be elected by  
33 the members of the regional EMS medical director's advisory committee, shall serve a term of four  
34 years, and shall seek to coordinate EMS services between the EMS regions, promote educational  
35 efforts for agency medical directors, represent Missouri EMS nationally in the role of the state EMS  
36 medical director, and seek to incorporate the EMS system into the health care system serving  
37 Missouri.

38       2. A medical director is required for all ambulance services and emergency medical  
39 response agencies that provide: advanced life support services; basic life support services utilizing

1 medications or providing assistance with patients' medications; or basic life support services  
2 performing invasive procedures including invasive airway procedures. The medical director shall  
3 provide medical direction to these services and agencies in these instances.

4 3. The medical director, in cooperation with the ambulance service or emergency medical  
5 response agency administrator, shall have the responsibility and the authority to ensure that the  
6 personnel working under their supervision are able to provide care meeting established standards of  
7 care with consideration for state and national standards as well as local area needs and resources.  
8 The medical director, in cooperation with the ambulance service or emergency medical response  
9 agency administrator, shall establish and develop triage, treatment and transport protocols, which  
10 may include authorization for standing orders. Emergency medical technicians shall only perform  
11 those medical procedures as directed by treatment protocols approved by the local medical director  
12 or when authorized through direct communication with online medical control.

13 4. All ambulance services and emergency medical response agencies that are required to  
14 have a medical director shall establish an agreement between the service or agency and their  
15 medical director. The agreement will include the roles, responsibilities and authority of the medical  
16 director beyond what is granted in accordance with sections 190.001 to 190.245 and rules adopted  
17 by the department pursuant to sections 190.001 to 190.245. The agreement shall also include  
18 grievance procedures regarding the emergency medical response agency or ambulance service,  
19 personnel and the medical director.

20 5. Regional EMS medical directors and the state EMS medical director elected as provided  
21 under subsection 1 of this section shall be considered public officials for purposes of sovereign  
22 immunity, official immunity, and the Missouri public duty doctrine defenses.

23 6. The state EMS medical director's advisory committee shall be considered a peer review  
24 committee under section 537.035.

25 7. Regional EMS medical directors may act to provide online telecommunication medical  
26 direction to AEMTs, ~~[EMT-Bs, EMT-Ps]~~ EMTs, paramedics, and community paramedics and  
27 provide offline medical direction per standardized treatment, triage, and transport protocols when  
28 EMS personnel, including AEMTs, ~~[EMT-Bs, EMT-Ps]~~ EMTs, paramedics, and community

31 8. When developing treatment protocols for special needs patients, regional EMS medical

35 approved application or loan agreement. In the event the board determines that loan funds have  
36 been expended for purposes other than those specified in an approved application or loan agreement  
37 or any event of default of the loan agreement occurs without resolution, the board shall take  
38 appropriate actions to obtain the return of the full amount of the loan and all moneys duly owed or  
39 other available remedies.

1           10. Upon failure of a borrower to remit repayment to the board within sixty days of the date  
2 a payment is due, the board may initiate collection or other appropriate action through the  
3 provisions outlined in subsection 7 of this section, if applicable.

4           11. If the borrower is an entity not covered under the collection procedures established in  
5 this section, the board, with the advice and consent of the attorney general, may initiate collection  
6 procedures or other appropriate action pursuant to applicable law.

7           12. The board may, at its discretion, audit the expenditure of any loan, grant, or expenditure  
8 made or the computation of any payments made.

9           13. The board shall not approve any application made under this section if the applicant has  
10 failed to return the board's annual survey of public safety answering points as required by the board  
11 under section 650.330.

12           650.340. 1. The provisions of this section may be cited and shall be known as the "911  
13 Training and Standards Act".

14           2. Initial training requirements for ~~[telecommunicators]~~ telecommunicator first responders  
15 who answer 911 calls that come to public safety answering points shall be as follows:

16           (1) Police telecommunicator first responder, 16 hours;

17           (2) Fire telecommunicator first responder, 16 hours;

18           (3) Emergency medical services telecommunicator first responder, 16 hours;

19           (4) Joint communication center telecommunicator first responder, 40 hours.

20           3. All persons employed as a telecommunicator first responder in this state shall be required  
21 to complete ongoing training so long as such person engages in the occupation as a  
22 telecommunicator first responder. Such persons shall complete at least twenty-four hours of  
23 ongoing training every three years by such persons or organizations as provided in subsection 6 of  
24 this section.

25           4. Any person employed as a telecommunicator on August 28, 1999, shall not be required to  
26 complete the training requirement as provided in subsection 2 of this section. Any person hired as a  
27 telecommunicator or a telecommunicator first responder after August 28, 1999, shall complete the  
28 training requirements as provided in subsection 2 of this section within twelve months of the date  
29 such person is employed as a telecommunicator or telecommunicator first responder.

30           5. The training requirements as provided in subsection 2 of this section shall be waived for  
31 any person who furnishes proof to the committee that such person has completed training in another  
32 state which is at least as stringent as the training requirements of subsection 2 of this section.

33           6. The board shall determine by administrative rule the persons or organizations authorized  
34 to conduct the training as required by subsection 2 of this section.
