The MO HealthNet 32 division shall establish by administrative rule the definition and criteria for designation of a 33 comprehensive day rehabilitation service facility, benefit limitations and payment mechanism. Any 34 rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority 35 delegated in this subdivision shall become effective only if it complies with and is subject to all of 36 the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are 37 nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to 38 review, to delay the effective date, or to disapprove and annul a rule are subsequently held

1 unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after

2 August 28, 2005, shall be invalid and void.

3 3. The MO HealthNet division may require any participant receiving MO HealthNet 4 benefits to pay part of the charge or cost until July 1, 2008, and an additional payment after July 1, 2008, as defined by rule duly promulgated by the MO HealthNet division, for all covered services 5 6 except for those services covered under subdivisions (15) and (16) of subsection 1 of this section 7 and sections 208.631 to 208.657 to the extent and in the manner authorized by Title XIX of the 8 federal Social Security Act (42 U.S.C. Section 1396, et seq.) and regulations thereunder. When 9 substitution of a generic drug is permitted by the prescriber according to section 338.056, and a 10 generic drug is substituted for a name-brand drug, the MO HealthNet division may not lower or 11 delete the requirement to make a co-payment pursuant to regulations of Title XIX of the federal 12 Social Security Act. A provider of goods or services described under this section must collect from all participants the additional payment that may be required by the MO HealthNet division under 13 14 authority granted herein, if the division exercises that authority, to remain eligible as a provider. 15 Any payments made by participants under this section shall be in addition to and not in lieu of payments made by the state for goods or services described herein except the participant portion of 16 17 the pharmacy professional dispensing fee shall be in addition to and not in lieu of payments to 18 pharmacists. A provider may collect the co-payment at the time a service is provided or at a later 19 date. A provider shall not refuse to provide a service if a participant is unable to pay a required 20 payment. If it is the routine business practice of a provider to terminate future services to an 21 individual with an unclaimed debt, the provider may include uncollected co-payments under this 22 practice. Providers who elect not to undertake the provision of services based on a history of bad 23 debt shall give participants advance notice and a reasonable opportunity for payment. A provider, 24 representative, employee, independent contractor, or agent of a pharmaceutical manufacturer shall 25 not make co-payment for a participant. This subsection shall not apply to other qualified children, 26 pregnant women, or blind persons. If the Centers for Medicare and Medicaid Services does not approve the MO HealthNet state plan amendment submitted by the department of social services 27 28 that would allow a provider to deny future services to an individual with uncollected co-payments, 29 the denial of services shall not be allowed. The department of social services shall inform providers 30 regarding the acceptability of denying services as the result of unpaid co-payments.

31

4. The MO HealthNet division shall have the right to collect medication samples from 32 participants in order to maintain program integrity.

33 5. Reimbursement for obstetrical and pediatric services under subdivision (6) of subsection 34 1 of this section shall be timely and sufficient to enlist enough health care providers so that care and services are available under the state plan for MO HealthNet benefits at least to the extent that such 35 36 care and services are available to the general population in the geographic area, as required under 37 subparagraph (a)(30)(A) of 42 U.S.C. Section 1396a and federal regulations promulgated 38 thereunder.

6. Beginning July 1, 1990, reimbursement for services rendered in federally funded health
 centers shall be in accordance with the provisions of subsection 6402(c) and Section 6404 of P.L.
 101-239 (Omnibus Budget Reconciliation Act of 1989) and federal regulations promulgated
 thereunder.

5 7. Beginning July 1, 1990, the department of social services shall provide notification and 6 referral of children below age five, and pregnant, breast-feeding, or postpartum women who are 7 determined to be eligible for MO HealthNet benefits under section 208.151 to the special 8 supplemental food programs for women, infants and children administered by the department of 9 health and senior services. Such notification and referral shall conform to the requirements of 10 Section 6406 of P.L. 101-239 and regulations promulgated thereunder.

8. Providers of long-term care services shall be reimbursed for their costs in accordance
 with the provisions of Section 1902 (a)(13)(A) of the Social Security Act, 42 U.S.C. Section 1396a,
 as amended, and regulations promulgated thereunder.

9. Reimbursement rates to long-term care providers with respect to a total change in
ownership, at arm's length, for any facility previously licensed and certified for participation in the
MO HealthNet program shall not increase payments in excess of the increase that would result from
the application of Section 1902 (a)(13)(C) of the Social Security Act, 42 U.S.C. Section 1396a
(a)(13)(C).

10. The MO HealthNet division may enroll qualified residential care facilities and assisted
living facilities, as defined in chapter 198, as MO HealthNet personal care providers.

11. Any income earned by individuals eligible for certified extended employment at a
sheltered workshop under chapter 178 shall not be considered as income for purposes of
determining eligibility under this section.

12. If the Missouri Medicaid audit and compliance unit changes any interpretation or application of the requirements for reimbursement for MO HealthNet services from the interpretation or application that has been applied previously by the state in any audit of a MO HealthNet provider, the Missouri Medicaid audit and compliance unit shall notify all affected MO HealthNet providers five business days before such change shall take effect. Failure of the Missouri Medicaid audit and compliance unit to notify a provider of such change shall entitle the provider to

30 continue to receive and retain reimbursement until such notification is provided and shall waive any 31 liability of such provider for recoupment or other loss of any payments previously made prior to the

32 five business days after such notice has been sent. Each provider shall provide the Missouri

33 Medicaid audit and compliance unit a valid email address and shall agree to receive

34 communications electronically. The notification required under this section shall be delivered in

35 writing by the United States Postal Service or electronic mail to each provider.

36 13. Nothing in this section shall be construed to abrogate or limit the department's statutory
 37 requirement to promulgate rules under chapter 536.

38 14. Beginning July 1, 2016, and subject to appropriations, providers of behavioral, social,
 39 and psychophysiological services for the prevention, treatment, or management of physical health

problems shall be reimbursed utilizing the behavior assessment and intervention reimbursement 1 2 codes 96150 to 96154 or their successor codes under the Current Procedural Terminology (CPT) 3 coding system. Providers eligible for such reimbursement shall include psychologists. 4 15. There shall be no payments made under this section for gender transition surgeries, 5 cross-sex hormones, or puberty-blocking drugs, as such terms are defined in section 191.1720, for 6 the purpose of a gender transition. 7 217.230. The director shall arrange for necessary health care services for offenders confined 8 in correctional centers, which shall not include any gender transition surgery, as defined in section 9 191.1720. 10 221.120. 1. If any prisoner confined in the county jail is sick and in the judgment of the 11 jailer, requires the attention of a physician, dental care, or medicine, the jailer shall procure the 12 necessary medicine, dental care or medical attention necessary or proper to maintain the health of 13 the prisoner; provided, that this shall not include any gender transition surgery, as defined in section 14 191.1720. The costs of such medicine, dental care, or medical attention shall be paid by the prisoner through any health insurance policy as defined in subsection 3 of this section, from which the 15 prisoner is eligible to receive benefits. If the prisoner is not eligible for such health insurance 16 benefits then the prisoner shall be liable for the payment of such medical attention, dental care, or 17 18 medicine, and the assets of such prisoner may be subject to levy and execution under court order to 19 satisfy such expenses in accordance with the provisions of section 221.070, and any other applicable 20 law.
