1 AMEND House Committee Substitute for House Bill Nos. 1108 & 1181, Page 43, Section 589.414,
2 Line 215, by inserting after said section and line the following:

4 "590.040. 1. The POST commission shall set the minimum number of hours of basic
5 training for licensure as a peace officer no lower than [~~four hundred seventy and no higher than~~] six
6 hundred, with the following exceptions:

7 (1) Up to one thousand hours may be mandated for any class of license required for
8 commission by a state law enforcement agency;

9 (2) As few as one hundred twenty hours may be mandated for any class of license restricted
10 to commission as a reserve peace officer with police powers limited to the commissioning political
11 subdivision;

12 (3) Persons validly licensed on August 28, 2001, may retain licensure without additional
13 basic training;

14 (4) Persons licensed and commissioned within a county of the third classification before
15 July 1, 2002, may retain licensure with one hundred twenty hours of basic training if the
16 commissioning political subdivision has adopted an order or ordinance to that effect;

17 (5) Persons serving as a reserve officer on August 27, 2001, within a county of the first
18 classification or a county with a charter form of government and with more than one million
19 inhabitants on August 27, 2001, having previously completed a minimum of one hundred sixty
20 hours of training, shall be granted a license necessary to function as a reserve peace officer only
21 within such county. For the purposes of this subdivision, the term "reserve officer" shall mean any
22 person who serves in a less than full-time law enforcement capacity, with or without pay and who,
23 without certification, has no power of arrest and who, without certification, must be under the direct
24 and immediate accompaniment of a certified peace officer of the same agency at all times while on
25 duty; and

26 (6) The POST commission shall provide for the recognition of basic training received at law
27 enforcement training centers of other states, the military, the federal government and territories of
28 the United States regardless of the number of hours included in such training and shall have
29 authority to require supplemental training as a condition of eligibility for licensure.

1 2. The director shall have the authority to limit any exception provided in subsection 1 of
2 this section to persons remaining in the same commission or transferring to a commission in a
3 similar jurisdiction.

4 3. The basic training of every peace officer, except agents of the conservation commission,
5 shall include at least thirty hours of training in the investigation and management of cases involving
6 domestic and family violence. Such training shall include instruction, specific to domestic and
7 family violence cases, regarding: report writing; physical abuse, sexual abuse, child fatalities and
8 child neglect; interviewing children and alleged perpetrators; the nature, extent and causes of
9 domestic and family violence; the safety of victims, other family and household members and
10 investigating officers; legal rights and remedies available to victims, including rights to
11 compensation and the enforcement of civil and criminal remedies; services available to victims and
12 their children; the effects of cultural, racial and gender bias in law enforcement; and state statutes.
13 Said curriculum shall be developed and presented in consultation with the department of health and
14 senior services, the children's division, public and private providers of programs for victims of
15 domestic and family violence, persons who have demonstrated expertise in training and education
16 concerning domestic and family violence, and the Missouri coalition against domestic violence.

17 590.080. 1. The director shall have cause to discipline any peace officer licensee who:

18 (1) Is unable to perform the functions of a peace officer with reasonable competency or
19 reasonable safety [~~as a result of a mental condition, including alcohol or substance abuse~~];

20 (2) Has committed any criminal offense, whether or not a criminal charge has been filed, or
21 has been convicted or has entered a plea of guilty or nolo contendere in a criminal prosecution under
22 the laws of any state, or the United States, or of any country, whether or not a sentence is imposed;

23 (3) Has committed any act [~~while on active duty or under color of law~~] that involves moral
24 turpitude or a reckless disregard for the safety of the public or any person;

25 (4) Has caused a material fact to be misrepresented for the purpose of obtaining or retaining
26 a peace officer commission or any license issued pursuant to this chapter;

27 (5) Has violated a condition of any order of probation lawfully issued by the director; ~~[or]~~

28 (6) Has violated a provision of this chapter or a rule promulgated pursuant to this chapter;

29 (7) Has tested positive for a controlled substance, as defined in chapter 195, without a valid
30 prescription for the controlled substance; or

31 (8) Is subject to an order of another state, territory, the federal government, or any peace
32 officer licensing authority suspending or revoking a peace officer license or certification.

33 2. When the director has knowledge of cause to discipline a peace officer license pursuant to
34 this section, the director may cause a complaint to be filed with the administrative hearing
35 commission, which shall conduct a hearing to determine whether the director has cause for
36 discipline, and which shall issue findings of fact and conclusions of law on the matter. The
37 administrative hearing commission shall not consider the relative severity of the cause for discipline
38 or any rehabilitation of the licensee or otherwise impinge upon the discretion of the director to
39 determine appropriate discipline when cause exists pursuant to this section.

1 3. Upon a finding by the administrative hearing commission that cause to discipline exists,
2 the director shall, within thirty days, hold a hearing to determine the form of discipline to be
3 imposed and thereafter shall probate, suspend, or permanently revoke the license at issue. If the
4 licensee fails to appear at the director's hearing, this shall constitute a waiver of the right to such
5 hearing.

6 4. Notice of any hearing pursuant to this chapter or section may be made by certified mail to
7 the licensee's address of record pursuant to subdivision (2) of subsection 3 of section 590.130. Proof
8 of refusal of the licensee to accept delivery or the inability of postal authorities to deliver such
9 certified mail shall be evidence that required notice has been given. Notice may be given by
10 publication.

11 5. Nothing contained in this section shall prevent a licensee from informally disposing of a
12 cause for discipline with the consent of the director by voluntarily surrendering a license or by
13 voluntarily submitting to discipline.

14 6. The provisions of chapter 621 and any amendments thereto, except those provisions or
15 amendments that are in conflict with this chapter, shall apply to and govern the proceedings of the
16 administrative hearing commission and pursuant to this section the rights and duties of the parties
17 involved."; and
