## **FISCAL ANALYSIS**

### **ASSUMPTION**

Officials from the **Department of Elementary and Secondary Education** and the **Department of Higher Education and Workforce Development** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **University of Missouri System** state section 173.2171 would have a minimal fiscal impact on the University of Missouri System as a result of cost increases in an amount less than \$100,000. This legislation would require the University of Missouri System to review and, where appropriate, modify existing and create new trainings for both faculty and staff. Additional efforts to review the curriculum above and beyond existing practices may also be necessary.

Officials from the **University of Central Missouri** assumes this proposal has an indeterminate fiscal impact. There may be indirect costs associated with reviewing existing training material to ensure compliance.

Officials from the **Northwest Missouri State University** and **St. Charles Community College** each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** assumes colleges and universities could absorb the costs related to this proposal with existing resources.

In response to a similar proposal, HB 1484 (2022), officials from the **Sedalia School District 200** assumed the proposal would have no fiscal impact on their organization.

**Oversight** received a limited number of responses from school districts and institutions of higher education related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other school districts and institutions of higher education were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the MOLIS database is available upon request.

Rule Promulgation

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current appropriation.

Officials from the **Office of the Secretary of State (SOS)** note many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with its core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill prohibits public schools and institutions of higher education from requiring students to engage in any form of mandatory gender or sexual diversity training or counseling.

The bill also prohibits public school employees and employees of institutions of higher education from requiring or making as a part of a course specified concepts including but not limited to: one race or sex is inherently superior to another race or sex; an individual's moral character is necessarily determined by the individual's race or sex; and an individual should feel discomfort,


guilt, anguish, or any other form of psychological distress on account of the individual's race or sex.

This bill contains an emergency clause.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
