AN ACT

To repeal section 337.615, RSMo, and to enact in lieu thereof twenty new sections relating to social workers.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 337.615, RSMo, is repealed and twenty new sections enacted in

- 2 lieu thereof, to be known as sections 337.615, 337.616, 337.652, 337.666, 337.1000,
- 3 337.1005, 337.1010, 337.1015, 337.1020, 337.1025, 337.1030, 337.1035, 337.1040,
- 4 337.1045, 337.1050, 337.1055, 337.1060, 337.1065, 337.1070, and 337.1075, to read as
- 5 follows:
 - 337.615. 1. Each applicant for licensure as a clinical social worker shall furnish evidence to the committee that:
- 3 (1) The applicant has a master's degree from a college or university program of social 4 work accredited by the council of social work education or a doctorate degree from a school 5 of social work acceptable to the committee;
- 6 (2) The applicant has completed at least three thousand hours of supervised clinical 7 experience with a qualified clinical supervisor, as defined in section 337.600, in no less than
- 8 twenty-four months and no more than forty-eight consecutive calendar months. For any
- 9 applicant who has successfully completed at least four thousand hours of supervised clinical
- 10 experience with a qualified clinical supervisor, as defined in section 337.600, within the same
- 11 time frame prescribed in this subsection, the applicant shall be eligible for application of
- 12 licensure at three thousand hours and shall be furnished a certificate by the state committee
- 13 for social workers acknowledging the completion of said additional hours;

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

14 (3) The applicant has achieved a passing score, as defined by the committee, on an examination approved by the committee. The eligibility requirements for such examination 15 16 shall be promulgated by rule of the committee;

- (4) The applicant is at least eighteen years of age, is a United States citizen or has status as a legal resident alien, and has not been finally adjudicated and found guilty, or entered a plea of guilty or nolo contendere, in a criminal prosecution under the laws of any state, of the United States, or of any country, for any offense directly related to the duties and responsibilities of the occupation, as set forth in section 324.012, regardless of whether or not sentence has been imposed.
- 2. [Any person holding a current license, certificate of registration, or permit from another state or territory of the United States or the District of Columbia to practice clinical social work who does not meet the requirements of section 324.009 and who has had no disciplinary action taken against the license, certificate of registration, or permit for the preceding five years may be granted a license to practice clinical social work in this state if the person has received a masters or doctoral degree from a college or university program of social work accredited by the council of social work education and has been licensed to practice clinical social work for the preceding five years.
- 3. The committee shall issue a license to each person who files an application and fee as required by the provisions of sections 337.600 to 337.689 and who furnishes evidence satisfactory to the committee that the applicant has complied with the provisions of subdivisions (1) to (4) of subsection 1 of this section or with the provisions of subsection 2 of this section.

337.616. 1. For purposes of this section, the following terms mean:

- (1) "Committee", the state committee for social workers;
- "License", a license, certificate, registration, permit, accreditation, or military occupational specialty that enables a person to legally practice an occupation or profession in a particular jurisdiction;
- (3) "Military", the Armed Forces of the United States, including the Air Force, Army, Coast Guard, Marine Corps, Navy, Space Force, National Guard, and any other military branch that is designated by Congress as part of the Armed Forces of the United States, and all reserve components and auxiliaries. The term "military" also includes the military reserves and militia of any United States territory or state;

- 16 (5) "Oversight body", any board, department, agency, or office of a jurisdiction 17 that issues licenses;
- (6) "Resident military spouse", a spouse of an active-duty member of the Armed 19 Forces of the United States who has been transferred or is scheduled to be transferred to 20 the state of Missouri or an adjacent state and who is a permanent resident of the state of Missouri, who is domiciled in the state of Missouri, or who has Missouri as his or her home of record.
 - 2. Any person who holds a valid current clinical social work license issued by another state, a branch or unit of the military, a territory of the United States, or the District of Columbia, and who has been licensed for at least one year in such other jurisdiction, may submit to the committee an application for a clinical social work license in Missouri along with proof of current licensure and proof of licensure for at least one year in the other jurisdiction.

- (1) "Committee", the state committee for social workers;
- "License", a license, certificate, registration, permit, accreditation, or military occupational specialty that enables a person to legally practice an occupation or profession in a particular jurisdiction;
- (3) "Military", the Armed Forces of the United States, including the Air Force, Army, Coast Guard, Marine Corps, Navy, Space Force, National Guard, and any other military branch that is designated by Congress as part of the Armed Forces of the United States, and all reserve components and auxiliaries. The term "military" also includes the military reserves and militia of any United States territory or state;

(1) Within six months of receiving an application described in subsection 2 of this section, waive any examination, educational, or experience requirements for licensure in this state for the applicant if it determines that there were minimum education requirements and, if applicable, work experience and clinical supervision requirements in effect and the other jurisdiction verifies that the person met those requirements in order to be licensed or certified in that jurisdiction. The committee may require an applicant to take and pass an examination specific to the laws of this state; or

 - 337.1000. 1. Sections 337.1000 to 337.1075 shall be known and may be cited as the "Social Work Licensure Compact".
- 2. The purpose of this Compact is to facilitate interstate practice of Regulated Social Workers by improving public access to competent Social Work Services. The Compact preserves the regulatory authority of States to protect public health and safety through the current system of State licensure.
 - 3. This Compact is designed to achieve the following objectives:
 - (1) Increase public access to Social Work Services;
- 9 (2) Reduce overly burdensome and duplicative requirements associated with 10 holding multiple licenses;
 - (3) Enhance the Member States' ability to protect the public's health and safety;

Encourage the cooperation of Member States in regulating multistate 12 **(4)** practice; 13

- 14 Promote mobility and address workforce shortages by eliminating the necessity for licenses in multiple States by providing for the mutual recognition of other 15 16 **Member State licenses:**
 - (6) Support military families;

- 18 (7) Facilitate the exchange of licensure and disciplinary information among 19 **Member States**;
- 20 (8) Authorize all Member States to hold a Regulated Social Worker accountable for abiding by the Member State's laws, regulations, and applicable professional 22 standards in the Member State in which the client is located at the time care is rendered; 23
- 24 (9) Allow for the use of telehealth to facilitate increased access to regulated 2.5 Social Work Services.

337.1005. As used in this Compact, and except as otherwise provided, the following definitions shall apply:

- 3 (1) "Active Military Member" means any individual in full-time duty status in 4 the active armed forces of the United States including members of the National Guard 5 and Reserve.
- (2) "Adverse Action" means any administrative, civil, equitable or criminal 7 action permitted by a State's laws which is imposed by a Licensing Authority or other authority against a Regulated Social Worker, including actions against an individual's 9 license or Multistate Authorization to Practice such as revocation, suspension, probation, monitoring of the licensee, limitation on the licensee's practice, or any other Encumbrance on licensure affecting a Regulated Social Worker's authorization to practice, including issuance of a cease and desist action.
 - (3) "Alternative Program" means a non-disciplinary monitoring or practice remediation process approved by a Licensing Authority to address practitioners with an Impairment.
 - "Charter Member States" means Member States who have enacted **(4)** legislation to adopt this Compact where such legislation predates the effective date of this Compact as defined in section 337.1065.
- 19 (5) "Compact Commission" or "Commission" means the government agency whose membership consists of all States that have enacted this Compact, which is 20 21 known as the Social Work Licensure Compact Commission, as defined in section 22 337.1045, and which shall operate as an instrumentality of the Member States.
 - (6) "Current Significant Investigative Information" means:

(a) Investigative information that a Licensing Authority, after a preliminary inquiry that includes notification and an opportunity for the Regulated Social Worker to respond has reason to believe is not groundless and, if proved true, would indicate more than a minor infraction as may be defined by the Commission; or

- (b) Investigative information that indicates that the Regulated Social Worker represents an immediate threat to public health and safety, as may be defined by the Commission, regardless of whether the Regulated Social Worker has been notified and has had an opportunity to respond.
- (7) "Data System" means a repository of information about Licensees, including, but not limited to, continuing education, examination, licensure, Current Significant Investigative Information, Disqualifying Event, Multistate License(s) and Adverse Action information or other information as required by the Commission.
- (8) "Domicile" means the jurisdiction in which the licensee resides and intends to remain indefinitely.
- (9) "Disqualifying Event" means any Adverse Action or incident which results in an encumbrance that disqualifies or makes the Licensee ineligible to either obtain, retain or renew a Multistate License.
- (10) "Encumbered License" means a license in which an Adverse Action restricts the practice of Social Work by the Licensee and said Adverse Action may be reportable to the National Practitioners Data Bank (NPDB).
- (11) "Encumbrance" means a revocation or suspension of, or any limitation on, the full and unrestricted practice of Social Work licensed and regulated by a Licensing Authority.
- 47 (12) "Executive Committee" means a group of delegates elected or appointed to 48 act on behalf of, and within the powers granted to them by, the compact and 49 Commission.
- 50 (13) "Home State" means the Member State that is the Licensee's primary 51 Domicile.
 - (14) "Impairment" means a condition(s) that may impair a practitioner's ability to engage in full and unrestricted practice as a Regulated Social Worker without some type of intervention and may include, but are not limited to, alcohol and drug dependence, mental health impairment, and neurological or physical impairments.
- 15) "Multistate License" means a license to practice as a Regulated Social Worker issued by a Home State Licensing Authority that authorizes the Regulated Social Worker to practice in all Member States under a Multistate Authorization to Practice.

- 60 (16) "Licensee(s)" means an individual who currently holds a license from a 61 State to practice as a Regulated Social Worker.
- 62 (17) "Licensing Authority" means the board or agency of a Member State, or 63 equivalent, that is responsible for the licensing and regulation of Regulated Social 64 Workers.
- (18) "Member State" means a state, commonwealth, district, or territory of the United States of America that has enacted this Compact.
 - (19) "Multistate Authorization to Practice" means a legally authorized privilege to practice, which is equivalent to a license, associated with a Multistate License permitting the practice of Social Work in a Remote State.
- 70 (20) "Qualifying National Exam" means a national licensing examination 71 approved by the Commission.
 - (21) "Regulated Social Worker" means any clinical, master's or bachelor's Social Worker licensed by a Member State regardless of the title used by that Member State.
- 75 (22) "Remote State" means a Member State other than the Home State, where a 76 Licensee is exercising or seeking to exercise the Multistate Authorization to Practice.
 - (23) "Rule(s)" or "Rule(s) of the Commission" means a regulation or regulations duly promulgated by the Commission, as authorized by the compact, that has the force of law.
 - (24) "Single State License" means a Social Work license issued by any state that authorizes practice only within the issuing State and does not include a Multistate Authorization to Practice in any Member State.
 - (25) "Social Work" or "Social Work Services" means the application of social work theory, knowledge, methods, ethics, and the professional use of self to restore or enhance social, psychosocial, or biopsychosocial functioning of individuals, couples, families, groups, organizations, and communities through the care and services provided by a Regulated Social Worker as set forth in the Member State's statutes and regulations in the State where the services are being provided.
- 89 (26) "State" means any state, commonwealth, district, or territory of the United 90 States of America that regulates the practice of Social Work.
- 91 (27) "Unencumbered License" means a license that authorizes a Regulated 92 Social Worker to engage in the full and unrestricted practice of Social Work.
 - 337.1010. 1. To be eligible to participate in the compact, a potential Member State must currently meet all of the following criteria:
- 3 (1) License and regulate the practice of Social Work at either the clinical, 4 master's, or bachelor's category.

5 **(2)** Require applicants for licensure to graduate from a program that is accredited, or in candidacy by an institution that subsequently becomes accredited, by an accrediting agency recognized by the Council for Higher Education Accreditation, or its successor, or by the United States Department of Education and operated by a college or university recognized by the Licensing Authority and that corresponds to the licensure sought as outlined in section 337.1015. 10

- (3) Require applicants for clinical licensure to complete a period of supervised 12 practice.
 - (4) Have a mechanism in place for receiving, investigating, and adjudicating complaints about Licensees.
 - 2. To maintain membership in the Compact a Member State shall:
 - (1) Require applicants for a Multistate License pass a Qualifying National Exam for the corresponding category of Multistate License sought as outlined in section 337.1015;
 - (2) Participate fully in the Commission's Data System, including using the Commission's unique identifier as defined in Rules;
 - (3) Notify the Commission, in compliance with the terms of the Compact and rules, of any Adverse Action or the availability of Current Significant Investigative Information regarding a Licensee;
 - Implement procedures for considering the criminal history records of applicants for a Multistate License. Such procedures shall include the submission of fingerprints or other biometric-based information by applicants for the purpose of obtaining an applicant's criminal history record information from the Federal Bureau of Investigation and the agency responsible for retaining that state's criminal records;
 - (5) Comply with the Rules of the Commission;
 - (6) Require an applicant to obtain or retain a license in the Home State and meet the Home State's qualifications for licensure or renewal of licensure, as well as all other applicable Home State laws;
 - (7) Authorize a Licensee holding a Multistate License in any Member State to practice in accordance with the terms of the Compact and Rules of the Commission; and
 - (8) Designate a delegate to participate in the Commission meetings.
 - 3. A Member State meeting the requirements of subsections 1 and 2 of this section shall designate the categories of Social Work licensure that are eligible for issuance of a Multistate License for applicants in such Member State. To the extent that any Member State does not meet the requirements for participation in the Compact at any particular category of Social Work licensure, such Member State may choose, but is not obligated to, issue a Multistate License to applicants that otherwise meet the

- 4. Home States may charge a fee for granting the Multistate License.
- 337.1015. 1. To be eligible for a Multistate License under the terms and provisions of the compact, an applicant, regardless of category must:
 - (1) Hold or be eligible for an active, Unencumbered License in the Home State;
 - (2) Pay any applicable fees, including any State fee, for the Multistate License;
- (3) Submit, in connection with an application for a Multistate License, fingerprints or other biometric data for the purpose of obtaining criminal history record information from the Federal Bureau of Investigation and the agency responsible for retaining that state's criminal records;
- 9 (4) Notify the Home State of any Adverse Action, Encumbrance, or restriction 10 on any professional license taken by any Member State or non-Member State within 30 11 days from the date the action is taken;
- 12 (5) Meet any continuing competence requirements established by the Home 13 State;
- 14 (6) Abide by the laws, regulations, and applicable standards in the Member 15 State where the client is located at the time care is rendered.
- 2. An applicant for a clinical-category Multistate License must meet all of the following requirements:
 - (1) Fulfill a competency requirement, which shall be satisfied by either:
 - (a) Passage of a clinical-category Qualifying National Exam; or
- 20 (b) Licensure of the applicant in their Home State at the clinical category, 21 beginning prior to such time as a Qualifying National Exam was required by the Home 22 State and accompanied by a period of continuous Social Work licensure thereafter, all of 23 which may be further governed by the Rules of the Commission; or
- (c) The substantial equivalency of the foregoing competency requirements which the Commission may determine by Rule.
 - (2) Attain at least a master's degree in Social Work from a program that is:
- 27 (a) Operated by a college or university recognized by the Licensing Authority; 28 and
- 29 **(b)** Accredited, or in candidacy that subsequently becomes accredited, by an 30 accrediting agency recognized by either:
 - a. the Council for Higher Education Accreditation or its successor; or
- 32 b. the United States Department of Education.
- 33 (3) Fulfill a practice requirement, which shall be satisfied by demonstrating 34 completion of either:

- 35 (a) A period of postgraduate supervised clinical practice equal to a minimum of three thousand hours; or 36
- 37 (b) A minimum of two years of full-time postgraduate supervised clinical 38 practice; or
- 39 (c) The substantial equivalency of the foregoing practice requirements which the 40 Commission may determine by Rule.
 - 3. An applicant for a master's-category Multistate License must meet all of the following requirements:
 - (1) Fulfill a competency requirement, which shall be satisfied by either:
 - (a) Passage of a masters-category Qualifying National Exam;

 - 3. The Commission shall exercise its Rulemaking powers pursuant to the criteria set forth in this Section and the Rules adopted thereunder. Rules shall become binding on the day following adoption or the date specified in the rule or amendment, whichever is later.
 - 4. If a majority of the legislatures of the Member States rejects a Rule or portion of a Rule, by enactment of a statute or resolution in the same manner used to adopt the Compact within four (4) years of the date of adoption of the Rule, then such Rule shall have no further force and effect in any Member State.
 - 5. Rules shall be adopted at a regular or special meeting of the Commission.
 - 6. Prior to adoption of a proposed Rule, the Commission shall hold a public hearing and allow persons to provide oral and written comments, data, facts, opinions, and arguments.
 - 7. Prior to adoption of a proposed Rule by the Commission, and at least thirty (30) days in advance of the meeting at which the Commission will hold a public hearing on the proposed Rule, the Commission shall provide a Notice of Proposed Rulemaking:
 - (1) On the website of the Commission or other publicly accessible platform;
- To persons who have requested notice of the Commission's notices of 30 proposed rulemaking; and
 - (3) In such other way(s) as the Commission may by Rule specify.
 - 8. The Notice of Proposed Rulemaking shall include:
- 33 (1) The time, date, and location of the public hearing at which the Commission will hear public comments on the proposed Rule and, if different, the time, date, and 35 location of the meeting where the Commission will consider and vote on the proposed 36 Rule:
- (2) If the hearing is held via telecommunication, video conference, or other electronic means, the Commission shall include the mechanism for access to the hearing 39 in the Notice of Proposed Rulemaking;
 - (3) The text of the proposed Rule and the reason therefor;

41 (4) A request for comments on the proposed Rule from any interested person; 42 and

- (5) The manner in which interested persons may submit written comments.
- 9. All hearings will be recorded. A copy of the recording and all written comments and documents received by the Commission in response to the proposed Rule shall be available to the public.
 - 10. Nothing in this section shall be construed as requiring a separate hearing on each Rule. Rules may be grouped for the convenience of the Commission at hearings required by this section.
 - 11. The Commission shall, by majority vote of all members, take final action on the proposed Rule based on the Rulemaking record and the full text of the Rule.
 - (1) The Commission may adopt changes to the proposed Rule provided the changes do not enlarge the original purpose of the proposed Rule.
 - (2) The Commission shall provide an explanation of the reasons for substantive changes made to the proposed Rule as well as reasons for substantive changes not made that were recommended by commenters.
 - (3) The Commission shall determine a reasonable effective date for the Rule. Except for an emergency as provided in subsection 12 of this section, the effective date of the rule shall be no sooner than 30 days after issuing the notice that it adopted or amended the Rule.
 - 12. Upon determination that an emergency exists, the Commission may consider and adopt an emergency Rule with 48 hours' notice, with opportunity to comment, provided that the usual Rulemaking procedures provided in the Compact and in this section shall be retroactively applied to the Rule as soon as reasonably possible, in no event later than ninety (90) days after the effective date of the Rule. For the purposes of this provision, an emergency Rule is one that must be adopted immediately in order to:
 - (1) Meet an imminent threat to public health, safety, or welfare;
 - (2) Prevent a loss of Commission or Member State funds;
 - (3) Meet a deadline for the promulgation of a Rule that is established by federal law or rule; or
 - (4) Protect public health and safety.
 - 13. The Commission or an authorized committee of the Commission may direct revisions to a previously adopted Rule for purposes of correcting typographical errors, errors in format, errors in consistency, or grammatical errors. Public notice of any revisions shall be posted on the website of the Commission. The revision shall be subject to challenge by any person for a period of thirty (30) days after posting. The revision may be challenged only on grounds that the revision results in a material change to a

78 Rule. A challenge shall be made in writing and delivered to the Commission prior to the

- end of the notice period. If no challenge is made, the revision will take effect without
- further action. If the revision is challenged, the revision may not take effect without the
- approval of the Commission. 81

- 82 14. No Member State's rulemaking requirements shall apply under this 83 compact.
 - 337.1060. 1. (1) The executive and judicial branches of State government in each Member State shall enforce this Compact and take all actions necessary and appropriate to implement the Compact.
- (2) Except as otherwise provided in this Compact, venue is proper and judicial proceedings by or against the Commission shall be brought solely and exclusively in a 6 court of competent jurisdiction where the principal office of the Commission is located. The Commission may waive venue and jurisdictional defenses to the extent it adopts or consents to participate in alternative dispute resolution proceedings. Nothing herein shall affect or limit the selection or propriety of venue in any action against a licensee for professional malpractice, misconduct or any such similar matter.
 - The Commission shall be entitled to receive service of process in any proceeding regarding the enforcement or interpretation of the Compact and shall have standing to intervene in such a proceeding for all purposes. Failure to provide the Commission service of process shall render a judgment or order void as to the Commission, this Compact, or promulgated Rules.
 - 2. (1) If the Commission determines that a Member State has defaulted in the performance of its obligations or responsibilities under this Compact or the promulgated Rules, the Commission shall provide written notice to the defaulting State. The notice of default shall describe the default, the proposed means of curing the default, and any other action that the Commission may take, and shall offer training and specific technical assistance regarding the default.
 - (2) The Commission shall provide a copy of the notice of default to the other Member States.
 - 3. If a State in default fails to cure the default, the defaulting State may be terminated from the Compact upon an affirmative vote of a majority of the delegates of the Member States, and all rights, privileges and benefits conferred on that state by this Compact may be terminated on the effective date of termination. A cure of the default does not relieve the offending State of obligations or liabilities incurred during the period of default.
 - 4. Termination of membership in the Compact shall be imposed only after all other means of securing compliance have been exhausted. Notice of intent to suspend or

terminate shall be given by the Commission to the governor, the majority and minority leaders of the defaulting State's legislature, the defaulting State's State Licensing Authority and each of the Member States' State Licensing Authority.

- 5. A State that has been terminated is responsible for all assessments, obligations, and liabilities incurred through the effective date of termination, including obligations that extend beyond the effective date of termination.
- 6. Upon the termination of a State's membership from this Compact, that State shall immediately provide notice to all Licensees within that State of such termination. The terminated State shall continue to recognize all licenses granted pursuant to this Compact for a minimum of six (6) months after the date of said notice of termination.
- 7. The Commission shall not bear any costs related to a State that is found to be in default or that has been terminated from the Compact, unless agreed upon in writing between the Commission and the defaulting State.
- 8. The defaulting State may appeal the action of the Commission by petitioning the U.S. District Court for the District of Columbia or the federal district where the Commission has its principal offices. The prevailing party shall be awarded all costs of such litigation, including reasonable attorney's fees.
- 9. (1) Upon request by a Member State, the Commission shall attempt to resolve disputes related to the Compact that arise among Member States and between Member and non-Member States.
- (2) The Commission shall promulgate a Rule providing for both mediation and binding dispute resolution for disputes as appropriate.
- 10. (1) By majority vote as provided by Rule, the Commission may initiate legal action against a Member State in default in the United States District Court for the District of Columbia or the federal district where the Commission has its principal offices to enforce compliance with the provisions of the Compact and its promulgated Rules. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing party shall be awarded all costs of such litigation, including reasonable attorney's fees. The remedies herein shall not be the exclusive remedies of the Commission. The Commission may pursue any other remedies available under federal or the defaulting Member State's law.
- (2) A Member State may initiate legal action against the Commission in the U.S. District Court for the District of Columbia or the federal district where the Commission has its principal offices to enforce compliance with the provisions of the Compact and its promulgated Rules. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing party shall be awarded all costs of such litigation, including reasonable attorney's fees.

- 69 (3) No person other than a Member State shall enforce this compact against the 70 Commission.
 - 337.1065. 1. (1) The Compact shall come into effect on the date on which the Compact statute is enacted into law in the seventh Member State.
- (2) On or after the effective date of the Compact, the Commission shall convene 4 and review the enactment of each of the first seven Member States ("Charter Member States") to determine if the statute enacted by each such Charter Member State is 6 materially different than the model Compact statute.
- (a) A Charter Member State whose enactment is found to be materially different 8 from the model Compact statute shall be entitled to the default process set forth in section 337.1060.
- 10 (b) If any Member State is later found to be in default, or is terminated or 11 withdraws from the Compact, the Commission shall remain in existence and the Compact shall remain in effect even if the number of Member States should be less than 13 seven.

 - (1) Any State that joins the Compact subsequent to the Commission's initial adoption of the Rules and bylaws shall be subject to the Rules and bylaws as they exist on the date on which the Compact becomes law in that State. Any Rule that has been previously adopted by the Commission shall have the full force and effect of law on the day the Compact becomes law in that State.
 - (2) Any Member State may withdraw from this Compact by enacting a statute repealing the same.
 - 4. A Member State's withdrawal shall not take effect until 180 days after enactment of the repealing statute.
- 5. Withdrawal shall not affect the continuing requirement of the withdrawing State's Licensing Authority to comply with the investigative and Adverse Action 32 reporting requirements of this Compact prior to the effective date of withdrawal.
- 6. Upon the enactment of a statute withdrawing from this compact, a State shall immediately provide notice of such withdrawal to all Licensees within that State. 35

The provisions of this Compact shall be severable and if any phrase, clause, sentence or provision of this Compact is held by a court of competent jurisdiction to be contrary to the constitution of any Member State, a State seeking participation in the Compact, or of the United States, or the applicability thereof to any government, agency, person or circumstance is held to be unconstitutional by a court of competent jurisdiction, the validity of the remainder of this Compact and the applicability thereof to any other government, agency, person or circumstance shall not be affected thereby.
 - 3. Notwithstanding subsection 2 of this section, the Commission may deny a State's participation in the Compact or, in accordance with the requirements of subsections 2 and 3 of section 337.1060, terminate a Member State's participation in the Compact, if it determines that a constitutional requirement of a Member State is a material departure from the Compact. Otherwise, if this Compact shall be held to be contrary to the constitution of any Member State, the Compact shall remain in full force and effect as to the remaining Member States and in full force and effect as to the Member State affected as to all severable matters.
- 337.1075. 1. A Licensee providing services in a Remote State under a Multistate
 Authorization to Practice shall adhere to the laws and regulations, including laws,
 regulations, and applicable standards, of the Remote State where the client is located at
 the time care is rendered.
