HOUSE RESOLUTION NO. 256

NOW THEREFORE BE IT RESOLVED by the Missouri House of Representatives, One Hundred Second General Assembly, First Regular Session, that the Rules of the House of Representatives be amended by adding thereto one new rule, as follows:

HOUSE HEARING ROOMS

RULE 130. Members may reserve House hearing rooms for the purpose of conducting religious study, prayer, and worship between the hours of 7:00 a.m. to 9:00 p.m., Monday through Friday, subject to the following provisions:

- (1) Activities shall not interfere with the official business of the House and shall be conducted only at times when hearings and committee meetings are not scheduled;
 - (2) Activities shall not violate any state law;
- (3) Music and singing are permissible but such activities shall be conducted at a volume and in a manner that does not disrupt business conducted outside of the hearing room;
- (4) The member reserving the hearing room, or his or her designee, shall be present and assume responsibility for the group's actions for the duration of the activities;
- (5) The member reserving the hearing room, or his or her designee, shall ensure that the hearing room is undamaged and cleaned upon the conclusion of the activities; and
 - (6) State information systems technology or audiovisual systems shall not be used to support the activities.

Members reserving hearing rooms are required to coordinate with the chair of the Committee on Administration and Accounts to schedule the hearing room and the time for such activities. Approval or denial of a request that complies with the provisions of this rule shall not be based on the content or ideology of the religious activity or service.

BE IT FURTHER RESOLVED that the Chief Clerk of the Missouri House of Representatives be instructed to prepare a properly inscribed copy of this resolution.
