#### PERFECTION OF HOUSE BILLS - INFORMAL

**HCS HB 253**, relating to admission of nonresident pupils, was taken up by Representative Pollitt.

On motion of Representative Pollitt, the title of HCS HB 253 was agreed to.

Representative Hudson assumed the Chair.

Representative Black offered House Amendment No. 1.

House Amendment No. 1

AMEND House Committee Substitute for House Bill No. 253, Page 8, Section 167.1205, Lines 24 to 27, by deleting all of the said lines and inserting in lieu thereof the following:

"(4) (a) Districts may restrict the number of students who may transfer to a nonresident district under sections 167.1200 to 167.1230 in each school year to a maximum of three percent of the previous school year's enrollment for the district."; and

Further amend said bill, Pages 12 to 13, Section 167.1210, Lines 23 to 36, by deleting all of the said lines and inserting in lieu thereof the following:

"4. (1) The transferring student or the student's parent is responsible for the transportation of the student to and from the school in the nonresident district where the student is enrolled.

(2) A nonresident district may enter into an agreement with the student's parent that the parent may transport the student to an existing bus stop location convenient to the school district if the school district has capacity available on a bus serving that location."; and

Further amend said bill and section, Page 13, Lines 41 to 47, by deleting all of the said lines and inserting in lieu thereof the following:

- "6. (1) (a) Notwithstanding the provisions of subsection 4 of this section to the contrary, any transferring student described in paragraph (b) of this subdivision:
  - a. Shall be offered transportation services provided by the nonresident district; or
- b. May choose to be reimbursed by the parent public school choice fund established in section 167.1212 for the costs of transportation of the student as provided in this subsection.
- (b) Paragraph (a) of this subdivision shall apply to a transferring student who transfers to any nonresident district sharing a border with the student's resident district and who:
  - a. Qualifies for free and reduced price meals under federal guidelines; or
  - b. Has transportation as a related service on such student's individualized education program (IEP).
- (2) The amount of transportation costs eligible for reimbursement to such transferring student or the student's parent under subparagraph b. of paragraph (a) of subdivision (1) of this subsection shall be,"; and

Further amend said bill, page, and section, Lines 59 to 61, by deleting the said lines and inserting in lieu thereof the following:

- "(5) A transferring student who transfers to a nonresident district that does not share a border with the student's resident district shall be eligible for a transfer if the student's parent enters into an agreement with the noncontiguous nonresident district that contains a statement that the parent waives both:
- (a) Transportation services as described in subparagraph a. of paragraph (a) of subdivision (1) of this subsection including, but not limited to, any transportation as a related service under the student's IEP; and
- (b) Reimbursement for transportation costs as described in subparagraph b. of paragraph (a) of subdivision (1) of this subsection."; and

Further amend said bill and section, Page 14, Lines 68 to 69, by deleting all of the said lines and inserting in lieu thereof the following:

"parent public school choice fund established in section 167.1212 for the actual transportation costs for the student on a quarterly basis and in a manner determined by the department."; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.

AMEND House Committee Substitute for House Bill No. 253, Pages 6 to 7, Section 167.1200, Lines 5 to 9, by deleting all of the said lines and inserting in lieu thereof the following:

"(2) "Nonresident district", a school district other than a transferring student's"; and

Further amend said bill, page, and section, by renumbering subsequent subdivisions accordingly; and

Further amend said bill, Pages 18 to 19, Section 167.1225, Lines 1 to 34, by deleting all of the said lines and inserting in lieu thereof the following:

"167.1225. 1. Any student transferring from a resident school district may participate in the public school open enrollment program under sections 167.1200 to 167.1230 if such student's transfer does not cause the district to conflict with a provision of an enforceable desegregation court order or a district's court approved desegregation plan.

2. (1) Any student who transfers to a nonresident district under section 167.131,"; and

Further amend said bill and section, Page 19, Line 41, by deleting the number "5." and inserting in lieu thereof the number "3."; and

Further amend said bill, Section 167.1229, Page 20, Lines 4 to 7, by deleting all of the said lines and inserting in lieu thereof the following:

#### "167.1200 to 167.1230"; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.

Further amend said bill and section, Page 7, Line 207, by inserting after all of the said line the following:

"(16) A host district may contract with a provider to perform any required services involved with delivering a full time virtual education."; and

AMEND House Committee Substitute for House Bill No. 461, Page 3, Section 1.512, Line 72, by deleting the number "(5)" and inserting in lieu thereof the number "(6)"; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.

On motion of Representative Riggs, **House Amendment No. 2** was adopted.

#### House Amendment No. 3

AMEND House Committee Substitute for House Bill No. 461, Page 5, Section 1.512, Line 138, by inserting after all of said section and line the following:

- "227.675. 1. The provisions of this section shall be known and may be cited as the "Department of Transportation Fiber Network Expansion Act".
  - 2. For purposes of this section, the following terms mean:
  - (1) "Commission", the Missouri highways and transportation commission;
  - (2) "Department", the Missouri department of transportation.
- 3. The commission may enter into public-private partnerships with private broadband internet service providers to expand and further develop the department's fiber network.
- 4. The commission shall prioritize expansion and development under this section in unserved areas and underserved areas, as such terms are defined in section 620.2450.
- 5. The commission shall use a competitive procurement process to form public-private partnerships under this section. The commission shall publish a public notice of the commission's request for proposals, including any deadline for submission of such proposals, which shall be published once a week for two consecutive weeks in:
  - (1) A newspaper of general circulation in the city where the proposed project is located;
  - (2) At least one technology industry trade publication that is nationally distributed; and
  - (3) Such other publications or manner as the commission may determine.
- 6. As part of a contract award under this section, the private partnering entity may use the excess fiber capacity to provide internet services as long as the services provided meet the state minimum standard for broadband set by the department of economic development.
- 7. The commission may promulgate any rules to implement the provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after August 28, 2023, shall be invalid and void."; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.
