HCS HB 909, relating to solid waste disposal area permits, was taken up by Representative Haffner.

House Amendment No. 1

AMEND House Committee Substitute for House Bill No. 909, Page 5, Section 260.205, Line 163, by adding after the word "county," the following:

"any city with more than one hundred sixty thousand but fewer than two hundred thousand inhabitants located in any county with more than two hundred sixty thousand but fewer than three hundred thousand inhabitants, any county with more than one million inhabitants, or any county with more than two hundred thousand but fewer than two hundred thirty thousand inhabitants,"; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.

AMEND House Committee Substitute for House Bill No. 909, Page 5, Section 260.205, Line 163, by deleting "~~one-half~~ **one**" and inserting in lieu thereof "one-half"; and

Further amend said section and page, Line 164, by inserting after the word "municipality." the following:

"Beginning January 1, 2026, the distance requiring the approval of an adjoining municipality under this subsection 9 shall be increased from one-half mile to one mile, but under no circumstances shall the one-mile limit apply to any solid waste processing facility or disposal area that was issued a construction permit prior to January 1, 2026."; and

House Amendment No. 2

AMEND House Committee Substitute for House Bill Nos. 556 & 581, Page 22, Section 313.1016, Line 24, by inserting after all of said section and line the following:

"313.1017. 1. There is hereby created a revolving fund for the department of elementary and secondary education which shall be known as the "Elementary and Secondary Education School Supplies Fund", and which shall be administered by the commissioner of the department of elementary and secondary education. The fund shall consist of moneys received from the wagering tax established in section 313.1021 to such fund, and any moneys paid into the state treasury and required by law to be credited to such fund. The elementary and secondary education school supplies fund shall be kept separate and apart from all other moneys in the state treasury and shall be paid out by the state treasurer pursuant to chapter 33.

2. After appropriation pursuant to law, the moneys in the elementary and secondary education school supplies fund shall be available for the payment of the costs and expenses for school supplies as defined in section 144.049.

3. All revenue collected through cost recovery activities authorized pursuant to law shall be credited to the elementary and secondary education school supplies fund.

4. Any unexpended balance in the elementary and secondary education school supplies fund at the end of each fiscal year shall be exempt from the provisions of section 33.080 relating to the transfer of unexpended balances to the general revenue fund.

5. Moneys in the elementary and secondary education school supplies fund shall be invested by the state treasurer in the same deposits and obligations in which state funds are authorized by law to be invested; except that, the income accruing from such investments shall be credited to the elementary and secondary education school supplies fund on an annual basis."; and

Further amend said bill and page, Section 313.1021, Lines 18-19, by deleting said lines and inserting in lieu thereof the following:

"shall be deposited in the state treasury to the credit of the elementary and secondary education school supplies fund, which shall be distributed as provided under section 313.1017."; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.

AMEND House Committee Substitute for House Bill Nos. 556 & 581, Page 22, Section 313.1016, Line 24, by inserting after all of said section and line the following:

"313.1017. 1. There is hereby created in the state treasury the "Elementary and Secondary Education School Supplies Fund", which shall consist of moneys collected under section 313.1021. The state treasurer shall be custodian of the fund. In accordance with sections 30.170 and 30.180, the state treasurer shall approve disbursements. The fund shall be a dedicated fund and, upon disbursements, moneys in the fund shall be used solely as provided in this section.

2. Notwithstanding the provisions of section 33.080, to the contrary, any moneys remaining in the fund at the end of the biennium shall not revert to the credit of the general revenue fund.

3. The state treasurer shall invest moneys in the fund in the same manner as other funds are invested. Any interest and moneys earned on such investments shall be credited to the fund.

4. The state board of education shall disperse to public schools in this state based on an average daily attendance basis moneys in the elementary and secondary education school supplies fund solely for the payment of the costs and expenses for school supplies and personal computers as those terms are defined in section 144.049 at the discretion of the local school district."; and

Further amend said bill and page, Section 313.1021, Lines 18-19, by deleting said lines and inserting in lieu thereof the following:

"shall be deposited in the state treasury to the credit of the elementary and secondary education school supplies fund, which shall be distributed as provided under section 313.1017."; and

Further amend said bill by amending the title, enacting clause, and intersectional references accordingly.
