2. For all tax years beginning on or after January 1, ~~[2017]~~ **2023**, in addition to all other modifications allowed by law, a taxpayer shall be allowed a deduction from the taxpayer's federal adjusted gross income when determining Missouri adjusted gross income in an amount equal to fifty percent of the net capital gain from the sale or exchange of employer securities of a Missouri corporation to a qualified Missouri employee stock ownership plan if, upon completion of the transaction, the qualified Missouri employee stock ownership plan owns at least thirty percent of all outstanding employer securities issued by the Missouri corporation.

3. Whenever an employee leaves a Missouri corporation with a qualified Missouri employee stock ownership plan, the Missouri corporation shall inform the former employee of the deadline for when the former employee shall decide whether they will receive their shares of employer securities or compensation for their shares of employer securities.

Such position shall end when the medical residency funding under this section is completed or when the resident in the medical grant-funded residency position is no longer employed by the eligible entity, whichever is earlier;**

(5) "Participating medical resident", an individual who is a medical school graduate with a doctor of medicine degree or doctor of osteopathic medicine degree, who is participating in a postgraduate training program at an eligible entity, and who is filling a grant-funded residency position.

2. (1) Subject to appropriation, the department shall establish a medical residency grant program to award grants to eligible entities for the purpose of establishing and funding new general primary care and psychiatry medical residency positions in this state and continuing the funding of such new residency positions for the duration of the funded residency.

(2) (a) Funding shall be available for three years for residency positions in family medicine, general internal medicine, and general pediatrics.

(b) Funding shall be available for four years for residency positions in general obstetrics and gynecology, internal medicine-pediatrics, and general psychiatry.

3. (1) There is hereby created in the state treasury the "Medical Residency Grant Program Fund". Moneys in the fund shall be used to implement and fund grants to eligible entities.

(2) The medical residency grant program fund shall include funds appropriated by the general assembly, reimbursements from awarded eligible entities who were not able to fill the residency position or positions with an individual medical resident or residents, and any gifts, contributions, grants, or bequests received from federal, private, or other sources.

(3) The state treasurer shall be custodian of the fund. In accordance with sections 30.170 and 30.180, the state treasurer may approve disbursements. The fund shall be a dedicated fund and, upon appropriation, moneys in the fund shall be used solely as provided in this section.

(4) Notwithstanding the provisions of section 33.080 to the contrary, any moneys remaining in the fund at the end of the biennium shall not revert to the credit of the general revenue fund.

(5) The state treasurer shall invest moneys in the fund in the same manner as other funds are invested. Any interest and moneys earned on such investments shall be credited to the fund.

4. Subject to appropriation, the department shall expend moneys in the medical residency grant program fund in the following order:

(1) Necessary costs of the department to implement this section;

(2) Funding of grant-funded residency positions of individuals in the fourth year of their residency, as applicable to residents in general obstetrics and gynecology, internal medicine-pediatrics, and general psychiatry;

(3) Funding of grant-funded residency positions of individuals in the third year of their residency;

(4) Funding of grant-funded residency positions of individuals in the second year of their residency;

(5) Funding of grant-funded residency positions of individuals in the first year of their residency; and

(6) The establishment of new grant-funded residency positions at awarded eligible entities.

5. The department shall establish criteria to evaluate which eligible entities shall be awarded grants for new grant-funded residency positions, criteria for determining the amount and duration of grants, the contents of the grant application, procedures and timelines by which eligible entities may apply for grants, and all other rules needed to implement the purposes of this section. Such criteria shall include a preference for eligible entities located in areas of highest need for general primary care and psychiatric care physicians, as determined by the health professional shortage area score.

6. Eligible entities that receive grants under this section shall:

(1) Agree to supplement awarded funds under this section, if necessary, to establish or maintain a grant-funded residency position for the duration of the funded resident's medical residency; and

(2) Agree to abide by other requirements imposed by rule.

7. Annual funding per participating medical resident shall be limited to:

(1) Direct graduate medical education costs including, but not limited to:

(a) Salaries and benefits for residents, faculty, and program staff;

(b) Malpractice insurance, licenses, and other required fees; and

(c) Program administration and educational materials; and

(2) Indirect costs of graduate medical education necessary to meet the standards of the Accreditation Council for Graduate Medical Education.

8. No new grant-funded residency positions under this section shall be established after the tenth fiscal year in which grants are awarded. However, any residency positions funded under this section may continue to be funded until the completion of the resident's medical residency.

9. The department shall submit an annual report to the general assembly regarding the implementation of the program developed under this section.

10. The department may promulgate all necessary rules and regulations for the administration of this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. **HEC 1**

On January 5, 2023, a petition was filed with the Chief Clerk of the Missouri House of Representatives requesting a recount of the votes cast during the 2022 Missouri House District 105 General Election. This petition, HEC 1, alleges the following in support of its request for a recount:

- Contestee Schwadron received 5,404 votes.
- Contestant Berne received 5,305 votes.
- This 99 vote difference constituted 0.9% of the total votes cast.
- Pursuant to RSMo 115.563, all contested elections for the office of state representative shall be heard and determined by the state house of representatives.
- Pursuant to RSMo 115.601, candidates defeated by less than one percent of the votes cast shall have a right to a recount.

Contestant's petition does not allege any irregularity or impropriety on the part of any election official in the conduct of this election. Contestant's petition does not challenge the validity of any vote cast or counted in this election. Contestant's only request is for a recount based on the number of votes that decided the election.



### **Activities of the Special Committee**

- On January 11, 2023, the Speaker established the Special Committee on Election Contests and appointed Representative Dan Stacy as Chair and Representative Mike Henderson as Vice-Chair. Representatives Kimberly-Ann Collins, Rick Francis, Peggy McGaugh, Alex Riley, and Mark Sharp were appointed as members of the committee. HEC 1 was referred to the Special Committee on Election Contests on January 11, 2023.
- On February 9, 2023 the committee heard testimony from Kurt Bahr, the Saint Charles County Director of Elections.
- On February 22, 2023 the committee heard testimony from Chrissy Peters, the Director of Elections in the Missouri Secretary of State's office.
- On March 1, 2023 the committee heard testimony from contestant Berne's legal counsel, Matt Vianello, and contestee Schwadron's legal counsel, Lowell Pearson.

### **Notice of Requested Relief**

During the March 1, 2023 hearing of the Special Committee on Election Contests, the chair indicated that the committee required more information from the contestant in order to make a determination on the appropriateness of a recount. The contestant and her counsel responded by providing the chair with a notice of requested relief. The notice indicates the following:

- Contestant requests a hand recount of all votes cast in the 2022 general election for Missouri House District 105 in which questions of voter intent arise during the recount.
- Contestant requests a hand recount of all absentee ballots cast, whether counted or not.
- Contestant requests a hand recount of all provisional ballots cast, whether counted or not.
- Contestant requests a review of all affidavits submitted by voters in connection with their attempt to vote.
- Contestant requests a machine recount of all ballots in which a voter's intent is not at issue.
- Contestant requests the Special Committee appoint the relevant persons necessary to perform the recount.

### **Findings of the Committee**

A review of public testimony delivered to the committee found the following:

- Longstanding employees of the Saint Charles County Election Authority are aware of no instance in which a recount changed the outcome of an election.
- In every manual recount performed by Director Bahr since he entered his post at the Saint Charles County Election Authority in January 2019, the result of the recount has matched that of the election.
- Director Bahr already performed a recount of one of the precincts from this race as part of his office's audit of the 2022 general election. The results of the audit matched the results reported after the election.
- Since 2000, the Secretary of State's office has performed 24 recounts. Not one recount performed in this 23 year period has reversed the result of an election.

A review of recent House actions on election contests found the following:

- Since 1997, three requests for recount have been made to the House of Representatives.
- In 1997, contestant Michael Frame petitioned the House for a recount of the 1996 general election for Missouri House District 105. Contestee Marilyn Edwards won the election by a margin of 15 votes. The House ordered a recount, the results of which confirmed the results of the election, by a margin of 14 votes.
- In 2000, Bobbie J Campbell lost the general election for Missouri House District 41 to Melba J. Curls. The Reform Party requested a recount. Finding that the party had no standing to make this request, the committee voted unanimously to take no action on the petition.
- In 2011, contestants Sean O'Toole and Will Royster petitioned the House for a recount of the 2010 primary election results for Missouri House District 40. Contestee John Rizzo won his primary by a single vote. The committee took no action on the petition.

A review of relevant statutes and constitutional provisions found the following:

- Article III Section 18 of the Missouri Constitution makes each house of the General Assembly the sole judge of qualifications, election and returns of its own members.
- Article VII Section 5 of the Missouri Constitution gives the General Assembly the power to determine what governmental body shall try the different types of election contests.
- Provisions for election contests are established in RSMo 115.526-115.601.
- Pursuant to RSMo 115.563, all contested elections for the office of state representative shall be heard and determined by the House of Representatives.
- Pursuant to 115.573, the determination made by the House of Representatives on a contested election shall be final and not subject to court review.
- Pursuant to RSMo 115.583, if the court or legislative body hearing a contest finds that there is a *prima facie* showing of irregularities which place the result of any contested election in doubt, the court or legislative body shall order a recount of all votes brought in question by the petition or its answer.
- The process of conducting a recount, if ordered by the court or legislative body, is established in RSMo 115.585.
- “Recount,” for the purposes of RSMo 115.601, means “one additional counting of all votes counted for the office or on the question with respect to which the recount is requested”.

#### **Conclusions of the Special Committee on Election Contests**

- On March 22, 2023, the committee met and concluded that there was not a *prima facie* showing of irregularities which place the result of the contested election administered by the Saint Charles County Election Authority in doubt, and that no recount is warranted.
- Therefore, the Special Committee on Election Contests recommends that the House of Representatives does not order a recount of the 2022 Missouri House District 105 General Election.
