Associated Industries of Missouri fully supports the bill and proposed language that will lower the maximum Second Injury Fund Supplemental Surcharge to 1%, allow DOLIR to round to the nearest quarter percent, and extend the surcharge through 2026. The rate maximum changes are aligned with the actuarial report estimates of the amount needed to fully pay Second Injury Fund obligations. We thank the DOLIR staff for working with us on this language.
