As a licensed dental hygienist, I can attest to the benefits of water fluoridation through my 53 years in clinical practice in the fluoridated St. Louis area. According the CDC, "Drinking fluoridated water keeps teeth strong and reduces tooth decay by approximately 25 percent in children and adults." Promoting this practice of allowing health officials to educate the public will hopefully promote the cause for water fluoridation and demonstrate that it is a cost-effective strategy that supports good health, keeps citizens free from pain whether they are rich or poor, is a win -win for all residents of a community.
