My name is Ed Gargas, of Dexter, Missouri my phone number is 573-624-8566. I graduated from Southeast Missouri State University in 1990. I was active in a variety of activities as an undergraduate in Greek Life, a two-year term on the All-University Judicial Board, and President of the Student Government Association my senior year. Later, from 2015 to 2022 I served on the Board of Governors at the university, the final three years as President of the Board. As an alum, I have been an active donor as well as attendee to many university functions, athletic events, and performances at the River Campus. I know that there is a hearing on HB 1189 scheduled for Wednesday of this week, but my schedule will not allow me to testify in person. As an alumni and supporter of Southeast Missouri State University, and a businessperson in southeast Missouri, I wish to give this written statement in lieu of my personal appearance. I am well acquainted with the fact that students in Southeast Missouri are going to other states such as Illinois, Kentucky, Indiana, and Arkansas for programs the present law does not allow SEMO to offer. Unfortunately, traveling to the University of Missouri is not always a realistic choice for many students from southeast Missouri. For example, it takes about 3.5 hours of driving time, not counting stops, to go from Cape to Columbia. It is much more convenient for students to go across the river to Southern Illinois University-Carbondale, just 45 minutes away. Students can go there and come home on weekends or commute daily. Cost is also a factor as students can attend SIU, and other institutions, more cost efficiently than the University of Missouri. The biggest need that SEMO could fulfill if the law allowed it, is engineering; if the law allowed us to give an engineering degree and the Coordinating Board of Higher Education approved. SEMO could also help address a growing need in our region for healthcare professionals with advanced degrees. I am in favor of and fully support HB 1189. It does not prohibit MU from offering any programs it wants to offer and it supplies a convenient and economical way for Missouri students to stay in Missouri. Thank you very much for hearing my statement.
