If you are late to the Meeting and do not turn in a Speaker Card, you are disenfranchised with your basic Missouri Rights being Violated. The East-Central Missouri Water & Sewer Authority and Public Water Supply District #2 of Saint Charles County have removed Public Comments from ALL Meeting Agendas since I uncovered that they are Illegally and in Violation of State Law appointing themselves and friends to the Board getting a \$1,500 Monthly Base Salary, \$200 a Meeting for an Open Meeting, \$200 a Meeting for a Closed Meeting and \$200 for a Zoom Call all that last 10-minutes to one (1) hour, plus catered meals, security, office and Medical Benefits.
