ACEC Missouri opposes HB1366 due to the uncertainty of the fiscal note and the potential of individuals being able to claim more in refunds that they pay in fees. Under this legislation, a driver who drives 10,000 miles per year in a hybrid that gets 40 mpg would purchase 250 gallons of fuel and pay an additional \$31.25 in fuel tax when SB 262 is fully phased in. He would be able to claim a \$75 standard deduction under the language in House Bill 1366.
