On behalf of the members of the Freedom Principle MO, we offer our support for the following bills: HB 366, HB205, HB262, HB 445, and HB 700. During 2020 and 2021, there were fewer than a dozen counties in the United States where the county government fined businesses for violating COVID administrative rules. Jackson County, Missouri government stands as one of the few, if not the only one in the country, that actually closed businesses for breaking the COVID county rules. The Health Department was particularly aggressive to violate their own state and county health ordinances to make sure businesses were closed. I have met with and talked with several business owners when I ran for Jackson County Executive last year, and asked several of them to testify in person or submit testimony. But the response that I got was that they were often concerned about publicly opposing the county Health Department given how aggressively the fines were levied against them. Who is to say that County would not take some other type of retaliation against them again? Those of us who live in Jackson County experienced the same type of COVID rules that were in New York or California while nearly all of Missouri experienced freedom nearly throughout those two years. I witnessed first-hand the tyranny of county employees who threatened business owners with losing their livelihood if they didn't tow the line, even though there was absolutely no evidence whatsoever that the business resulted in any cases of COVID. When I filed Sunshine Act requests for much of this information, it was delayed by months or never fulfilled. Complaints about County employees to the County Ethics, Human Relations and Citizens Complaints board were never responded to or even acknowledged. One of the main reasons that I ran for County Executive, walking more than 700 miles and knocking on 7,000 doors personally, was that I wanted to change this mindset in Jackson County government that they have the heavy hand of government to do as they wish to its residents and its businesses. We do need this legislation because there are hundreds of businesses who were either fined outright and paid the fines, or they were forced to hire attorneys to fight these fines. For nearly two years, we lived in a type of aggressive police state of county government completely run of control. Please pass this legislation so that the businesses fined or who had to pay fees can see some measure of justice.
