Whatever the merits of the bill in other respects, it is poorly drafted. It should refer to the passenger compartment, not to "in the vehicle." As the bill now stands, you can carry marijuana on the roof, or in the back of a pickup, because that's not "in." But you can't carry it in the trunk, even though that's less accessible, because that's "in."
