Section 213.012 of the bill would unnecessarily modify the protected class of "race" in the Missouri Human Rights Act (MHRA) by including bairstyles and bair texture in the definition of "race." The							

definition would include braids, locks, twists, and afros. The expansion of this definition is unnecessary. Race discrimination is, and should be, illegal. We believe the current definition in the MHRA is sufficient and object to adding "hairstyles" to the definition in the MHRA. We have no position on the education-related provisions in the bill.
