Please pass HB367 to correct the civil statute of limitations for child sexual abuse to age 55. As a mental health provider for adults, I have seen how even a single incident in childhood can impact someone across their lifespan. Many times, I have been the first person a middle aged adult has told of their child sexual abuse. As a public school parent, I am aware that my district, since 2009, had 3 educators who sexually abused 4 child students. I am grateful for those child students who came forward because if they didn't, those educators would still be in the district my children are attending. We know that most children do not tell right away what happened to them, for many reasons. We need to have faith in our judicial process and allow adults to come forward with their childhood experiences, so that their abusers can be brought to justice and be removed from having access to more children. I support HB 367 which was co-written by childhood sexual assault survivors as myself. I am an incest survivor and lifelong Missourian. My father was my pastor. He started grooming me at age three while he was a student at Eden Seminary in Kansas City. At that age, I had no coherent thoughts or words to explain what was happening. Sexual abuse became such a norm that I didn't even really understand what I had gone through until I was in my late 20s. While living briefly in Iowa, he and other men, and women, abused me and my friends for sexual gratification, power, and VHS pornography. When I was old enough to start fighting back, in third grade, my father started drugging me. The assaults and psychological abuse continued until I left home for college. I had to do unimaginable things to keep my other siblings from being killed. My father spoke about his guns at home often and threatened to kill us. Because he was a Methodist minister, I would first test the waters with adults about his anger at home. When they wouldn't believe that small fraction of the abuse I'd go silent with shame. Understand, it takes childhood victims time to understand what is happening and what has happened. It takes time for them to find adults willing to help or years to grow up and find a lawyer and get the courage to speak to the police. I write to you in solidarity with my childhood church friends, the boys abused at Agape now rebranded as Stone of Hope, and the children abused at Camp Kanakuk. Childhood sexual abuse and trafficking in Missouri will not end until perpetrators are prosecuted and punished. SB367 protects children.
