mean that patients will not seek care until the cancer has spread making it much deadlier and much more costly to treat. Breast cancer can be up to five times more expensive to treat when it has spread beyond the breast to other parts of the body.Additionally, screening delays and cancellations during the COVID-19 pandemic have raised concerns about associated increases in "missed' and late-stage cancer diagnoses and mortality. Although we don't know the full impact of the pandemic, emerging data in the two years since the pandemic has reinforced these concerns. The potentially "missed" cancers could be larger and more advanced once ultimately detected, often requiring the use of diagnostic imaging.As committed partners in the fight against breast cancer, we know how deeply important it is for all cancer patients to have fair and equitable access to breast imaging that may save their lives. As such, we support HB 575 and urge you to pass this critical legislation. Thank you for your consideration
