When I was a kid. I went to a Catholic school where the unspoken policy was this level of "Don't Say Gay". If LGBT issues and people were mentioned at all, it was solely in condemnation. I barely knew anyone who identified as so much as bisexual until adulthood. I grew up depressed, near suicidal at times, and wondering what the hell was wrong with me. I had no words to express how I was feeling. *why* I hated the way "boyish" hairstyles looked on me, why every time I looked in the mirror everything looked wrong. I had always considered myself a cisgendered, straight person. And because I didn't have the language to question that effectively, I was miserable. Because I'm not a cisgendered, straight person. When I was twenty-eight, I came to understand that I was transgender. I started on hormones as soon as I was able to and, within a few months, the depression cleared. I was no longer suicidal. My quality of life improved dramatically, and I was able to focus, take interest in things I was previously numb to. As further evidence of that fact, the one time I went off them for a few weeks due to a scheduling mishap, I quickly dropped right back down to where I had been the year before. Starting on HRT saved my life. Like all other medicine, it fixed the problem that no amount of therapy or soul-searching could. To those of you considering the bill who are true believers, who earnestly believe the assertions of opinion columnists and church leaders preaching fire and brimstone, I beg you to understand that this bill protects nothing. It's demonizing innocent people for political gain and contributing to the depression and suicidality of minors who have to grow up not understanding why they're so depressed trying to live life as a cisgendered or heterosexual person, or worse, grow up fearing that the government of the state of Missouri is going to criminalize them as one last dying gasp of an ideology that refuses to change. Those of you who vote in support of it or any of the other dozens of anti-LGBT bills currently under consideration will not be remembered as the righteous victors, you'll be remembered the same way that we remember those who stood against civil rights whose work was ultimately undone in the name of a better, more equitable society. To those of you who know those facts, but will support this bill regardless for fear of political backlash from your peers or for easy "I'm the most conservative on this issue" fundraising, all I can say is don't act surprised when the devil welcomes you home. Claiming your faith demands you vote this way will not save you from the fire and brimstone you've earned for the pain you're going to cause without a second of remorse. Christ never said a single word about lesbian, gay, bisexual, trans or any other queer person, so don't pass the buck for your actions. This bill can fail now by taking a stand for people who do not have a voice in the Missouri legislature, or it can be undone by a later generation that remembers its supporters as monsters. But it *will* fail in the long run. The only question is how many people its passage will hurt in the long run.

I write in opposition to House Bill 634, I am the parent of two queer teenagers, one of whom is transgender. I am also an elected school board member in St. Louis County. As a school board member, I ask you to consider how this bill harms educators. Along with similar legislation that seeks to defund public schools, drive wedges between parents and teachers in the name of transparency, and ban teaching about race, this bill creates a hostile environment for teachers. It restricts their ability to help students see themselves in their learning. It disrespects their professional autonomy, and, in many cases, asks them to deny their own identities. It prevents them from affirming and valuing all students. I know this committee is aware of our critical teacher shortage in Missouri. An alarming number of educators are leaving the profession because of low pay and draining workplace conditions, not the least of which is the politicization of their work. With our state already ranking near the bottom nationally in school funding and teacher pay, HB 634 will contribute to Missouri's declining economic viability. Please, let's focus together on the real issues we're facing in K-12 education. This bill, which was not written by Missourians, does nothing to address those needs. As a parent, I ask you to consider how this bill harms my children. It will prohibit them from writing about themselves in class. It will deny them the opportunity to see themselves represented in literature, history, drama, even their foreign language studies. It will prevent them from receiving health education that is relevant to their bodies and their safety. It will discourage them from reporting harassment or bullying.Instead, HB 634 will create an unsafe school environment for my children. It will tell them that they should feel shame about who they are. That they are undeserving of support and affirmation from their school community. That in spite of my unconditional celebration of their identities, they will be erased in the very spaces where they should feel safest and most connected. Don't force that on my community. Please, protect my parental rights and stop looking for ways to harm my children. Vote no on HB 634.

My name is Arthur Smith, He himl live in Independence, Missouril serve on the worldwide leadership team for Community of Christ, an international religious denomination headquartered in Independence, Missouri. My daughter, who I am so proud of, is a 25 year old transgender woman. I am disheartened by the long list of bills targeting the LGBT community this session. I'm afraid that it's not a good look for Missouri and that our reputation nationally and internationally has already been damaged. I know that within the Trans community it feels like an all out attack. So much of this bill is vague, apparently trying to legislate someone's idea of general best practices, and elevating parent complaints to the state level. It seems to encourage overreaction and to create convoluted bureaucracy. The paragraph that stands out, of course, is the one that says:4. No classroom instruction by school personnel or third parties relating to sexual orientation or gender identity shall occur. For goodness sake! These are basic topics that are fundamental to a person being able to live in today's world. I wish that all of our Missouri legislators had received a little more basic instruction on sexual orientation and gender identity. Maybe we wouldn't be in this mess. My name is Becki Uccello, and I recently retired from teaching public school students. I spent my entire 25 years with junior high students. My college advisor had told me before I settled on a major: "Love your subject. Love your students. Everything else will fall into place." I learned quickly that establishing relationships with students was important. Most students want to connect positively with their educators. When teachers and students have a positive relationship, learning happens. Learning progresses. I have seen that with my daughter Izabella She will work for a teacher who has connected with her. If she feels disconnected with a teacher, she feels disconnected with her learning. As human beings, this is a normal phenomenon. A year ago, I had a student who was born female and identifies as male. I had long ago decided that as an educator, it is my job to educate, not judge. This student has always felt that he is male. He was a member of the speech and debate team and shared with me his speech about trans rights, for which he placed in competition. He received little support at home from his mom and stepdad. His biological dad supported this student, but distance had made it hard for them to connect at times. This student initially approached me early in the school year to thank me for making my classroom feel like a safe place to learn. I didn't feel like I had done anything special...I feel like all classrooms should feel safe. I tried to foster a sense of inclusion in my classroom because I know that's important to students, in addition to being part of Maslow's Hierarchy of Needs, which is something all pre-teachers learn about. To be clear, this student approached me. This student felt safe in my classroom. This student sought to feel like he belonged. This student's grades improved because his needs were being met. I was never out to convert nor to judge anyone. I just wanted my students to be successful. I oppose this bill because it will put teachers like me in a position to keep students at arms length when it comes to their lives. If students do not make a connection, if they don't feel safe, if they don't feel like they belong, they may not invest in their own learning. Besides, we as human beings live together in community. We interact with people from all walks and ways of life. Perhaps if we modeled this better in a school community, we would have less hostility in real life.

My name is Beth Newman and I live in St Louis. I work in the field of special education, I come to you in strong opposition to House bill 634.I'm a speech language therapist with over 20 years of experience working with children. For the past 6 years, I have had the privilege to work almost exclusively with high school students. My job is a bit different than classroom teachers. Unlike classroom teachers, a lot of my interaction with students occurs in small groups and even individual sessions. After you work with students one on one or in small groups year after year, a strong rapport and trust often develops. It's one of the things I love best about working with my teenage students. As you know, teenagers are incredibly complex, at the core of that complexity is a need to understand the world around them and communicate their knowledge. The teenagers I work with are the ones who sometimes have difficulty communicating. This can look like a lot of different things at the high school level. Sometimes it looks like not understanding vocabulary words used in a classroom text, sometimes it looks like having a hard time re-telling a story, and sometimes it looks like not understanding a peer or teachers' use of an idiom or metaphor. My time spent working with my students is often centered on helping my students understand a novel, re-tell a story, or understand figurative language. But sometimes. It's different. Sometimes they reveal more. They may want to tell me about who they are, who they like, who they identify as, what troubles them, or what brings them joy.HB 634 states on line 29: This subsection shall not be construed to prohibit voluntary counseling. But I'm not a counselor. I am, however, a trusted adult in my students' lives. An adult that they sometimes confide in, an adult that they sometimes-like many teenagers-just want to talk to. The way the current legislation is written, if one of my students brought up their sexual orientation or gender identity I would be required to tell them: Stop communicating with me. I can't speak with you about this. This is a violation of my professional code of ethics. American Speech Language Hearing Association Code of EthicsPrinciple of Ethics Part I, under part CWhen I tell my students "you can't talk to me about your sexual orientation or gender identity", it's akin to discrimination. Let's be honest, this legislation is not being written to target heteronormative discussions. I won't give pause when one of my heteronormative students wants to confide in me. This is about shutting down discussions of our students who identify as LGBTQIA+. Allow me to leave you with one final, very explicitly communicated message: House bill 634 prevents me from communicating with my LGBTQIA+ students in the same way I might communicate with my heterosexual, cisqender students. This is a direct violation of my professional code of ethics. My example is just one of the many problematic issues with this bill but perhaps one that you've never thought of previously. There will always be holes and problems with this type of legislation because you can't legislate these kids away. And you can't legislate this community away. Thank you for your

I graduated in a class of less than 100 people. Most of those I'd known a majority of my life. We experienced ups and downs, new adventures, and learned to navigate very important years of our lives together. We laughed, we cried, and sometimes we knew each other better than we knew ourselves. We grew up in a very small, majority Christian, conservative town. There wasn't room for outsiders or lifestyles we didn't understand. Not always intentionally, but as a byproduct of our upbringing and simply being sheltered from life's realities. There were a few people in our class that we sensed were holding things back, but they hid behind charades, knowing how our town would perceive them. You could tell in their mannerisms and personalities they were not being fully true to themselves, but how do you approach that topic when you're not sure they realize it? We graduated, and most of us left our small town. We gained experiences and insights that challenged our deeply held beliefs (which weren't even that deep, just what we knew). We questioned ourselves, each other, and how we were raised. Then, the most magical thing began happening little by little. People began accepting themselves for who they actually were, not who they were expected to be. Classmates changed career paths, political affiliations, some came out of the closet or embraced their real identity. We learned and continued to grow. Some of these classmates weren't who I hung out with in high school, but are now some of the people I respect the most because we've sat down and had hard conversations, challenged beliefs, and created a network of empathy and compassion. Those classmates from earlier I mentioned that were hiding who they were? When they came out, they began to FLOURISH. Entire demeanors changed. Standing taller, smiling larger, eyes twinkling, absolutely glowing. They began pursuing their dreams and passions. Pouring that into themselves, their friends, and their communities. They weren't able to do that before they moved away because many of them would not have been safe at home if their parents knew. Looking at our state history of child services, I can see why they would keep their mouths shut since chances are no one would be there to protect them. Looking back, I realize they had adults somewhere in our lives that subtly let them know they were safe. They were accepted as they were. I can probably pinpoint which teachers they were, because they made me feel the same as a straight white female. Unfortunately, there were not enough, and it was not soon enough. I cannot imagine the things that would have been accomplished if they had been shown that support earlier and more consistently in their lives. They say as you get older, you get more conservative, so I guess I'm going against the grain. The more I get out and experience the world, the more I believe we can do better, and we need to support everyone where they're at. Compassion and empathy go a long way, but it's lacking in huge chunks of the country because of beliefs we hold too tightly and refuse to challenge. Watching how the world was changing since I graduated used to give me a lot of hope for the future. Kids knew they were safe and accepted. They were able to come into themselves earlier and build that life they wanted without having to leave their town to do it. We were progressing and making huge changes. Then it all came crumbling down. These kids are being attacked and silenced for simply

being themselves. They're told they're not worthy, they're less than others, they don't deserve any rights or protections. Teachers soon won't be allowed to tell them they're safe and accepted. Things are going to get ugly and lives are going to be ruined. It breaks my heart knowing the potential they could have is being stamped out before they ever get a chance to see it. Simply because some people have so much hate in their hearts for what is different that they refuse to allow space for it. You say you're about the children. Forcing teachers to out them to their parents will put many kids in imminent danger. Is that okay because they're different than your kids? Why are they not worthy of being protected as well? If you're going to claim to be about the children, you need to be about ALL the children, not just the ones who appease your ideals.

Under the pretext of a concern for "parents' rights," these bills creates a host of new burdens on teachers, students, and parents. We strongly urge you to reject these harmful bills. American Atheists is a national civil rights organization that works to achieve religious equality for all Americans by protecting what Thomas Jefferson called the "wall of separation" between government and religion created by the First Amendment. We strive to create an environment where atheism and atheists are accepted as members of our nation's communities and where casual bigotry against our community is seen as abhorrent and unacceptable. We promote understanding of atheists through education, outreach, and community-building and work to end the stigma associated with being an atheist in America. Religious liberty is an individual right quaranteed by the First Amendment, and American Atheists opposes efforts to misuse these constitutional protections to undermine the civil rights or religious freedom of others.HB 627 is particularly harmful in that this bill allows parents to opt their children out of any classes or instruction based on the parents' "beliefs regarding morality, sex, and religion." For example, a parent might opt a student out of biology classes (if they have religious objections to evolution), history classes (if they disagree with the characterization of the US Civil War), geography (if they believe the Earth is flat), or even math (if they agree with the language in the Bible that implies p is 3). This is no way to run a school - and it would be a nightmare for teachers and administrators. Similarly, HB 634 is vague, overly broad, and eliminates student privacy. This bill would prevent school personnel from discouraging or prohibiting parental notification of and "involvement in critical decisions affecting a pupil's mental, emotional, or physical health or well-being". It is undoubtedly important for parents to be informed of their child's wellbeing, however this language can put a number of children at risk, Even with a provision that would allow for schools to adopt policies to withhold information if a disclosure would result in abuse or neglect, HB 634 still has the potential to endanger students. For example, if a school official disagrees with a student's religious views or lack thereof the official could inform the parent. Another example is LGBTQ students, by forcing teachers and counselors to disclose information that could potentially label students as LGBTQ could put them at harm. Growing up is challenging enough, and schools must be a space of safe expression for students. As drafted, HB 634 would effectively erase LGBTQ students, families, and history by banning classroom discussion about

sexual orientation and gender identity. The Legislature cannot force LGBTQ people back into the closet by policing identity or stopping kids from talking about their same-sex parents. This bill will also put school districts in an impossible bind. They are required to treat LGBTQ students equally and prevent harassment under Title IX, which prohibits discrimination on the basis of sex and gender, including sexual orientation and gender identity. At the same time, the strictures of this bill would prevent schools from offering supportive resources and mandate unequal treatment of LGBTQ youth. Missouri schools would be subject to liability whether they protect LGBTQ students and provide an inclusive learning environment or silence and stigmatize them as this bill requires. Missouri's scarce education resources should be used for the actual education of students, not wasted in political efforts to target vulnerable youth. Likewise, HB 482 purports to prevent racial stereotyping. However, as drafted, HB 482 limits diversity education, prevents discussion of structural racism, and ultimately results in a censored view of American history. Our nation's schools should promote critical thinking, limit censorship, and prevent the white washing of racial and religious history. The impact of bills like HB 482 filed around the country goes beyond just the text of each bill. These vague bills create fear among well-meaning educators and employees. For example, a Texas administrator, fearing being penalized under similar legislation recently passed in his state, instructed teachers that they must teach both sides of the Holocaust.1 At the same time, these bills empower those with extreme agendas to push to ban books,2 drive out veteran educators,3 and even oppose Black History Month.4 The environment created by these bills chill speech, impede education, and is harmful to students and schools, ultimately undermining the long term prosperity of Missouri.Recent survey research5 confirms that a broad bipartisan majority of Americans: Want students to learn a thorough, accurate, and fact-based account of American history; Trust teachers to thoughtfully teach the hard parts of history; Believe racism is widespread and harmful to society and that schools have a responsibility to teach students that racism is wrong; Want to reduce political division; and Want schools to ensure that all students feel they belong and see themselves reflected in the curriculum. Teaching about the issues of the day, including matters that actually affect the lives of students and their families, can be an important way to invest students in their education and to connect the subjects they are studying to issues of significance in our nation's public discourse. Teachers, especially in areas like civics, social studies, and history, have a responsibility to teach critical thinking and to prepare students for full participation in our society and democracy. Deep engagement with so-called controversial subjects, including legislation or policies that affect the education of students themselves, can be an important way to encourage democratic participation and to bring these sometimes-abstract subjects to life. This bill would incentivize a censored teaching of our nation's history, tie the hands of the educators we trust, and could virtually eliminate discussions of structural racism. The quality of instruction, critical thinking skills of students, and sense of belonging of all students will suffer, and it will worsen the already poor diversity education offered in many schools. This bill will harm Missouri students, and is being driven by political, rather than educational, interests. Rather than attempting to silence history, trust and equip your teachers and educational institutions to do the important work of digging into difficult discussions around race and a nuanced understanding of our nation's complex racial history. In conclusion, Missouri's public schools are meant to be safe and welcoming for all students. Lawmakers should not manufacture "parent's rights" that endanger students or strip away their civil rights. We strongly urge you to reject these unnecessary and harmful bills. My name is Cheryl Adelstein and I serve as the Deputy Director of the Jewish Community Relations Council of St. Louis. We are here today to express our opposition to both the Parents Bill or Rights and Curriculum ban bills being heard today. The Jewish Community Relations Council (JCRC), guided by Jewish values, advocates, educates, collaborates, and mobilizes action on issues important to the Jewish community, 60,000 strong in St. Louis. We are committed to pursuing religious tolerance, civic discourse and social justice in St. Louis and beyond. Jewish tradition teaches about the act of t'shuvah, or making amends. When we begin the process of repentance, there are five steps we are required to make in order to successfully achieve the process, including the act of "desisting from sin." But in order to desist from sin, we must be knowledgeable about the issue, how it began and why it was a problem. If we stop teaching our children the sins of our past, how will we prevent those sins from occurring in the future? There are some things about history on which we can all agree. Two examples: slavery was a horrific part of our nation's history and that no one could fathom it happening again; and the Holocaust was devastating and also difficult to comprehend how something like that could happen. How do we ensure that horrors like the Holocaust, are not repeated? By educating the next generation. We tell the stories of the efforts by a few in power to systemically dehumanize one group, the Jews of Germany. We describe how the government stripped this group of their rights, then removed them from their homes, inhumanly transported them to concentration camps and killed, starved or worked 6 million or more people to death. We repeat the rally cry, Never Again. And we ensure that the stories are never forgotten so that they are never repeated. And there are stories of our American history that we want never to be repeated. In the 1800's, as part of the U.S. belief in Manifest Destiny, our government removed native American peoples from their lands, marched them inhumanly to far away reservations - away from their own lands and traditions. During WWII, the U.S. gathered its own citizens of Japanese American origins, and placed them in internment camps for the duration of the war, ruining lives, reputations and never providing restitution. And then there were the race riots that occurred on either side of our state - in East St. Louis, IL and in Tulsa, OK, where entire black communities were burned to the ground. SB 89 says, and I quote, parents have "the right to object to the instructional materials and other materials used in their children's classroom based on the parent's belief that such materials are inappropriate for whatever reason and to be assured such objectionable materials are not taught to the parent's child. "How do we teach comprehensive history without talking about times when our country missed the mark? I love this country. The premise of religious freedom, enshrined in our founding document, has enabled the Jewish people to live and thrive in the United state for nearly 400 years. When I learned about the Trail of Tears, the intentional slaughter of the buffalo, the rise of Jim Crow laws, the intentional displacement of US Citizens into camps, race riots, lynching, and I could go on, I do feel discomfort. Not because of my race or sex or my religion, but

because I am a human being. It is only through a full accounting of our American History, and our faith in our children to be critical thinkers, that they can understand the past and stand up and say Never Again.

I appeared in person today, and thought I submitted my witness form. I don't know what random paper you got from me, but I found my form in my notebook. These are the remarks I spoke from: This bill is problematic on several levels. Section 2's language surrounding access of records could apply to counseling records. Right now, when a kid asks a counselor, "Will you tell anyone? Is this confidential?" A counselor usually says, "I only have to report if you're in danger or danger of hurting someone else." This bill changes that. Parents already have the right to educational records and they usually provide medical records, so what does that even mean? Before third party counseling is started, it is my experience that parents have to provide written permission (or not). Section 6 contradicts other legislation surrounding parental rights to determine care for their transgender youth.. Parents either have the right to medical decisions or they don't. Additionally, it could exacerbate neglect. Sometimes the only eye or dental visits students get are through the schools. Finally the punitive measures could create a cottage industry of frivolous suits. It's not clear who can bring litigation. While such suits might be found for the district, this will still siphon resources of time and money from the district. This bill looks similar to other parents' rights bill but has the added feature of attacking the LGBTQ+ community with it's Don't Say Gay and forced outing component. The opposition to parents rights bills is 90% and so was the opposition to the Senate Don't Say Gay bill. In fact it is at 70% in general for all bills harming the LGBTQ+ community. These bills would fail under the propose initiative petition changes proposed the majority party. Representative Kelley said something in answer to a question on this bill: Things can be addressed if students bring something to the discussion. Students do bring something to the discussion every single day: themselves. They bring their hearts, their hopes, their fears, their silliness. They should be allowed to bring their authentic, beautiful selves to school every single day without fear.

My name is Jamie Howard, I am a 29 years old resident of Jefferson City and I oppose HBs 634, 482 and 627. I was born and raised in Missouri and graduated from Moberly Senior High School. I'm a veteran of the Missouri Army National Guard, and a former deputy sheriff here in Cole County, I left law enforcement to pursue a medical education through the University of Cincinnati and had the opportunity to serve as Student Government Vice President as an adult nontraditional student, and I will be running for House of Representatives. I say this because I want to emphasize that my time in the educational sphere is recent. LGBTQ people exist. Queer people exist. They are real people, we are real people, human beings, attempting to live normal lives like everyone else. They love like humans do and in the way that only humans can do. They should be allowed to live their lives publicly and participate FREELY in our society with as much liberty you would afford a straight couple. They should be able to be proud of their spouses and their families and their lives. I know for a fact that there are LGBTQ Missourians employed right here in the capitol building that this bill will affect, or it will affect their spouses or their families. It is outrageous to me that you cannot see how these bills will affect the families and lives of people you work with every day, people you likely would call friends. Beyond that LGBTQ kids exist, and it is not a new phenomenon, and you all know this as well. I graduated high school in 2012 and there were kids I grew up with, that I was friends with, who were openly gay while they were in school. Going back to middle school at least, I remember queer kids being bullied relentlessly in a time in our society when we used "gay" as an insult in school, at work, on television and on the radio and after fighting relentlessly for representation in the media, people began to see the LGBTQ community as human beings, as neighbors and co-workers, friends even, and we saw progress. We saw our American society begin to stop using "gay" as an insult and the word "fag" became so awful to hear that most people become offended when they hear it. If these bills pass, we will see less supportive teachers and staff in schools due to fear of reprisals. We will see less effective intervention from school staff in handling bullying and harassment problems, just like when I was in school. We will see more homophobic remarks from students, parents and school staff just like when I was in school. Under this bill, teachers cannot discuss any book that involves LGBTQ people or has a romantic relationship within the book, they cannot mention LGBTQ history, and they cannot discuss anything to do with human relationships. And principals would be banned from discussing bullying/harassment that a student may endure. LGBTQ history is American history. Stonewall happened, Harvey Milk is an important part of American history, the AIDS epidemic happened, and yes the Nazis did raid the worlds first Research Institute of Sexology. Opened in 1919 dedicated to studying trans and queer healthcare, and providing gender affirming care until the 1930s when Nazis raided the hospital and burned 10s of thousands of books related to the study of transgender healthcare. This statement from PROMO perfectly frames my above points together, "This bill aims to erase LGBTQ students, families, and history by banning any mention about them in schools. The sad thing is

childhood psychologists have taught for decades that relationships or relational aspects within a classroom or school environment are and integral part of growth and development. We need to leave education to our educators. Teachers have a tough job of helping children think critically and prepare for their futures. Curriculum should be set by educators, not censored by politicians with partisan agendas." As for HB 627 lines 81 through 87 are deliberate. You want to attempt to get ahead of "CRT" but you're firing solutions in all the wrong directions. Begin: My personal lessons for my educational account regarding systemic racism in the United StatesWashington CNN — One of Richard Nixon's top advisers and a key figure in the Watergate scandal said the war on drugs was created as a political tool to fight blacks and hippies, according to a 22-year-old interview recently published in Harper's Magazine. "The Nixon campaign in 1968, and the Nixon White House after that, had two enemies: the antiwar left and black people," former Nixon domestic policy chief John Ehrlichman told Harper's writer Dan Baum for the April cover story published Tuesday. "You understand what I'm saying? We knew we couldn't make it illegal to be either against the war or black, but by getting the public to associate the hippies with marijuana and blacks with heroin. And then criminalizing both heavily, we could disrupt those communities," Ehrlichman said. "We could arrest their leaders, raid their homes, break up their meetings, and vilify them night after night on the evening news. Did we know we were lying about the drugs? Of course we did." Ehrlichman's comment is the first time the war on drugs has been plainly characterized as a political assault designed to help Nixon win, and keep, the White House. It's a stark departure from Nixon's public explanation for his first piece of legislation in the war on drugs, delivered in message to Congress in July 1969, which framed it as a response to an increase in heroin addiction and the rising use of marijuana and hallucinogens by students. However, Nixon's political focus on white voters, the "Silent Majority," is well-known. And Nixon's derision for minorities in private is well-known from his White House recordings. COINTELPRO - (syllabic abbreviation derived from Counterintelligence Program; 1956–1971) was a series of covert and illegal projects actively conducted by the United States Federal Bureau of Investigation (FBI) aimed at surveilling, infiltrating, discrediting, and disrupting domestic American political organizations. FBI records show COINTELPRO resources targeted groups and individuals the FBI deemed subversive, including feminist organizations, the Communist Party USA, anti-Vietnam War organizers, activists of the civil rights and Black power movements (e.g. Martin Luther King Jr., the Nation of Islam, and the Black Panther Party), environmentalist and animal rights organizations, the American Indian Movement (AIM), Chicano and Mexican-American groups like the Brown Berets and the United Farm Workers. In 1971 in San Diego, the FBI financed, armed, and controlled an extreme right-wing group of former members of the Minutemen anti-communist paramilitary organization, transforming it into a group called the Secret Army Organization that targeted groups, activists, and leaders involved in the Anti-War Movement, using both intimidation and violent acts. The FBI has used covert operations against domestic political groups since its inception; however, covert operations under the official COINTELPRO label took place between 1956 and 1971. Many of the tactics used in COINTELPRO are alleged to have seen continued use including; discrediting targets through psychological warfare; smearing individuals and groups using forged documents and by planting false reports in the media; harassment; wrongful imprisonment; illegal violence; and assassination. According to a Senate report, the FBI's motivation was "protecting national security, preventing violence, and maintaining the existing social and political order". Beginning in 1969, leaders of the Black Panther Party were targeted by the COINTELPRO and "neutralized" by being assassinated, imprisoned, publicly humiliated or falsely charged with crimes. The Black Codes were laws which governed the conduct of free and freed African Americans United states. Although black codes existed before the civil war and many northern states had them it was the southern U.S. states that codified them into everyday practice. The best known of them were passed in 1865 and 1866 by southern states after the American Civil War in order to restrict African Americans freedom and compel them to continue to work for low or no wages. Since the colonial period, colonies and states had passed laws that discriminated against free blacks and in the South these were generally included in slave codes. The goal was to suppress the influence of free African Americans particularly after slave rebellions because of their potential influence on slaves control their labor and preserve the free labor system. In the first two years after the civil war black codes were enacted by politicians to maintain white control over former slaves namely by restricting African Americans labor activity. Common codes included

vagrancy laws that criminalize African Americans lack of employment or permanent residents and law often also prevented them owning or renting property, and inability to pay these fees for vagrancy crimes resulted in imprisonment during which prisoners labored in the very same wage free positions held by slaves less than two years prior. Other crimes punishable by imprisonment and subsequent slave labor per black codes included unlawful assembly for worship learning to read and write and to racial relationships violation of slave like labor contracts possession of firearms making or selling liquor selling agricultural produce without a written permission from an employer whether or not they were self-employed and practicing any occupation other than servant or farmer without holding a judge ordered license. Additionally orphaned minors and minors removed from their homes by the state were apprenticed by the courts to employers until the age of 21. Minors apprenticed under black codes were authorized to be forced into labor against their will and apprentice relationships closely resembled those of master and slave in terms of discipline and involuntary labor. By 1866 nearly all southern states had enacted individual sets of black codes the widespread enforcement of black code laws effectively use the 13th amendments exception of penal labor to reinvent the chattel slavery economy and society to comply with federal law. On September 9, 1912, Sleety Mae Crow, an 18-year-old white girl, was attacked as was walking from home to her aunt's house nearby on Browns Bridge Road along the Forsyth-Hall County line, in Georgia. The next morning, searchers found Mae Crow. She was still alive and breathing shallowly although she had been severely beaten and sexually assaulted, she would eventually pass from her injuries. At the scene of the rape, searchers found a small pocket mirror that was said to belong to Ernest Knox, a 16-year-old black resident of Oscarville. Knox allegedly told three friends what he had done, they went to see for themselves. They were Oscar Daniel, 17; Oscar's sister Trussie Daniel, 22; and Robert Edwards, 24, a close neighbor. These allegations were never proven, and statements were made under the threat of drowning. Ernest Knox was arrested at his home and transported to Gainesville. On the way Knox, after being subjected to a form of torture known as mock lynching and threatened with drowning, confessed to having attacked Crow. Crow's murder has not been solved to this day. Oscar Daniel, Trussie Daniel, and Rob Edwards were all arrested the next day as suspects in Crow's attack, as was their neighbor Ed Collins who was held as a witness. They were taken to the county jail in Cumming, where a mob of an estimated 2,000 nearby white residents had formed by the time, they got them to the jail. As the day went on the mob grew by an estimated several hundred to 4,000 and had begun calling for the lynching of the arrestees. Eventually some men gained entry and shot and killed Edwards in his cell, then dragged his body through the streets, and hanged him from a telephone pole on the Cumming town square. His body was so mutilated that early accounts identified him as Ed Collins. Charges against Trussie Daniel and Ed Collins were dismissed; she agreed to a plea bargain and testifying as a state witness against her brother and Knox. Knox and Oscar Daniel stood trial. Each of the youths were quickly convicted of rape and murder by the all-white jury, black residents were excluded as jurors because they were largely prevented from voting. On the following day both teenagers were sentenced to death by hanging. State law prohibited public hangings, and the scheduled execution was to be viewed only by the victim's family and select others. However, Gallows were built off the square in Cumming and the fence erected around the gallows was burned down the night before the execution. A crowd estimated at between 5,000 and 8,000 gathered to watch what became a public hanging of the two youths. The total county population was around 12,000 at the time. In the following months, a small group of men called Night Riders terrorized black citizens, warning them to leave in 24 hours or be killed. Those who resisted were subjected to further harassment, including shots fired into their homes, or livestock killed. An estimated 98% of black residents of Forsyth County left. Some property owners were able to sell at a loss. Many black properties ended up in white hands without a sale and without a legal transfer of title. Eventually, the village of Oscarville was submerged under the waters of Lake Lanier. This campaign of terror was widespread across Appalachian Georgia, with Forsyth County being the third to expel its black population after Towns and Union. The Campaign would continue to the surrounding counties of Fannin, Gilmer and Dawson and beyond and would later be described by historians and anthropologists as a racial cleansing. Between May 31st and June 1st, 1921, in Tulsa Oklahoma, a violent racially motivated riots broke out and sparked by confrontation of white residents and resulted in the deaths of hundreds of people mostly African Americans and the destruction of the Greenwood district. The Greenwood district was a prosperous African American community, business, and financial services district known as Black Wall Street. The conflict began when 19-year-old Dick Rowland, a black man, was accused of assaulting 17-year-old Sarah Paige, a white woman, in an elevator. Soon after Roland was arrested a white mob formed to attack the jail where he was being held and remove him with the plan to lynch Rowland in the same manner, they had lynch Roy Belton the year prior. African American residents who were armed for self-defense confronted the white mob and the situation escalated into a full-blown riot. Over the next two days the white mob burned and looted homes businesses and churches in the Greenwood district leaving nearly 10,000 African Americans homeless and erasing a modern estimate of \$200 million in generational wealth built despite decades

of setbacks from slave and black codes and Jim Crow laws, forever. A 2001 Commission report found between 75 and 300 people had been killed, mostly African American. The National Guard would eventually be called in to restore order, but the damage had already been done. The Tulsa race riot was one of the worst incidences of racial violence in American history. A violent and tragic event that reflected the deep-seated racial tensions and inequalities in the American Society in the early 20th century. It had and continues to have a profound impact on the African American community in Tulsa and beyond. The events of the riot were largely suppressed by local state and federal officials for decades it serves today as a reminder of the ongoing struggle for racial justice and equality here in the United States. Bleeding Kansas, Bloody Kansas, or the Border War was a series of violent civil confrontations in Kansas Territory, and to a lesser extent in western Missouri, between 1854 and 1859. It emerged from a political and ideological debate over the legality of slavery in the proposed state of Kansas. The conflict was characterized by years of electoral fraud, raids, assaults, and murders carried out in the Kansas Territory and neighboring Missouri by proslavery "border ruffians" and antislavery "free-staters". According to Kansapedia of the Kansas Historical Society, 56 political killings were documented during the period, and the total may be as high as 200. It has been called a Tragic Prelude, or an overture, to the American Civil War, which immediately followed it. The conflict centered on the question of whether Kansas, upon gaining statehood, would join the Union as a slave state or a free state. The question was of national importance because Kansas's two new senators would affect the balance of power in the U.S. Senate, which was bitterly divided over the issue of slavery. The Kansas-Nebraska Act of 1854 called for popular sovereignty: the decision about slavery would be made by popular vote of the territory's settlers rather than by legislators in Washington. Existing sectional tensions surrounding slavery quickly found focus in Kansas. Missouri, a slave state since 1821, was populated by many settlers with Southern sympathies and proslavery views, some of whom tried to influence the Kansas decision by entering Kansas and claiming to be residents. The conflict was fought politically, as well as between civilians, where it eventually degenerated into brutal gang violence and paramilitary guerrilla warfare. The term "Bleeding Kansas" was popularized by Horace Greeley's New-York Tribune. Kansas had a state-level civil war that would soon be replicated on a national basis. It had two different capitals (proslavery Lecompton and antislavery Lawrence and Topeka), two different constitutions (the proslavery Lecompton Constitution and the antislavery Topeka Constitution), and two different legislatures (the so-called "bogus legislature" in Lecompton and the antislavery body in Lawrence). Both sides sought and received help from outside, the proslavery side from the federal government; Presidents Franklin Pierce and James Buchanan openly helped the proslavery partisans. Both claimed to reflect the will of the people of Kansas. The proslavers used violence and threats of violence, and the free-soilers responded in kind. After much commotion, including a congressional investigation, it became clear that a majority of Kansans wanted Kansas to be a free state, but this required congressional approval, which Southerners in Congress blocked. On May 21, 1856, proslavery Missourians invaded Lawrence, Kansas, and burned the Free State Hotel, destroyed two antislavery newspaper offices, and ransacked homes and stores in what became known as the Sack of Lawrence.

Neosho, Fort Zumwalt, Lamar, and others already have Board policies, administrative guidelines, and procedures in place or in process on what you are proposing including curriculum and book access to parents, complaint procedures are in handbooks, parents visit schools and more. School districts track complaints and acknowledge trends of concerns in public forums and strategic plan. What you are proposing does not come up because parents already have access. Erasing children is immoral and hurtful. When a school ignores or cannot validate some children's families, friends, even legislators - and themselves in schools, it is hurtful, models discrimination, and teaches hate. No child should be told not to explain his "draw your family" picture or "you can't read that book because some of the characters are different."And, your bill contradicts two of the six standards in your MSIP School Accreditation process. There are no data and no evidence to support the redundant school communication for adults and redacting targeted individuals and families from children. Instead - I implore you to model trust and honor professionalism in schools, to acknowledge existing law and policy, acknowledge every child's worthiness, and to respect parenting. Trust Teachers. Teachers in Missouri are professionals. They are educated, certified, participate in continuing education, and supervised. Students and parents observe directly and indirectly 180 days a year. They care and have children's best interests at heart. Trust them. They are good people with knowledge, instructional skills, mission, and heart. They are good teachers, your children like them, and we can't afford to lose any more. Trust Missouri Professional District Leadership and Content Area AssociationsMissouri School Boards and Missouri School Administrator associations analyze policies and interpret your laws for school district; they train board members and superintendents; and they have provided model policies and best practices to serve parents and children in over 500 school districts for decades. Missouri Associations of mathematic, English, science, social studies, music, guidance counseling and others know research and community expectations for colleges, careers, and trades; set high standards and expectations for students, teachers, and supervisors; and recommend juried resources for schools. Trust Parents. Stop disrespecting parents and scripting how they should be parents. They know what to do and have advocates and allies to help them navigate schools if they don't. Parents ALREADY receive routine notes and activities from teachers. They attend school events and parentteacher conferences. They visit schools and classrooms. Are teachers doing that which you are accusing them of, unfairly. Why? Trust Government. The Missouri Department of Elementary and Secondary Education, the Federal Office of Civil Rights, and other agencies who protect rights of children and parents and already follow laws which obligates them to accept and investigate complaints. Trust parents, the faith community, community agencies, community groups, recreational associations, and all those in the proverbial village who raise a child. Collectively, they've done a pretty good job – and legislating their actions and silencing their care is wrong. Teacher, counselors, cafeteria workers, security guards, administrators - only "agenda" is to 1) keep children safe - physically and YES, emotionally; 2) teach children approved lessons and YES to use the teachable moment to support children; and 3) be responsible and professional. They do not discriminate – nor do they judge, cite preference, label or pontificate when sensitive topics arise. They use age-appropriate communication. They listen. They protect children who might be teased or bullied (per federal and state Safety Act laws). They diffuse situations. They do not preach; they teach and let kids figure things out. Why would our schools not want to teach history? Why would our schools not want our students to know about the history of the United States? When students are learning about history, they are going to come across LGBTQIA+ topics and how they became history. Taking away a student's right to learn about Stonewall, the AIDS pandemic in the 80s and 90s, the fight for equality and freedom for the LGBTQ community is something that should not be decided by our state legislature. According to a 2022 National Survey on LGBTQ Youth conducted by The Trevor Project, 45% of LGBTQ youth seriously considered attempting suicide in the past year. 60% of LGBTQ youth who wanted mental health care in the past year were not able to get it and LGBTQ youth who live in a community that is accepting of LGBTQ people reported significantly lower rates of attempting suicide than those who do not. The only thing I really knew in my youth was that homosexuals were bad people who hated Jesus. I liked Jesus-I liked Jesus a lot-so clearly I couldn't be one of them. And yet I walked into my ballet class at age thirteen, saw my new teacher, and felt my innocent little heart flipflop when she smiled at me.At age sixteen I looked forward all week to seeing one girl at church and felt a pit in my stomach if she wasn't there. At age twenty-one I talked about my aesthetic appreciation for feminine beauty and a gay friend looked at me sideways. Something about me always felt different, but I couldn't put it into words. I did, eventually, put it into words. Today I will tell you I am a bisexual woman. Having no information about who I was did not prevent me from having a non-heterosexual orientation. Having no mature adult of whom I could ask such questions or in whom I could confide did not protect me-it left me very alone. I did not turn gay when I met LGBT people. I just found people who for the first time in my life accepted the real me. Today I am asking you not to use government mandates in school classrooms to isolate and ostracize children who, like teenage me, do not have the words for who they already are, and whose only agenda is, in the words of famous painter Vincent Van Gogh, "I wish they would only take me as I am."

Through books, examples, and history, I got to have a small snapshot of how people lived. But even with that, I never really learned about people much different than me. I grew up in a very heteronormative world. I so badly wanted to just be like my parents and the rest of my family, married to a man, have a good job. and eventually have kids. I did not grow up in a home that celebrated different sexual orientations or gender identities. It's honestly not something we talked about, and when we did, it was negative. Throughout high school, my depression got worse, I struggled with suicidal thoughts, and I couldn't feel better. Much, much later in life, I learned to accept myself. I had known all along, but wanted to change to preserve my relationships and my safety. I am so fortunate that my family was willing to do the work to question those biases they had and for loving me and my fiancé. I can tell you honestly, I did not learn about LGBTQ people in my household, and today 3 of the four kids in my family have come out to the family as a part of the LBGTQ+ community. As a current therapist and school based counselor, I regularly see the impacts of erasing an entire part of identity and don't discuss it. We don't prevent kids from knowing who they are or loving who they love, instead we add shame and judgement to the topic. I'm sure everyone in here has felt shame and knows first hand how damaging it can be, especially when that shame is perpetuated by adults they trust. In front of me, I see people who honestly look familiar. You look like and represent folks like my parents, aunts, uncles, friends, and neighbors. I have these conversations what feels like daily, and what I ask of them is to question their own defensiveness and trust the experts in the room. I am asking the same of you today. Please, for myself and all the clients and families I serve, vote no on HB 634.

My name is Michael Walk, from St. Louis County to oppose HB 634, My daughter held a secret in her heart for a long time. We had loved her believing she was a boy for fourteen years before she finally told us she was a girl. She had known since she was in kindergarten, but she didn't feel like it was okay to tell anyone. The pain and loneliness were tearing her apart. A kid has to feel safe to confide in someone, to share who they really are. Our daughter didn't feel safe telling anyone until she was already severely depressed. She tried to put up a good show, but puberty is not a happy time for kids whose bodies don't match their brains. In our case, our daughter finally told us, her parents, who she was. For some other kids, that may not be a safe option, and that is terrifying. If our daughter had not had anyone she could trust to talk to, she would no longer be with us. Some kids are transgender or queer, but don't think their parents will understand or accept them. They need to be able to confide in someone. School counselors and teachers can be such trusted individuals, who a kid can talk to before making themselves known to the rest of the world. Criminalizing talking with a student about these topics will put students in jeopardy. It's an ethical dilemma: Talk to the student and risk being tried as a criminal? Or refuse to talk, knowing that the kid may end up engaged in self-harm, even suicide?There are several bills proposed this session which target the ability of educators to provide any but the narrowest educational experience. These bills, including the one under discussion, seek to hide proven facts because they make some people uncomfortable. In this case, it is the fact that gay people and trans people exist, that they are human. As human beings, they need to be valued and acknowledged, not made to feel that their very identity is unspeakably shameful. One more thing I want to note about this bill is the harm it would do to teachers and other school staff. As they deal with the important job of educating our youth, they seem increasingly to be vilified, even criminalized, by some people in our state. There are people who want to control every bit of information their children learn, even if what is being taught is completely accurate. Teachers are doing all of this important work while being paid the lowest starting wage in the United States. Teachers and counselors got into this work because they care about kids, and want to help them. This bill would make it impossible for them to help a group of kids who sorely need it. This bill would take this important resource away and harm many students.2) Besides directly harming mental health, this bill would also undermine anti-bullying efforts. LGBT+ students face an increased risk of bullying, and this bill would make it much harder for teachers to address that issue. 3) This bill ignores that LGBT+ topics aren't inherently sexual. It is possible to mention that gay people or trans people exist without mentioning sex. Also, if the goal of section 4 of this bill was the stop the sexualization of kids, shouldn't it have directly targeted sexualization instead of LGBT+ people?4) This bill censors useful information. Students should be able to receive accurate information about the world, and LGBT+ people exist in this world. So LGBT+ topics should not be censored from students. Another thing this bill might censor is access to accurate sex education.5) This bill is also vague and would have a chilling effect on free speech. It is unclear what "sexual orientation or gender identity" means and how far it goes. This would force teachers to limit their speech under the threat of litigation or punishment.6) Proponents of this bill might say that it stops the indoctrination of kids regarding LGBT+ topics. However, this is misleading, most LGBT+ education simply tells students that LGBT+ people exist and that it is ok to be LGBT+. These 2 things are not wrong. If schools are allowed to stop bullying over a student's race or support gender equality, then supporting LGBT+ acceptance is fine. Virtually all major medical organizations in the United States agree that being LGBT+ is fine, not a mental illness and that LGBT+ people should be accepted in society.7) Finally, section 4 of this bill does not even try to protect parental rights. It does not give an opt-out option for parents regarding LGBT+ issues, it flat-out bans them. If a parent is ok with their kid learning about LGBT+ topics in school, this bill harms their parental rights. For all of these reasons, I urge you to vote NO on HB 634.

I'm the CEO of Youth In Need, a nonprofit organization that serves over 8,000 children, youth and young adults each year in eastern Missouri. Youth In Need was founded and is headquartered in St. Charles, where I am a lifelong resident. Youth In Need has an annual operating budget of almost \$30 million, and we employ 400 staff. Our programs include crisis outreach and shelter for youth who are homeless, mental health counseling for kids of all ages, foster care, and early learning for young children. What I know from our 50+ mental health counselors who are based in elementary, middle and high schools in 17 school districts throughout St. Charles County, Lincoln County, and St. Louis County is that kids' mental health is in crisis. The rates of depression and suicide are alarming and rising. LGBTQ youth are particularly vulnerable to suicide risk, not because of their sexual orientation or gender identity, but because of how they are bullied and mistreat. Having a trusted adult to talk to can help all children and youth learn healthy coping skills and social skills so they can have a positive sense of well being and function well at home, in school, and in the community. House Bill 634 would ban those trusted adults from responding when kids want to talk about someone they have a crush on or how they feel, or put those trusted adults in the position of having to immediately inform parents. In Youth In Need's work with minors and in schools, our goal is always to facilitate communication between youth and their parents. However, we see all too many times when youth are kicked out of their homes or physically abused by their parents if they are questioning or exploring their sexual orientation or gender identity. Having time to thoughtfully and therapeutically broach these conversations can lead to the best outcome for the young person and the family. I also want to address the fallacy that youth are being encouraged to become gay or transgender. In my 33 years at Youth In Need, I have seen that LGBTQ youth are widely over-represented in the homeless youth population. These youth come from a variety of backgrounds and situations, but what they have in common is that they are homeless because they have been rejected by their families. Most have tried desperately to change or hide their sexual orientation or gender identity, because they loved their families and were terrified at the prospect of having no safe place to live. I can tell you with certainty that not accepting LGBTQ kids does not make them straight, it just makes them miserable, and at high risk to be victims of sex trafficking and violence. Like all youth, LGBTQ young deserve to be in positive school environments where they feel valued and visible, not silenced and shunned. As a licensed professional who has devoted over 30 years to alleviating suffering and distress for children and youth in Missouri, I truly believe this would cause needless harm by sending the message that being gay or transgender is so shameful that it cannot be discussed. Please respect the humanity of our LGBTQ children and youth.

As a minister and a pastor, I value the worth of all people. While my values as a Christian prompt me to defend the LGBTQIA+ community. I know many who support HB 634 do so because of their Christian values. I would remind those people that our democracy is not a theocracy, and that their personal religious beliefs should not be used to infringe on the ability of any group of people to be treated with dignity and respect. This bill seeks to force teachers and school staff to pretend LGBTQIA+ people do not exist, even though they are already a part of our school communities. Worse, it could put LGBTQIA+ youth in danger. It will cause alienation and division rather than understanding and unity. As a teacher, I am horrified that my fellow Missourians would even consider HB 634. Our teachers are under enough pressure already, without worrying that they will lose their jobs for simply acknowledging the existence of gay people. Am I not allowed to acknowledge the family of the boy in my class who has two moms? What about the teacher at my school, a woman who is married to a woman? Can she not mention her wife at school? Am I not allowed to mention my non-binary child? Such a bill is hurtful and an undue burden on teachers. I can think of about a thousand ways you could help teachers right now, but this bill does nothing but harm teachers and students. I beg you to vote no on HB 634.

My name is Thomas Sebacher, and I am a graduate student in the Master of Arts in Public History program at Southeast Missouri State University. I graduated with bachelor's in philosophy & religion and history from Truman State University. My current research regards the history of mental health treatment and sexuality in the state of Missouri, and I have written a book for the Missouri Hospital Association regarding its 100 years of history. I testify in opposition to this bill from a logical perspective as well as a historical perspective. With all due respect, the bill has two major flaws; it amounts to a poor attempt to "out" queer children to their parents and a denial of the existence of sexual orientation and gender identity in the public education system. Here, we'll begin by focusing on the first problem: although the bill's opponents may claim that it does not require the disclosure of sexual orientation or transgender status to parents, the wording of the bill in subsections 1 and 2 requires disclosure of "mental, emotional, or physical health or well-being, a change in related services or monitoring."This is based on an outdated and misguided assumption that sexuality or gender represent "mental, emotional, or physical health or well-being," which, according to the professional guidelines set by the Diagnostic Statistical Manual (DSM) is not the case. This would also violate the ethics of the field of psychology if a school psychologist or counselor believed that this disclosure would lead to emotional or physical harm of their patient. This bill would therefore encourage the psychological community to either violate or trivialize their professional obligations to their patients. Alternatively, the requirement would propose a breach of confidential mental health information. According to Missouri regulations, the disclosure of an "individual's" confidential information, not the client's confidential information (20 CSR 2235-5.030, subsection 2A). The parent may be the client in this case, but confidential information including "issues directly affecting the physical or emotional safety of the individual" do not relate to the client. As sexual orientation and gender identity directly affect this physical and emotional safety (see American Psychological Association's "APA Resolution on Supporting Sexual/Gender Diverse Children and Adolescents in Schools," Feb. 2020), the bill as proposed would argue that the state should violate its own established code of ethics for the sake of parents' rights. My second objection is that the bill violates not only previous Missouri laws regarding sexual education, but also internationally established best practices for comprehensive sexual education. Regarding the first point, the state of Missouri has very clear quidelines for the discussion of sexuality in schools in Title XI 170.015. Since this bill bans discussion or instruction regarding sexual orientation in school, which includes implicitly both heterosexual and homosexual orientations, this would make the fulfillment of Title XI impossible (see Jonathan Ned Katz's "The Invention of Heterosexuality" and John D'Emilio and Estelle B. Freedman's "Intimate Matters: A History of Sexuality in America). It also makes any discussion of men or women impossible, as both of these are gender identities, according to established historical and sociological interpretation (see Joan Wallach Scott's "Gender: A Useful Category of Historical Analysis" and similar

works). Meanwhile, the United Nations Educational, Scientific, and Cultural Organization (UNESCO) "International Technical Guidance on Sexuality Education" argues that sexual orientation is an integral part of sexual education. Banning this educated discussion on gender identity and sexual orientation would not effectively protect students and would strain the state's mental and physical health resources. It could also contribute to increased transmission of HIV/AIDS among the general population; men who have sex with men (MSM) are a group with acknowledged higher risk, and thus constitute a vulnerable population. HIV has and will continue to spread extensively outside of this group, and this could strain already scarce resources in the state for the disease's surveillance and treatment. As sexually transmitted disease education is mandated (as previously noted, in Title XI) by state law, this would be contrary established state regulation and spark significant confusion. Aside from the general absurdity of banning teaching regarding gender identity and sexual orientation in Missouri public schools, it is highly unethical educationally. Educational institutions, especially primary and secondary public schools, have a duty to prepare their students for the world that surrounds them. Ignoring these two categories will leave our students unprepared for their inevitable contacts with transgender individuals and those with alternative sexualities. Any parents that propose to challenge this should realize the consequences of their actions may very well harm their own children. I remember the issues I confronted when I witnessed the protests in Ferguson during my junior year of high school. I was completely bewildered. I had been repeatedly informed that racial strife was a thing of the past. I was under the impression that the Civil Rights Movement had successfully remedied all the problems of racial inequality. I was not prepared to discuss the topic, nor did I understand how race and racial issues permeate society still to this day. I only became equipped to understand the events in Ferguson years after the protests and violence had ended.I urge that the committee reconsider this proposal. It violates ethical standards for a variety of professions, educational standards the state previously established, and it will lead to the coddling of children to the point that they will be unequipped to understand the society in which they live. It will lead to unnecessary emotional and physical distress. It will strain already scarce state resources in critical areas. Altogether, parental rights to know about their children should not extend to knowledge that could negatively predispose them to their own child, especially that will cause undue emotional or physical harm to the child.

PPSLRSWMO proudly provides respectful, equitable, and evidence-based health services, sexuality education, and counseling, including services and education that affirms and centers LGBTQ+ communities. The experts providing these educational services and trainings center social justice and freedom from all forms of oppression, seek to reduce health inequities for those most marginalized, and see firsthand the positive impact of empowering people of all ages with knowledge, skills, and affirmation to advocate for their own sexual health. We are alarmed at the attempts of HB 634 to silence students and the educators they trust for support and accurate information. LGBTQ+ youth already experience marginalization, bullying, and discrimination, which imposes dangerous psychological stress. Trans youth report staggering rates of suicide attempts. What we know to be true, what the data confirms, is that we can optimize the health of LGBTQ+ young people — including transgender young people — by affirming their identities, supporting them, and securing their safety and ability to speak freely without fear of retribution. This legislation does the opposite.HB 634 is an affront to our state's educators who have dedicated their careers to creating an inclusive, welcoming, and safe environment for all young people.
