As Chief of a rural fire association our ability to provide assistance to our 96 square mile district is impaired by two primary things, personnel and funding. We have 638 parcels of land in our district and annually average 215 parcels as members meaning 1/3 of the parcels are supporting the other 2/3s and our annual revenue is \$12,000. From that we spend \$7000 for insurance \$3000 for utilities and fuel leaving only \$2000 for repairs and equipment. All of our personal protective gear (bunker gear) is over 10 years old, our only mainline pumper is a 1981 model that needs \$25,000 to \$30,000 of work on it, our brush trucks are 1985 military surplus units that need replacing. Neither of our stations have water in them so we must take our gear to a neighboring department to clean them and that leaves personnel without a set of gear if we have a call. One station is a 1960's built block garage that can only hold our two brush trucks due to it's size and it needs to be completely demolished and a new station built. Our other station holds the engine and tanker but it is only 2 bays with no room for training or storage of necessary supplies, a great amount of the supplies I keep at my house which is inconvenient for members. We have attempted twice to become tax based but the voters passed the district boundary issue but did not pass a levy for the support of the district. Without adequate funding we are unable to provide a high level of service to our resident community, critical infrastructure, automatic/mutual aid departments and citizens traveling through our district...this legislation is a step in the right direction in shoring up the funding issue for rural fire departments in our great state. Keep in mind these Volunteer Fire Personnel are required to respond to ALL EMERGENCIES AND HAZARDS risking their lives, and in many cases, are not compensated for responding and using their own resources in many ways. Many times volunteers have purchased their own protective gear which will today cost in excess of \$2,000 from head to foot. If this bill passes and the local issue passes our annual revenue will increase to approximately \$35,000 that will allow my department to plan for gear, apparatus and building projects. This is dealing with lives of citizens and the ability to get appropriate aid to them as quickly as possible by other citizens who want to take care of their community. The final questions are, how much is a life worth? How much are rural Volunteer Fire Personnel worth? They are all worth your vote in favor of this legislation. And by the way I am also an elected county official.

My name is Greg Greenwood I am the Fire Chief of the Highway K Volunteer Fire Department in Ripley Co. Mo. The Highway K VFD is funded through voluntary dues paid by residents in our district, fundraisers and donations. The average operating budget is around \$13000. The fire department district is roughly 250 square miles of rural Ripley Co. There is approximately 1200 residents/property owners in the district. Of those about 30% pay the \$40 yearly dues. The department advertises through the local newspaper, social medial, road signs and direct mailings to encourage residents to pay the dues to help support the fire departments operations. A lot of man hours is dedicated every year in fundraising efforts so that the department can meet operation expenses. The small budget and ever increasing cost of staying in operation leaves very little for the purchase of new/upgraded equipment. The department currently operates a 2000 (model year) engine, a 1998 (model year) military surplus tanker and a 1986 (model year) military surplus brush truck. The military surplus tanker and brush truck was acquired through the MDC surplus property program. The SCBA's used by the fire fighters are hand me downs from a department in North Carolina that had gotten new SCBA's. Half of the turn out gear that issued to firefighters is older and donated by other better funded departments. Many department in the state are in the same state as Highway K VFD. Small nontax supported (dues supported) department have a hard time raising funds necessary to keep operating and are in danger of shutting down due to lack of funding. Having the option available to have dues collected by the county collector would be a great benefit to local departments. It would increase the funds available for the departments, and decrease the amount of time and energy the volunteers put in to fundraising. It would ensure that every resident/property owner in the district would be helping keep the department in operation not just a small percentage.

I am writing this statement in support of HB 665. I have been with the Mountain Grove Rural Volunteer Fire Department since 1985. It was formed in 1980 and started with 250 members. Since it's beginning it has grown to cover 248 sq. miles and has 1100 members. Although our membership has grown we still only have 1/3 of the rural population as members. I feel this is due to people from out of area that are used the tax districts and are unaware of the fact the fire departments in our area are membership based. We advertise the need to become a member with little success due to the rise of social media and decline of newspaper sales. We attempt to reach the public with social media also with some success. State law allows for fire departments to charge for services to a non member but collecting is an expensive process if the land owner is unwilling to pay for the service. Some insurance companies will pay for the service if the property is covered by insurance, but the amount generally allowed by insurance is not enough to cover the cost of the service. Most of our calls are grass and brush fires that can last several hours. Most people do not have this covered by insurance. People expect the fire departments to respond in an emergency but do not realize that there is a cost associated with the response. The membership of the Mountain Grove Rural Fire Department has remained constant in the last 20 years of around 1000 to 1100 members. The cost of equipment to respond and effectively suppress fires has risen to the point that the financial stress to rural department has become a serious problem. Fire departments have attempted to offset costs of equipment by raising membership dues to compensate making it affordable for some persons to pay. It is also unfair to the members to provide service to non members. Then if the fire department does not respond, they are the "bad quy". This bill would solve the problems of having to worry about responding to non members, how to get paid for the service, the need to constantly advertise for membership and for persons moving into the area to be covered without finding when the incident occurs. You have some people that argue "we don't want to join and don't need the fire department to respond" and yet when an incident occurs that needs the fire department, 911 is their first call for help from the fire department that they did not want to purchase a membership from. The Mountain Grove Rural Volunteer Fire Department charges \$60.00 a year, \$5.00 month for coverage. This is up from \$35.00 a year just 2 years ago. This increase is still not enough to cover the expense of equipment for firefighting. I believe this bill will solve the problems plaguing rural memberships problems today. As time goes by and there is no assistance to rural departments in some way to keep them operating, persons in the rural area with not have fire protection and will be looking to counties and states for a solution. This bill will make it cheaper than a property tax fire district and yet will allow property owners to have the coverage they need. Thank you for the opportunity to submit my concerns for the rural fire service and the support for HB 665.

My name is Michael Schiff and I have been with the Squires Fire Department (in Douglas county) for 7 years. When I started, I was the treasurer and at the time we had very little money in our account, barely enough to meet the basic needs of utilities and insurance. Our pumper trucks were from the 1970s and required constant maintenance. Our fire gear was decades old, with holes in the knees and elbows. If it wasn't for a few one time donations, we would not have a fire department today. Today we continue to struggle with funding. Funding for updating our apparatus, our fire gear and for training. Without some intervention, many fire departments like ours will cease to function and the community will be put at risk. The collection rate for our fire protection rate is somewhere between 50-60%. The remaining amount, which would be collected as part of this bill, would enable us to not only survive but to start building a future for our department.

We have utilized a website, started collecting payments online, have advertised everything we do through Facebook and have tried to be as open to the public as possible to help get this information out to everyone. Caulfield is very humble and proud that we have received a grant for a new Fire Department that is currently being built, we are very fortunate and excited. If this trend continues, it will have a critical impact on our ability to respond to emergencies and assist our Missouri citizens. In speaking to other fire chiefs in our county and bordering counties, all are stating the same. "If something isn't done, more rural departments and associations will be forced to close their doors." This has already occurred here in our county, Huggins Fire Department, permanently closed, and now our association along with Roby are struggling to provide protection and safety for these citizens.

Hello, I am the fire chief of a small membership fire department and have been for just over 5 years now. We have struggled for way too long with no support and barely enough money to last one quarter of the year much less the whole year. I am in support of HB665. The purpose of this bill would be for all property owners to pay for fire protection on all owned property within each fire district. This bill would allow not only a few people to pay their part but instead all people inside of our district to pay their share. This would allow the fire department to do vital upgrades of apparatus as well as much needed maintenance to this equipment. This would also allow for departments to get lifesaving equipment for both the fire departments as well as for the patrons within their boundaries. Also assisting in funding much needed lifesaving and needed training. Volunteer firefighters are dwindling at an alarming rate in the great state of Missouri and across the U.S. for the most part due to lack of funding for vital equipment upgrades. Would you want to go into a house that is burning in bunker gear that expired 15 years ago? Well as you just answered no, the men and women that are doing this for free also feels this way. The rising cost of fuel, insurance and goods plays a great part of this as well. Most volunteer fire departments can barely cover their department's vehicle insurance and workers compensations insurance with the way dues are currently collected. An example would be that we have a yearly budget of around \$5,000. Our vehicle and building insurance is \$5,000 to \$6,000 a year and our workers compensation insurance is around \$1,700 a year. This is already \$1,000 plus over our budget. We fund raise when we are able too but what we don't raise there we pay out of our own pockets. This lack of funding requires volunteers to pay for training and equipment out of their own pocket. Most volunteer departments are kicked out of any grant opportunities because of lack of funding for matching grants. Critical communications upgrade was a major topic between VFD's and the Ozark County commissioners. However, the commissioners were more interested in county issues instead of volunteer fire departments yet volunteer fire departments are the first line of contact for emergencies man-made or mother nature caused. If this isn't passed, then in the very near future you will see volunteer fire departments closing. Think about this, in 1985 there were somewhere around 885,000 volunteer fire fighters, today there are under 680,000. Our calls have gone up 10 times in this time, we have increased calls two times in the past 2 years. What happens when we aren't here to answer those calls? This is not a want this is a have too decision to keep volunteer fire departments open and able to answer these calls, please consider this carefully because you are making the decision to keep us around or allowing us to fall the way side and having to close the doors for good.
