Red Flag Laws make no sense. If a person is believed to be a danger to him or herself, taking away their firearms does not remove that danger. Every Red Flag Law I have seen or heard about does three things: 1) They deprive the subject of their Second, Fourth, Fifth, and Fourteenth Amendment rights under the U.S. Constitution. 2) They do not contain punitive provisions for frivolous claims. Someone could initiate such action to satisfy a grudge or get revenge on the subject. 3) It also is problematic when the subject is living with a spouse or other family member that also owns firearms. All of the firearms are taken, depriving admittedly innocent people of their constitutional rights.

The Jewish Community Relations Council (JCRC), guided by Jewish values, advocates, educates, collaborates, and mobilizes action on issues important to the Jewish community, 60,000 strong in St. Louis. We are committed to pursuing religious tolerance, civic discourse and social justice in St. Louis and beyond. Jewish tradition emphasizes the sanctity and eternal value of human life. The Talmud teaches that: "One who takes a life, it is though they have destroyed the universe. And one who saves a life, it is as though they have saved the universe" (Mishnah Sanhedrin 4:5). The dehumanization of individuals and the carelessness with which human life is taken during incidents of gun violence stand in direct violation of these affirmations of our tradition. We are called upon to take action to prevent the loss of lives and end gun violence. One relatively easy way to prevent some incidents of gun violence is to enact Red Flag laws. These laws, considered a tool for law enforcements, permits a state court to order the temporary removal of firearms from a person who they believe may present a danger to others or themselves. A judge makes the determination to issue the order based on statements and actions made by the gun owner in question. After a set time, the guns are returned to the person from whom they were seized unless another court hearing extends the period of confiscation. A recent law passed by the U.S. Congress provides funds to states who implement Red Flag laws. So far, 19 states and the District of Columbia have them in place. Had Missouri passed a Red Flag law, it is highly likely that the shooter who killed two people at Central Visual ad Performing Arts High School, which is 3 miles from my home and where I know the guidance counselor, would not have had a gun. His parents told law enforcement he was troubled, but they had no tool to act. In Missouri, we cannot be content with the absence of a Red Flag Law, we have to go to the extreme, and attempt to pass an anti-Red Flag law. This piece of legislation is unnecessary, first because we don't have a Red Flag law in our State. Second, because it is directed at orders issued by federal courts and it exempts federal law enforcement from the provisions of the bill. Rather than waste taxpayer time and dollars on a non-issue, instead please direct attention to items that will help fight the epidemic of gun violence. Pass actually Red Flag Laws, increase the age for gun ownership and tighten background check requirements. Do as we are commanded by Jewish Law, help us save a life. Please oppose HB 701 and HB 712.

I'm writing to urge members of this committee to oppose proposals before the Missouri legislature that will further weaken our state's gun laws, including Missouri HB 701. I am submitting this testimony also on HB 712, and have testified in the Senate in opposition to the similar bill, SB 10. This bill expands nullification in Missouri by declaring federal and state judicial orders requiring relinquishment of firearms from "law-abiding citizens" as a Second Amendment infringement. The bill also will bar Missouri from receiving federal funding for enforcing laws requiring relinquishment of firearms, ammunition, or accessories. Missouri has some of the weakest gun laws in the country and our legislature has spent the past decade gutting our common sense public safety laws, while simultaneously resisting attempts to make our communities safer. And Missourians have been paying the price for these actions with their lives. Missouri's rate of gun deaths has increased 70% from 2011 to 2020, compared to a 33% increase nationwide. This past October, the horrific shooting at Central Visual and Performing Arts High School in St. Louis was a tragic reminder of our state's decades of policy failures on gun safety. This tragedy was preventable. Instead, this tragic school shooting was enabled by Missouri's weak gun laws. We saw the deadly ramifications of SAPA--the reckless bill to nullify federal gun laws--when police said they felt powerless to remove the shooters' gun because under Missouri's new law, they would be penalized for enforcing a federal gun law. And now a student and a teacher are dead--and seven others were wounded and school communities around the state felt the impacts of these traumas too. Unfortunately, a clear line can be drawn between the St. Louis high school tragedy and our state's lack of gun safety laws, including the enactment of the state's nullification law, repealing background checks, and the legislature's refusal to enact an extreme risk law. Constant heartbreak cannot and should not be our reality. Instead of taking steps backward, our state needs to be taking steps forward, by passing laws that would keep guns out of the hands of dangerous individuals, and providing communities with the support they need to adopt local solutions to gun violence. While Missouri is facing one of the worst gun violence epidemics in the country, we should not be advancing bills that tie the hands of our police and sheriffs. Our lawmakers should commit themselves to advocating for policies that will truly address the gun violence crisis in our state. I urge the committee to vote no on this dangerous bill.

Extreme risk protection orders (red flag laws) temporarily keep firearms out of the hands of people who a judge has ruled are a danger to themselves or others. As a mother, if my child expresses that they are having thoughts of suicide and they own a gun (which is legal for a minor in Missouri), a red flag law would allow me to petition a judge to temporarily remove their guns. This would buy just a little bit of time, allowing us to get that child the help that they desperately need. If a student expresses thoughts of shooting up their school, red flag laws would allow loved ones to petition a judge to temporarily remove firearms from this student's possession. If a woman is in an abusive relationship and her partner has threatened to shoot her, a red flag law would allow her to petition a judge to temporarily remove firearms from the abusive partner's possession, making a deadly situation less dangerous. Banning extreme risk protection orders (red flag laws) protects domestic abusers, school shooters, domestic abusers, mass shooters, and gives anyone suffering from suicide ideation the means to take their own life. Again, I strongly urge you to vote against this bill.

Extreme Risk Protection Orders, which are more commonly referred to as "Red Flag Laws" save lives. They allow family members or law enforcement to petition the courts to temporarily remove guns from those who are a danger to themselves or others. States that have ERPO laws have seen a reduction in firearm suicides. The Missouri Department of Mental Health's website (<https://dmh.mo.gov/media/pdf/missouri-suicide-prevention-facts-resources>) states that suicide rates in Missouri have risen 29% since 2010 and suicide is now the 3rd leading cause of death for children aged 10-17. The website also states that firearms were used in 63% of Missouri suicides. It seems to me that the legislature should be enacting an ERPO law to address the rising number of suicides in our state not outlawing their use.

Chair, Vice-Chair, members of the committee; thank you for the opportunity to submit testimony today in opposition to HB 712 & 701 – bills that would leave firearms in the possession of domestic abusers in Missouri and make us all less safe. Pro-Choice Missouri works to protect and expand every Missourians’ right to bodily autonomy, to access essential reproductive healthcare, to access accurate information to make the best decisions for ourselves and our families, and to parent our children in safety and dignity. Moreover, we work to ensure reproductive justice for all Missourians, which involves advocating to reduce disparities based on race, income level, insurance coverage status, and other factors. Members of this body frequently and deceitfully evoke the “protection of women and children” in this state while enacting policies that actively harm their health and safety. Banning abortion, gutting school funding, attacking our social safety net programs, and proliferating firearms are all proven to devastate the health and safety of women, children, and entire families. Missouri scored a zero percent safety rating for women on the recently published The Best and Worst States to Be a Woman: Introducing the U.S. Women, Peace, and Security Index 2020 out of the Georgetown Institute for Women, Peace, and Security. Explicitly named as a core reasoning for this low security score is the lack of firearm relinquishment for abusers under protective orders for acts of domestic violence. In an abusive relationship, a positive pregnancy test can be fatal. We know that the two most dangerous times for a person in an abusive relationship are 1) when they are escaping and, 2) when they are pregnant. 41.8% of Missouri women experience intimate partner physical violence, intimate partner sexual violence and/or intimate partner stalking in their lifetimes. Our own state’s Pregnancy Associated Mortality Review Board (PAMR) found that in Missouri, “the most common means of fatal injury in [pregnancy associated] homicide cases was the use of a firearm (62.5%). In half of these cases, the records provided to the PAMR program indicated a history of DV. In each of these homicides, the perpetrator was a current or former partner.... Firearms were the means of fatal injury for 12.7% of all pregnancy-related deaths.” Additionally, there is countless documentation of the link between perpetrators of mass acts of violence and violence against women. Banning red flag gun seizures not only jeopardizes the safety of Missourians already experiencing violence but also entire communities. Between 2014 and 2019, in 68.2% of mass shootings, the perpetrator either shot or killed at least one partner or family member or had a history of DV. In Pro Choice Missouri’s own home office community, law enforcement’s inability to act on red flag warnings and seize firearms due to THIS BODY’S INTERFERENCE enabled the murder of a beloved local teacher and community member/student. Honor the lives of Alexandria Bell and Jean Kirk Kuczka and reject these measures. Missourians deserve MORE. These measures will continue to enable the murders of Missourians and Missouri kids, Pro-Choice Missouri, representing more than 60,000 members across the state, opposes the advancement of this bill and urges you to vote NO. Thank you.

Red Flag Laws Red Flag Laws save lives. In Missouri, since the demise of 3 day waiting periods, background checks and mandatory safety training we have seen an increase in death by gun violence, especially for women or partners in abusive relationships, suicide (especially teens and in the rural areas), and accidental deaths in children because of lack of safety measures. Those of us who have worked with teens know that buying time saves lives. Same with domestic violence, a cooling off period is often successful in deterring gun violence. It is heartbreaking to me, that ideological adherence to the sacredness of gun ownership, without any qualification of responsible ownership is more important than saving lives. Those who drink and drive, drive recklessly, get their licenses taken away at the scene, THEN they go to court where they may plead innocent or guilty or take a deal. Those who were reckless must prove they are responsible before they get their license back, usually attending traffic school to learn proper safety, or at worst, in the case of injury, endangerment, or death, prison time. Red laws allow temporary measures when there is someone threatening self-harm, threatening to harm others, or who obviously is not practicing proper safety measures, like using gun locks. These compassionless laws, wrought from ideological rigidity, sentence parents, children, even whole communities to a lifetime of suffering and loss—many losses that could have been prevented, if only our lawmakers cared enough about the people they represent. Americans and people from Missouri, over 70%, want more gun safety measures in place. They believe Red Flag laws are worth the minor inconvenience they may cause to some gun owners. Common sense gun reform is a demonstration of how much Missourians value genuine safety for their families, their neighbors, and their communities. Missourians, including gun owners, support responsible gun ownership and common sense safety measures that are proven to save lives.

As a clergy person, these bills horrify me. Both practically and morally, these bills do a disservice to both worshipers and to the spirit of community in which they come to worship. Practically speaking, we have seen a wave of violence stem through this country as houses of worship have been attacked by people seeking to do evil by bringing weapons to bear on people at prayer. My community, in particular, still bears scars of synagogue attacks at the Tree of Life Synagogue in Pittsburg, PA (2018), the Chabad of Poway, CA (2019), and Congregation Beth Israel in Colleyville, TX (2022). Our community leaders get almost weekly security briefings from our community partners and partners in law enforcement about credible threats to houses of worship. We already need to hire extra security to keep our gatherings safe out of a fear of people doing exactly what these bills would allow them to do: bring weapons into our houses of worship. More than this, however, my community comes to pray together through the tradition we have inherited over the past four thousand years. It is a tradition that holds up as sacred the words of the Prophet Isaiah, who bade all people to "beat their swords into plowshares, and their spears into pruning hooks. Nation shall not take up sword against nation; they shall never again know war" (Isaiah 2:4). Our tradition goes further in Jewish law to forbid the carrying of a weapon while gathering in prayer or on the Sabbath, even for ornamentation, as was common for swords in the ancient world (Mishna Shabbat 6:4). For us to allow weapons into our house of worship would prevent us from living up to this creed, would sanction the tools of violence and war in our houses of peace, which cannot be considered anything but an infringement on our Constitutional rights to freely practice our religion. In addition, red flag laws have been shown to be a public good, stopping people who have proven through their words and actions that they pose a real threat to others. Just as someone can be detained for making threats of public harm, so to should someone who is a proven threat to themselves or others be prohibited from accessing the means to carry out that harm. Individual liberties are not limitless, and these proposed bills put the rights of individuals to own guns against the rights of all of their fellow citizens to pray and exercise religion freely, to live in safe communities, and to safeguard their life, liberty, and pursuit of happiness. I believe that these rights, too, must not be infringed upon. It is this first and most critical task of this government, any government, to protect its people. These bills would do real harm to the people in my community. They would be psychologically damaging, morally repugnant, and open the door to the ongoing attempts to harm our people that we have worked so hard to close day after day. PLEASE TAKE MY RIGHTS AND THE RIGHTS OF MY CONGREGANTS AND COMMUNITY MEMBERS JUST AS SERIOUSLY AS THE RIGHTS OF GUN OWNERS. Thank you for your consideration.
