will further weaken our state's gun laws, including Missouri HB 712. The same testimony applies in HB 701. I also submitted testimony on the Senate version, SB10. This bill expands nullification in Missouri by declaring federal and state judicial orders requiring relinguishment of firearms from "law-abiding citizens" as a Second Amendment infringement. The bill also will bar Missouri from receiving federal funding for enforcing laws requiring relinquishment of firearms, ammunition, or accessories. Missouri has some of the weakest gun laws in the country and our legislature has spent the past decade gutting our common sense public safety laws, while simultaneously resisting attempts to make our communities safer. And Missourians have been paying the price for these actions with their lives. Missouri's rate of gun deaths has increased 70% from 2011 to 2020, compared to a 33% increase nationwide. This past October, the horrific shooting at Central Visual and Performing Arts High School in St. Louis was a tragic reminder of our state's decades of policy failures on gun safety. This tragedy was preventable. Instead, this tragic school shooting was enabled by Missouri's weak gun laws.We saw the deadly ramifications of SAPA--the reckless bill to nullify federal gun laws--when police said they felt powerless to remove the shooters' gun because under Missouri's new law, they would be penalized for enforcing a federal gun law. And now a student and a teacher are dead-and seven others were wounded and school communities around the state felt the impacts of these traumas too.Unfortunately, a clear line can be drawn between the St. Louis high school tragedy and our state's lack of gun safety laws, including the enactment of the state's nullification law, repealing background checks, and the legislature's refusal to enact an extreme risk law. Constant heartbreak cannot and should not be our reality. Instead of taking steps backward, our state needs to be taking steps forward, by passing laws that would keep guns out of the hands of dangerous individuals, and providing communities with the support they need to adopt local solutions to gun violence. While Missouri is facing one of the worst gun violence epidemics in the country, we should not be advancing bills that tie the hands of our police and sheriffs. Our lawmakers should commit themselves to advocating for policies that will truly address the gun violence crisis in our state. I urge the committee to vote no on this dangerous bill.

The website also states that firearms were used in 63% of Missouri suicides. Red Flag LawsRed Flag Laws save lives. In Missouri, since the demise of 3 day waiting periods, background checks and mandatory safety training we have seen an increase in death by gun violence,				

especially for women or partners in abusive relationships, suicide (especially teens and in the rural areas), and accidental deaths in children because of lack of safety measures. Those of us who have worked with teens know that buying time saves lives. Same with domestic violence, a cooling off period is often successful in deterring gun violence. It is heartbreaking to me, that ideological adherence to the sacredness of gun ownership, without any qualification of responsible ownership is more important than saving lives. Those who drink and drive, drive recklessly, get their licenses taken away at the scene, THEN they go to court where they may plead innocent or guilty or take a deal. Those who were reckless must prove they are responsible before they get their license back, usually attending traffic school to learn proper safety, or at worst, in the case of injury, endangerment, or death, prison time. Red laws allow temporary measures when there is someone threatening self-harm, threating to harm others, or who obviously is not practicing proper safety measures, like using gun locks.These compassionless laws, wrought from ideological rigidity, sentence parents, children, even whole communities to a lifetime of suffering and loss-many losses that could have been prevented, if only our lawmakers cared enough about the people they represent. Americans and people from Missouri, over 70%, want more gun safety measures in place. They believe Red Flag laws are worth the minor inconvenience they may cause to some gun owners. Common sense gun reform is a demonstration of how much Missourians value genuine safety for their families, their neighbors, and their communities. Missourians, including gun owners, support responsible gun ownership and common sense safety measures that are proven to save lives.

As a clergy person, these bills horrify me. Both practically and morally, these bills do a disservice to both worshipers and to the spirit of community in which they come to worship. Practically speaking, we have seen a wave of violence stem through this country as houses of worship have been attacked by people seeking to do evil by bringing weapons to bear on people at praver. My community, in particular, still bears scars of synagogue attacks at the Tree of Life Synagogue in Pittsburg, PA (2018). the Chabad of Poway, CA (2019), and Congregation Beth Israel in Colleyville, TX (2022). Our community leaders get almost weekly security briefings from our community partners and partners in law enforcement about credible threats to houses of worship. We already need to hire extra security to keep our gatherings safe out of a fear of people doing exactly what these bills would allow them to do: bring weapons into our houses of worship. More than this, however, my community comes to pray together through the tradition we have inherited over the past four thousand years. It is a tradition that holds up as sacred the words of the Prophet Isaiah, who bade all people to "beat their swords into plowshares, and their spears into pruning hooks. Nation shall not take up sword against nation; they shall never again know war" (Isaiah 2:4). Our tradition goes further in Jewish law to forbid the carrying of a weapon while gathering in prayer or on the Sabbath, even for ornamentation, as was common for swords in the ancient world (Mishna Shabbat 6:4). For us to allow weapons into our house of worship would prevent us from living up to this creed, would sanction the tools of violence and war in our houses of peace, which cannot be considered anything but an infringement on our Constitutional rights to freely practice our religion. In addition, red flag laws have been shown to be a public good, stopping people who have proven through their words and actions that they pose a real threat to others. Just as someone can be detained for making threats of public harm, so to should someone who is a proven threat to themselves or others be prohibited from accessing the means to carry out that harm. Individual liberties are not limitless, and these proposed bills put the rights of individuals to own guns against the rights of all of their fellow citizens to pray and exercise religion freely, to live in safe communities, and to safeguard their life, liberty, and pursuit of happiness. I believe that these rights, too, must not be infringed upon. It is this first and most critical task of this government, any government, to protect its people. These bills would do real harm to the people in my community. They would be psychologically damaging, morally repugnant, and open the door to the ongoing attempts to harm our people that we have worked so hard to close day after day. PLEASE TAKE MY RIGHTS AND THE RIGHTS OF MY CONGREGANTS AND COMMUNITY MEMBERS JUST AS SERIOUSLY AS THE RIGHTS OF GUN OWNERS. Thank you for your consideration.
