February 28, 2023RE: Comments in support of MO HB 995Dear Committee Members: On behalf of the responsible pet care community, we ask that you support the passage of HB 995.As the advocacy voice of the responsible pet care community, the Pet Advocacy Network represents the interests and expertise of retailers, companion animal suppliers, manufacturers, distributors, pet owners, and others involved in the many aspects of pet care across the United States. Our association works to promote animal well-being, and responsible pet ownership, foster environmental stewardship, and ensure the availability of healthy pets through our work at the state and federal levels—including the United States Department of Agriculture, U.S. Fish and Wildlife Service, and the Centers for Disease Control and Prevention. We routinely advocate for legislative and regulatory proposals to advance the public interest of protecting public health and the safety, health, and availability of companion animals. All of us in the responsible pet care community don't just care about animals, we provide care for them daily—and are dedicated to ensuring that appropriate care of animals is the primary focus of any law or regulation. As such, we offer an unmatched depth and breadth of experience on legislative efforts to verify and certify the health and well-being of pets from the time they are born all the way until they are taken home and made a part of families. What we don't need in 2023 are more unnecessary barriers to pet ownership, like the local pet sale bans this bill seeks to quell. The care and companionship of pets is integral to not only the emotional and physical well-being of many Americans, but also to the strength and stability of our economy. According to the 2021-2022 American Pet Products Association National Pet Owners Survey, 70% of U.S. households own a pet, which equates to 90.5 million homes. Missouri is an integral part of the American pet sector that contributes \$260.5 billion directly and indirectly to the U.S. economy; 2.78 million U.S. jobs are directly and indirectly linked to pets, U.S. households spent \$93.95 billion on their pets and \$23.4 billion public revenues were generated by consumer expenditures on pets from local, state and federal taxes. View an infographic on the economic impact of the Missourian pet sector here: https://petadvocacv.org/wpcontent/uploads/2022/02/MO-Infographic.pdf All that local pet sale bans succeed in doing is running reputable businesses out of town, eliminating a transparent and trusted local source of pets. while further restricting consumer choice when it comes to selecting the pet that is the best fit for their family's lifestyle. The past several years have been incredibly challenging, particularly for small business owners. Representatives at all levels of Government should be doing everything in their power to support responsible small businesses, especially those that are highly regulated. These local pet care businesses are committed to the health, safety, and wellbeing of the animals they provide to families as establishing life-long quality relationships with pet owners is vital to sustain their businesses. And small pet stores can't compete with the volume pricing for pet products that online or big-box retailers are able to offer, so they also depend on their ability to offer families healthy pets as

an integral part of their business model. Without pet stores to personally interact with and select their new pet, families may turn to online sources, where they could fall victim to "puppy scams" that the Better Business Bureau has reported have surged in recent years— where folks are tricked into sending unrecoverable money for a nonexistent dog. While there are reputable and responsible online sellers, the Better Business Bureau has stated that fake online puppy sellers and puppy scams have dramatically increased by 39 percent since 2017, and up to 80 percent of sponsored online ads for puppies may be fake. Victims of these puppy scams often have no legal recourse because they purchased from a source without regulatory oversight and without a purchase warranty to protect them. Many pet stores that sell puppies provide protections that can include replacement of the animal, a refund of the purchase price, and/or reimbursement of veterinary expenses, generally up to the purchase price of the animal. In this way, pet stores are further incentivized to work with quality breeders to ensure that the dogs they offer are healthy and well-bred. We ask that you support HB 995; common sense legislation to make sure that pet owners across Missouri continue to have reliable access to healthy animals to love as pets now and in the future. This legislation is entirely about protecting Petland—a controversial, out-of-state corporation known for selling sick puppies from cruel puppy mills—and it's 7 Missouri locations. There are no local ordinances regulating the sale of puppies in pet stores in Missouri, but Petland is apparently so threatened by the mere possibility of local regulation and is so desperate for a win that they are targeting our state with this preemption bill. Petland has failed everywhere it has attempted to pass a bill like this since 2016.It would be unconscionable for our state lawmakers to force cities to accept the import of puppy mill puppies to be sold in pet stores considering Missouri shelters and animal control agencies are locally funded and most are already overwhelmed as they work to manage pet overpopulation. Missouri remains the puppy mill capital of the nation, yet there have been commendable improvements to our laws and enforcement mechanisms in recent years. This bill would be a big step in the wrong direction, showing that Missouri protects puppy mills and their pet store sales outlets above all else. There are no consumer protection exceptions in the bill so if a customer purchases a dog that has health issues that weren't caught by Petland's vets, there is no recourse and the customer will be forced to pay all vet bills. There are no public health protection exceptions so a zoonotic disease outbreak would not curtailed as quickly if we are completely reliant on the state to take action meaning more dogs and potentially people could get sick.

As a veterinarian and graduate of The University of Missouri College of Veterinary Medicine, I voice my strong opposition to HB 995 and encourage you to do the same. This bill provides protection from local oversight to an industry with a long history of practices which compromise the health and welfare of animals. Practices including, but not limited to, the purchase and sale of animals with undisclosed infectious diseases, put these animals at risk as well as other animals in our communities. The transfer of sick animals compromises the health of animals at the locations, while also risking exposure to animals in the community. The Petland model facilitates the interaction of dozens of people each day between their pets and animals in the store, increasing the likelihood of disease outbreaks spreading into communities through exposure to family pets. A prime example of this negligence is the 2019 outbreak of multidrug-resistant Campylobacter which spread from a single Petland store to over a dozen states. Furthermore, this bill has does not allow for exceptions related to animal welfare protection. Petland has been linked to poor management and diseased or dead animals dozens of times. Without the ability to regulate pet shops at a local level, violations of our animal welfare laws are likely to go unnoticed and therefore allowed to continue. Should HB 995 be enacted, local ordinances related to animal welfare that would have otherwise been applicable to pet shops will not have the ability to intervene. I strongly encourage the members of this committee to stand up for what is right by standing in opposition of HB 995.

This bill would be a big step in the wrong direction, showing that Missouri protects puppy mills and their pet store sales outlets above all else. I am a graduate of the University of Missouri College of Veterinary Medicine. I encourage you to oppose HB 995. This bill gives blanket protection from local oversight of an industry linked to purchasing and selling animals with undisclosed illnesses and congenital diseases. The transfer of sick animals puts the health of other puppies at these locations at risk while also potentially being the source of a disease outbreak like multidrug-resistant Campylobacter, which we saw spread from a Petland store to over a dozen states in 2019. The Petland model necessitates the interaction of dozens of people each day with their puppies and other animals in the store, increasing the likelihood of another outbreak of this and other diseases. It also runs the risk of bringing an illness home to a family pet. Additionally, this bill has no exceptions for animal welfare, and Petland has been linked to dozens of instances of poor management and diseased or dead animals. Without the ability to regulate pet shops at a local level, violations of our animal welfare laws and any local ordinances related to animal welfare that would have otherwise been applicable to pet shops are more likely to go unnoticed and unrepaired. I strongly encourage the members of this committee to oppose HB 995 for the reasons listed above.

Honorable Chair Murphy, Vice-Chair Van Scholack, Ranking Minority Member Bangert and esteemed Committee members: Best Friends Animal Society and our Missouri members, supporters and partners respectfully submit our opposition to House Bill 995, which would effectively strip Missouri localities of their ability to regulate pet dealers. Pet mills are a serious problem in the U.S. These facilities, which supply nearly all retail pet stores and online retailers that sell purposely bred pets, are cruel and inhumane breeding factories in which profit takes priority over the health, comfort and welfare of the animals. Although the USDA regulates many of these breeders, the minimum federal standards do not ensure a humane life for animals. Commercial dog kennels can legally have more than a thousand dogs in one facility, and those dogs are allowed to be confined to very small cages for their entire lives, breeding continuously in order to produce as many puppies as possible for the pet trade. And USDA inspection reports show that many USDA-licensed breeders continue to sell animals to local pet stores even after being cited for serious violations at their facilities. In other words, having a USDA license does not ensure humane or responsible breeding. Because the focus is solely on profit, pet mill owners cut all possible corners to keep their overhead low, at the expense of the health and well-being of their animals. For the unsuspecting consumer, this frequently results in the purchase of a pet facing an array of immediate veterinary problems or harboring genetic diseases that surface down the line. This creates a financial burden on the consumer and results in many of these animals being surrendered to overcrowded, taxpayer-subsidized shelters. Thus, this is not just an animal welfare issue but a consumer protection concern that has a direct impact on taxpayers. It makes little sense to continue manufacturing dogs and cats while so many are being killed for lack of space. Public education has been effective, but until states take the initiative to limit the supply of pets being imported from mostly out-of-state, substandard commercial facilities, there can be no hope of preventing these unnecessary deaths. Pet stores rely on commercial pet mills and their distributors to supply their pets because ethical breeders won't sell to pet stores for two simple reasons; it's not financially viable and they don't sell to third parties. They want to know where those pets are going. They want to meet the people who are going to care for that animal. And that's why the pledge never to sell a pet to a pet store can be found verbatim in every reputable breeder's code of ethics, including virtually all of the parent breed clubs promoted by the American Kennel Club, as well as the national cat fancier associations. Ethical breeders encourage potential buyers to visit the home where the animals were bred, they conduct an interview to be sure the match is the best one for both the buyer and the animal, and they require a contract that requires the buyer to provide good care, to spay and neuter the animal, and to return the pet to the breeder if things don't work out at any point over the pet's lifetime. These sensible provisions cannot apply when animals are sold through pet stores. Also concerning is the fact that 21 states have been hit by an outbreak of a strain of bacteria (Campylobacter) that is linked to pet shop

puppies. Campylobacter is resistant to antibiotics and contagious to humans. Now more than ever, Missouri residents should not have to worry about being exposed to this serious public health threat. Those who benefit most from companion animal sales in pet stores are the retailers themselves. While they may profit from the practice of buying these pets at a low price from commercial brokers and then selling them at a high price (typically without first spaying or neutering them), it is the taxpaying public who pays for animal control to house and euthanize excess animals in the community. Further, many pet stores are frequently accused of predatory lending by offering financing upwards of 160%, creating a serious and unexpected financial strain on the consumer, sometimes resulting in an obligation for ongoing payments for a pet that is deceased. Pet stores that sell commercially bred pets can choose to be part of the solution rather than the problem by phasing out the sale of commercially bred pets in favor of other common, profitable revenue streams such as pet product sales, grooming and day care, and by offering space for animal rescue organizations to adopt out animals from those stores, as so many pet stores across the U.S. already do with great success.Pet stores that have transitioned from selling milled dogs and cats to offering rescued pets for adoption have found this animal-friendly model to be both viable and embraced by the communities in which the stores are located. Therefore, allowing localities to restrict the retail sale of pets does not preclude pet stores from doing business, but does, in fact, alleviate a significant burden on local shelters by increasing pet adoptions. Further, it does not prevent anyone from purchasing a pet directly from a private breeder. Nearly 500 cities, counties and states have enacted retail pet sales legislation in order to effectively address the problem of puppy and kitten mills from the point of sale. While statewide commercial breeder regulation is important, it should not preclude localities from taking even more stringent steps to eliminating the puppy and kitten mill problem in their own communities. Allowing businesses that profit from the sale of puppies from mills to determine how localities choose to regulate their businesses is not in the best interest of those communities and their residents, nor of the state. In view of numerous concerns regarding HB 995, Best Friends Animal Society and our Missouri members, supporters and partners respectfully ask that you not move the bill forward.
