To the Missouri House Election and Elected Officials Committee: The Missouri Sierra Club opposes House Joint Resolution 19. The Missouri Sierra Club represents over 8,000 dues-paying members across the state who advocate for conservation, environmental, social justice, and democracy through grassroots efforts. We believe that every voter should have all the tools to exert their constitutional right to be involved in our democracy. Missouri's 115 year constitutional right to utilize the initiative petition to bring policy to the people of the state is a historic treasure and allows voters to participate in our democratic process. HJR 19 requires that any measure referred to the people shall take effect when approved by a majority of the votes cast statewide and also a majority of votes cast in each of more than half of the state senate districts. This is an attempt to make it harder for Missouri voters to pass legislation together, leads to minority rule, and is in direct opposition to our organization's values of an equitable and accessible democracy for all. According to research from the Missouri Scout, Missourians across the political spectrum want the initiative petition process to be made EASIER (40%) or LEFT ALONE (33%). The Missouri legislature should respect the voice and will of the people and reject HJR 19.The Sierra Club, Missouri Chapter has worked on numerous initiative petition campaigns over the past 50 years. This organization and our leadership understand how rigorous this process already is- you have to get hundreds of thousands of voters to sign on before a measure even gets considered for the ballot. Adding additional barriers does nothing more than censure the voice of the people. This is the people's tool to get things done. As Governor Ashcroft once said, "It is through the initiative process that those who have no influence with elective representatives may take their cause directly to the people. The American Civil Liberties Union of Missouri submits this testimony in opposition to HJR 19, which proposes increasing the threshold for passing proposed constitutional amendments. Currently, proposed citizen amendments pass by a majority of votes cast. This resolution proposes requiring passage by at least 50% of votes cast, PLUS gaining a majority vote in at least 50% of state senate districts. This could dilute votes of more populous areas, and result in the rejection of measures that captured a majority of votes cast. The citizen initiative process provides a manner for direct participation. It promotes civic engagement and encourages citizens to discuss issues with one another. It promotes accountability between the government and the governed. But for this potential to be realized, it must be actual — by not erecting undue barriers to participation or creating a confusing passage threshold that fails to effectuate the will of Missouri's voters.

Black aims at fairness of representation through the resolution on initiative petitions requiring passage in a majority of state senate districts, rather than as a power play for vested interests who have been dissatisfied with the results of prior statewide petitions. If his concern involves the former assumption of seeking the fairness of passage of a statewide initiative petition, then his resolution misses the mark. A statewide initiative petition seeks an answer by all of the voters in the state on a particular issue. The resolution proposed by Rep. Black, if adopted, could have the result of being a very anti-democratic measure. It could be possible to have a high majority of voters supporting an initiative petition statewide, but lacking passage in a majority of senate districts. Denying a petition under this kind of structure would be profoundly anti-democratic, defeating the whole purpose and intent of initiative petitions to begin with. We don't elect presidential candidates this way in any state. Candidates are chosen by who wins the most votes of all those cast, regardless of from what part of the state they are cast from. It would be profoundly ridiculous to pass a law, requiring a presidential candidate to not only win the majority of the vote in a state, but also win the majority of the state senate districts, or the majority of the Congressional districts. If this resolution has been submitted on the behalf of special interests who have been dissatisfied with prior statewide petitions, such as the passage of expansion of Medicaid and an increase in the minimum wage, then this resolution is obviously profoundly antidemocratic. Years before, I wrote to The Honorable John Ashcroft, Missouri's 50th Governor (1984-1993) who went on to serve as US Senator (1995-2001) and 79th US Attorney General, aka Justice Dept CEO (2001-2005). I urged him to sign the bill on his desk passed by a progressive Missouri House and Senate to divest Missouri funds in an international response to apartheid in South Africa and then enforce the law he signed when the MOSERS (MO State Employees Retirement System) Board refused to comply 5 years later. I was surprised, both times, he did the honorable thing after I appealed to him citing Old Testament references in the name of Jesus. I supposed as a Republican, he would not sign the Democratic led divestment bill into law. Little did I know, he was the son of a Pentecostal preacher and was not Jewish as I assumed. I try to leave judging people to the Lord God Almighty now.Nobel Peace Prize Winner, Archbishop Desmond Tutu visited UMKC and praised Missouri's forward thinking in this important fight for human rights. HJR 19 would impose a new standard for passage of both constitutional and statutory amendments. The new threshold is that passage of an initiative petition ballot measure would require not only a majority of votes cast, but also a majority of votes in each Senate district. Currently, measures require only a majority of total votes cast. Our objections to HJR 19 are twofold: 1) Our re-districting process is not carried out in a non-partisan way. Political parties jockey for advantage after the tenyear Census forces us to re-draw the boundaries of our voting districts. The geography of the final Senate district lines (and other district lines) often represents political "horse-trading" as opposed to an attempt to equalize the voices of all Missourians. 2) A simple majority does translate to one person=one vote no matter where you live in Missouri. Adding an extra criterion of securing passage in a majority of the votes in a majority of State Senate Districts in order to pass a measure adds a layer of complexity, making it more difficult to secure passage. Having grown up in a rural area, I hear the concerns of friends in rural areas who say they feel ignored by the current process, but I ask them to consider this. Missourians from all eight Congressional districts do tend to collect signatures in every petition initiative signature drive because there are local residents who support the measure that is being put forward. It is paid signature gathering that focuses on areas with concentrated populations because of the high expenses already associated with meeting our high standards to get a measure on the ballot. Those who wish to participate in gathering signatures can volunteer to do so with the organizations leading each campaign. Those who wish to oppose a ballot measure once it secures a place on the ballot can organize informational forums and reach out to their friends and neighbors, no matter where they live. A healthy democracy depends on informed and active citizens. Those who say they did not know that a measure - like legalization of recreational marijuana - was going to be on the ballot simply abdicated their responsibility to study the ballot in advance to prepare to vote. There are many organizations, such as the Missouri League of Women Voters, that will gladly educate about what is on the ballot - in a non-partisan way - when their help is requested. Paraquad certainly provides voter education to our staff and to our participants so that we are ready to vote in each election. Let us step up to both our rights as voters and our RESPONSIBILITIES as voters. The initiative petition process is one of the only avenues open to people with disabilities when we bring concerns to the General Assembly repeatedly but see no action to solve the challenges we are experiencing. For years we have been sounding the alarm about the lack of affordable, healthy, and accessible housing and public transportation and how this is damaging our health, employability, and ability to participate in day-to-day activities in our communities. It would be an uphill climb to meet the criteria to put issues of housing or transportation on a ballot and to secure a simple majority of votes from our Missouri neighbors without adding a new standard to meet for successful passage. We ask

that you not make our participation in direct democracy even harder. Please vote no on HJR 19.About Paraquad: Paraquad is one of the oldest and largest independent living centers in the country. Centers for Independent Living are unique because more than 50% of our board and staff are people with disabilities. Chairwoman McGaugh, Vice-Chair Stacy, members of the committee; thank you for the opportunity to submit testimony today in opposition to HB 703, 780,& HJR 19 which would prevent the initiative petition (IP) process from working for the people of Missouri. Pro-Choice Missouri works to protect and expand every Missourians' right to bodily autonomy, to access essential reproductive healthcare, to access accurate information to make the best decisions for ourselves and our families, and to parent our children in safety and dignity. Moreover, we work to ensure reproductive justice for all Missourians, which involves advocating to reduce disparities based on race, income level, insurance coverage status, and other factors. Over the last 3+ years Pro-Choice Missouri has been heavily invested in several ballot initiatives including Medicaid Expansion, Raise up Missouri, and Clean Missouri. We had a team of 7 people who collected more than 5.500 signatures to help get Medicaid Expansion on the ballot. This number is only a fraction of the total 120,000 signatures that were collected by the larger campaign. Everyday our employees got up in the sun, the wind, the snow, and the rain, to speak to strangers on street corners all across the First and Second Congressional Districts. They waited on metro platforms for hours on freezing days being rejected by strangers, hoping for a few good conversations- from the most densely populated neighborhoods in St Louis to the most lonely country roads. Under current law, initiative petitions proposing constitutional amendments must be signed by 8% of the legal voters who voted in the last gubernatorial election in each of two-thirds of the congressional districts. The proposed changes in HB 703, 780, & HJR 19, if approved by the voters, would make the IP process increasingly more difficult by mandating approval by a majority of the votes cast statewide and a majority of votes cast thereon in each of more than half of the state senate districts, and over burdening signature collectors with unnecessary cumbersome regulations. Our small non-profit organization puts considerable effort into supporting these ballot initiatives, and makes up only a small fraction of the signatures already required. This amendment would require over 100,000 more signatures and would make it so only well financed groups could access the ballot. This change denies the people their voice in the process and preferences large monied organizations. HB 703, 780, & HJR 19 would make the ballot initiative process prohibitively difficult, because the task is already a monumental one. The measure is retaliatory to the millions of voters who voted in favor of medical marijuana, ethics reform, medicaid expansion, and so much more. Further, the increased attacks in this 2023 legislative session are a direct response to the overwhelming number of voters across five states who voted to protect and expand access to abortion in the 2022 Midterm election. Abortion access wins at the ballot. The majority of Missourians, 7 in 10, do NOT support political interference in abortion access. Missourians deserve MORE than power hungry politicians utilizing their positions of power to undo the will of the people they purport to represent. These measures will have lasting negative impacts in Missouri. Pro-Choice Missouri, representing more than 60,000

members across the state, opposes the advancement of these resolutions, and urges you to vote NO. Thank you.

HJR 19 does one thing - it seeks to make it significantly more difficult for the citizens of this state to exercise their right to direct democracy. Missouri was born from the depths of direct democracy. Since its conception in 1875, our state's constitution has reserved the right for people to "propose and enact or reject laws and amendments to the constitution by the initiative, independent of the general assembly." It is contradictory to our innately representative government for our state leaders to be focused on adding obstacles for Missourians to participate in the democratic process. This bill and those like it show the hypocrisy of our state legislature. Since 1910, the constitution has been amended 182 times, and only 27 of those changes have originated through the initiative petition process. Each of these proposals has required 50% + 1 of the vote in order to pass. HJR 19 proposes to require amendments to not only require a simple majority of votes cast, but also the majority of votes in the majority of senate districts. The sponsor of this bill would like you to believe that this measure would be beneficial to the state... It is not. The ballot initiative petition process is about checks and balances and serves as an important part of our democracy by giving voters the freedom to have a say on the laws that govern us. This is important as we've seen our state legislature grow increasingly more paralyzed by partisan politics. This bill seeks to silence the voices of voters across the state and allow legislators to nullify the voice of the people that they were elected to represent. There are two ways to amend the constitution: The Initiative Petition process and through General assembly. Yet, the bill only proposes changes to the Initiative Petition process. For this reason, we respectfully ask that you oppose HJR 19. This modifies the current requirement that such petitions be signed by 8% of voters in two-thirds of the congressional districts. It creates an added limitation of requiring more than half of the state senate districts to approve constitutional amendments that arise from initiative petitions, which differs from the current requirement. This will make the initiative process more difficult for Missourians to pass amendments that can meaningfully improve their lives and have their voices heard. We have our initiative petition structure to protect our democracy and create a balance between Missourians and their respective elected officials. Voters have confidence in this process because everyone gets an equal chance to vote and make a change. It empowers Missourians to collaborate and speak to issues that directly impact them and their communities. For these reasons, we are coming together to oppose any change to the initiative petition process. However, requiring that there must be 51% of the vote in favor of constitutional and statutory amendments in all 8 senate districts does nothing except make it almost impossible to change the law or amend the constitution using the initiative petition process. The state of Missouri is diverse. There are issues that are important to some senate districts that are not important to others. For those districts, an issue brought by initiative petition process may not attract as many votes as the measure will in another district. It doesn't mean the issue is not important to many citizens or to the state. Requiring the majority vote of each senate district does not reflect the will of the people. The Missouri legislatures' interest in making the initiative petition process more difficult is a power grab that evades the will of the people. Advocates of Planned Parenthood of the St. Louis Region and Southwest Missouri opposes House Joint Resolution 19 and House Bill 703 because they impose additional, unnecessary burdens on Missourians' right to directly petition one another and thwart the will of the people. Missourians have had the right to directly petition one another for changes to our laws and constitution for nearly 150 years. This measure is an attack on our history and constitution. Missourians of all political persuasions have come together and put measures on the ballot to make their voices heard and overcome legislative roadblocks. The current process to qualify a measure for the ballot through initiative petition is already extremely difficult, requiring hundreds of volunteers to devote thousands of hours to gather the signatures of 200,000 to 350,000 Missourians — one of the highest signature requirements in the nation — while the Legislature can put items on the ballot with a simple majority vote of politicians. To become law, a ballot measure must receive a majority vote. Imposing additional requirements makes it more difficult for Missourians to make their voices heard and undermines the will of the people. Whether by adding additional bureaucracy or imposing additional barriers for passage, both of these proposals make it more difficult — in some cases, impossible — for Missourians to engage in direct democracy through the initiative petition process. It's plain to see that these measures are about silencing, not empowering, Missouri voters.Lawmakers should focus on making voting more accessible for Missourians rather than pursuing unnecessary, expensive and unconstitutional burdens on the right to vote in our state.
