As a citizen, I fully support this bill. Legislation such as this will enable the average person, if desired, to transact using a more stable currency than what we are currently using, the Federal Reserve Note. For those who want information on how this could be worked out practically, look no further than the Goldback as a day-to-day currency. Several states that have already allowed transactions with gold and silver have seen their citizens use these. A 1 Goldback note is actually made of 1/1000 oz of gold. It isn't that it is backed by gold, it is actually gold itself. It is designed to make gold transactable. A common question is what it would look like to pay with gold. Certainly we are not going to get gas or groceries and then pay with a gold bar, so how would this work? But each Goldback is made with only about \$4 worth of gold. That makes it transactable. And unlike our Federal Reserve Notes, where the only real difference between a \$1 bill and a \$10 bill is the face and an extra 'zero', a 10 Goldback note contains 10 times the amount of gold as a 1 Goldback note (1/100 oz). A 50 Goldback note, then would be 1/20 oz of gold, or 50 times a 1 Goldback note. This allows for a spendable currency that is very stable, and not subject to the sort of inflation or manipulation that our current bills are. For some, this is important because of a fear that the Federal Reserve may be weaponized against us. There may well be truth to that, but even if we were to assume the Federal Reserve's actions are truly altruistic, we still must admit they are fallible people, and they can make mistakes. I believe it is far better to promote and normalize a currency that is so stable that it is 'as good as gold' than one that is at best subject to error and at worst subject to tyranny. So please, consider voting in favor of SB100.
