Moreover, this bill would place an undue burden on taxpayers, as it would require the state to provide tax relief to those who purchase firearms and ammunition. This is an unnecessary expense that our state can ill afford, especially given the current economic climate. In addition, this bill would make it more difficult for law enforcement to track firearms sales, which could lead to an increase in gun-related crimes. By providing tax relief to those who engage in the trade of firearms, this bill would effectively incentivize the proliferation of weapons in our community, which is a concerning prospect. In conclusion, I strongly urge you to oppose this bill. While the proponents of this bill may argue that it will provide tax relief to taxpayers, the potential risks to our community far outweigh any potential benefits. We must work together to create a safer and more secure community for all, and this bill is not the way to do so.
