Madam Chair and members of the committee: My name is Robyn Schelp and I am the Director of Policy and Advocacy for Kids Win Missouri. We advocate on issues of child well-being including early care and education, foster care, healthcare, and other issues which impact children. Kids Win Missouri supports SB 198, as it helps victims of abuse and homeless youth get the documentation they need to improve their lives. Thank you to Sen. Thompson Rehder for her leadership on this legislation. Kids Win Missouri leads a coalition of approximately 20 organizations statewide which serve youth who are experiencing homelessness. The language on SB 198 bill which waives the fee for an ID or driver's license for homeless youth is a priority of this coalition and we appreciate Senator Gannon's work on this part of the legislation.SB 47 would ensure that homeless or unaccompanied youth have access to a free state issued ID in the form of either a driver's license or a non-driver's license. To qualify, a youth would need a note from a school counselor/school homeless liaison, an agency, or an attorney representing the youth. Identification is something many of us take for granted, but it is crucial for accessing daily needs. For many youth, an identification opens the door to building a more stable life. Identification is necessary for getting a job, opening a bank account, enrolling in school or workforce training, etc. Providing a free drivers license or non-drivers license is a simple measure that the state can take in helping Missouri's youth who are homeless or unaccompanied as they take the necessary steps towards employment, housing, and independence.
