Please find below an opposition letter to SB 222 from the City of St. Louis Department of Human Services Director: I am writing to oppose SB 222 and respectfully request you vote 'no' on this bill. During the pandemic, eviction moratoriums helped households at risk of eviction as the economy suffered from the COVID-19 pandemic. The moratoriums assisted families and children stay in place and stay safe as the virus spread. St. Louis, like many communities in Missouri, struggles with affordable housing for renters. The COVID-19 pandemic caused an unprecedented impact on lowincome renters struggling to make ends meet as the cost of rent increased for St. Louis residents. Nationally, asking rents increased by 15 percent in February 2022, which put an estimated 150,000 to 230,000 Missouri households at risk of eviction of the 802,535 Missouri renter households. In St. Louis City, we estimate that 37,000 households are cost-burdened by rent. Collectively, they pay more than \$100M more in rent than they can afford every year. The previous eviction moratoriums in the City of St. Louis during the pandemic were enacted by the Missouri Twenty-Second Judicial Circuit to suspend eviction for nonpayment of rent. Evictions could still move forward for the following: (1) Engaging in criminal activity while on the premises; (2) Threatening the health or safety of the other residents; (3) Damaging or posing an immediate and significant risk of damage to property; (4) Violating any applicable building code, health ordinance, or similar regulation relating to health and safety; or (5) Violating any other contractual obligation, except non-payment of rent. The moratoriums were coordinated with resources, such as rental and utility assistance and mediation, which benefited low-income renters and helped make landlords whole. Emergency Rental Assistance programs are coming to a close locally and at the state, while the need is still great to support renters and landlords. The Missouri Housing Development Commission is closing the State Assistance for Housing Relief Program as it continues to fund 3,500 to 4,000 applications per week. The City of St. Louis is exploring options to continue rental and utility assistance to support renters and make landlords whole. Eviction moratoriums are potential policy tools utilized to help families and children stay in their home as nonpayment for rent is resolved. These tools working together have shown results in being able to pay landlords for a tenants rental arrears, forward rent, and utilities. The eviction moratoriums are rare policy tools necessary to save lives and help protect citizens. The COVID-19 pandemic has not been easy, especially for our small business owners and low-income families. To ensure a successful recovery from this pandemic, and to prepare in case of future emergencies, we must ensure we have this tool available to local governments.
