As a homeschool mom, I am in favor of SB 411.By adding the FLEX designation, it preserves and protects the traditional home school who does not want to participate in the public schools, but allows those who want to participate in public school extracurriculars like sports or to enroll in the MOScholars scholarship program, the ability to do so. Private and parochial schools are only defined by religion, otherwise they operate the same. A home school and FLEX school will be defined by the activities, but operate the same. This will address concerns that many traditional home school families have of additional government oversight, that goes above and beyond our home school statutes, that might be created when families choose to participate in public school sports or the MoScholars program. This adds another layer of protection for the traditional home school family that chooses to school at home, and not join in public school activities. SB 411 includes the following, which I am in favor of:FLEX SCHOOLS (Sections 161.670, 162.996, 162.1250, 166.700, 167.031, 167.061, 167.600, 167.619, 210.167, 210.211, 211.031, 452.375, and 167.071) The act defines a "Family-Led Educational eXperience (FLEX) school" or "FLEX school" as a school that meets certain criteria that also apply to home schools, except that a FLEX school may enroll students who participate in the Missouri Empowerment Scholarship Accounts Program or activities offered by a public school district. The definition of "home school" is modified to exclude students who participate in such Program or activities. The act modifies certain provisions of law to include FLEX schools in provisions that also apply to home schools. The act also modifies the definition of "qualified schools" in provisions relating to the Missouri Empowerment Scholarship Accounts Program to include FLEX schools instead of home schools. Public schools, state agencies and employees, and certain private entities shall not refer to FLEX schools or to publicly funded programs, including but not limited to virtual school programs, as "home schooling". Additionally, public schools, state agencies and employees, and certain private entities shall not refer to students who are enrolled in an attendance center of a public school district, including full-time virtual school programs, students who receive education funding from the state of Missouri, or students who participate in the Missouri Empowerment Scholarship Accounts Program as "home schooled" students.

I strongly support SB 411. I am a homeschool mother of five children. I never intended to homeschool. My kids were enrolled in public school until 2020 when the whole world shut down. There are good things that come out of bad situations, and one thing I learned very quickly was that my children were falling behind academically. The school district I was in didn't offer a lot of curriculum or academic support in the Spring of 2020, they basically ended the school year in March. I decided I would purchase curriculum myself to make best use of our time at home together. It was then that I realized that my children were behind on their reading, writing, and math levels. My second grader was reading at an early first grade level, my fourth grader couldn't spell and was writing sentences without capitalization or punctuation. I was shocked. My children had good grades in school, they were often chosen for character recognition, and the teachers would give me good reports regarding their progress. However, when I assessed their skills at home, I realized that they were not where they should be.I worked really hard with my children for the remainder of that year and throughout the summer. When it came time for the 2020-2021 school year to begin, the district put strict Covid rules in place that I believed would further disable my children from learning properly, so I kept them home and they have been home ever since. My children are now above grade level in all of their subjects. This past year, my oldest child entered seventh grade. He was devastated when he learned he would not be able to play with his football team of three years. Up until this point, he was able to play on the local youth league, but starting in seventh grade, it all changes to being exclusively part of the public school. We were originally told by someone in the district that he could play if he took two in-seat classes, but when we went to enroll, we were told that the person who gave us the information was mistaken. That rule only applies to the High School, and not all High Schools allow it. It was painful to watch my son be forced to sit out a season. It is very unfair that he is being penalized. We took him out of public school because we feel the school was not teaching him in a way that he can learn. We have sacrificed our time, energy, and finances to teach him ourselves. We are homeowners, landowners, and law abiding citizens. We are teaching our children the importance of education, morals, and being good neighbors. We believe that we should be able to participate in the extracurricular activities that would further enhance our children's futures. Further, our schools would be enriched by including homeschool children. My kids are not only phenomenal human beings, they are also excellent athletes. Please vote yes on SB 411.

My name is Rebecca Kammer and I live in O'Fallon, Missouri, I am asking you to support SB 411, which would give homeschool students access to public school sports and activities through our local public schools. This affects my family because we homeschool our four children in the Fort Zumwalt school district. Though we do have access to sports outside of the schools, it is not cost effective for my children to be a part of private club sports teams. I pay taxes to my school district and my children should have access to the sports teams, provided they try out and are good enough to play for the teams. However, or so district refuses to host homeschoolers in any capacity. But, more importantly than sports are the academic clubs. I am not sure if you are aware, but many of the academic clubs. like the Technology Student Association, which hosts STEM-related competitions on the state and national level, are only accessible through public schools. Though we have plenty of competitive homeschool sports teams in the greater St. Louis area, the National TSA will not allow homeschoolers or a coop of homeschoolers, to charter a TSA chapter of their own; even if we are willing to privately foot the bill. They will only allow homeschoolers to compete in the STEM competitions if their public school district allows them to join their school's TSA chapter. Though there are school districts in Missouri that are already welcoming homeschoolers, my school district of Fort Zumwalt has historically refused. This leaves my children unable to experience many of the academic clubs that enrich the educational experience and help prepare our kids for future carreers dealing with leadership, science, engineering, etc.. It is not just the TSA, but also clubs like the FBLA, FFA, FCCLA, DECCA, etc...are all clubs that homeschool children are excluded from because you can only join through a public school chapter and they offer valuable life-experience to prep kids for futures in those areas of interest.By passing this bill, you would help homeschoolers gain access to the important extracurriculars that our families do support with real estate taxes and would help strengthen our communities by encouraging the public school kids and the homeschool kids to come together in the areas outside of academics. I have no doubt that the public schooled kids and the homeschooled kids have a lot to offer each other in learning and relationships through extracurriculars that they are allowed to join together for.And with so much uncertainty surrounding public schools (who often have pockets of teachers pushing agendas) and safety, bullying, intense push for screen-time and social media use, etc., homeschooling is growing in our area. Our community would be better served if the public school districts would allow homeschoolers to join for extracurriculars; unfortunately, my children live in a school district where they will not do so unless they are required too. Families should have the freedom to choose a homeschooling environment for their kids and not be excluded from the opportunities that can only come by being connected to the district we still financially support. My name is Danielle Dent-Breen. I am the president of Kansas City Homeschool Connection, a 501(c)3 oraganization in the greater Kanasas City metro area, representing approximately 475 homeschool families. I am here to speak personally and on the behalf our membership, as we are strongly opposed to this legislation. As a homeschooling parent in the state of Missouri, I am extremely troubled by the creation of a second homeschool option for Missouri families. These "Flex" families will still be required to keep the entirety of the MO homeschool statute. They will, in every way, still be homeschooling families, only with extra regulations above and beyond those that are already established by the homeschool statute. I am incredibly opposed to the idea of the MO Scholars program money being given to homeschool families. The regulations imposed within this program that apply only to homeschool families are unjust and a complete overreach of regulation. Families who choose to participate in the Mo Scholars prorgam \*or\* in the MSHAA activities as outlined in this bill will be duped into accepting the "carrot on the stick" in exchange for the promise of a few bucks or "free" high school sports and clubs. Ultimately, the creation of a second tier of homeschooling in Missouri will be bad for all homeschooling families. With increased regulation of "flex" schoolers will come the eventual call for increased regulation on all homeschoolers across the state. This has been played out numerous times across the nation. Those in charge of the program are definitely not allies of family-based Christian home education. Homeschool parents in the State of Missouri neither ask permission from, nor report to, the State. As a former high school Business and Marketing teacher and FBLA Advisor I am concerned of how students not involved in Business or Marketing coursework without attending school could actively participate in FBLA or DECA. Another aspect of Business and Marketing courses is Supervised Business Experience course, where the Business or Marketing teaching is the work-based learning supervisor and supervises students as they gain real-world skills while working in a business or marketing career. My concern also extends to student safety and classroom inclusion efforts as allowing students not attending school to participate in CTSO could create a safety issue for the teacher and/or active students in the CTSO. It seems obvious that the student choosing to attend the FLEX school or virtual school should be allowed to participate in the extra curricular activities and/or CTSO's offered by the FLEX or virtual school. I would like to see language that addresses the instructional areas of Career and Tech education where seated time in the classroom is an integral part and often required portion of participation in Career and Technical Student Organizations. As an Agriculture Instructor and Future Farmers of America (FFA) Advisor in Cass County, Missouri, I have concerns with allowing homeschool or FLEX students to participate in some FFA activities that require safety training. Through FFA, students have the opportunity to perform hands on activities in agricultural mechanics, livestock management, horticulture, etc... Before students have to do these activities in FFA, all students take rigorous safety tests and perform these activities in front of a certified teacher who has had training in agriculture safety. Students who wish to participate in homeschooling or FLEX education may or may not receive quality safety instruction which may or may not put themselves and others in danger during an FFA activity. Through our local FFA Chapter, we have taken many students on field trips to local farms and agribusinesses. However, before we take these field trips, we ensure students understand the dangers and how to act safely around these farms and agribusinesses. Without classroom instruction, a homeschool or FLEX student may not get as thorough explanation and training as they need. Additionally, in some FFA activities, students have to use Arc Welders, MiG Welders, an Oxy-Acetylene Torch. As a teacher, I want to personally instruct students how to use these safely. I don't want to have to wonder if the video they watched goes through all the safety precautions the student needs. I feel my 20 years of educational experience in the agriculture classroom and laboratory is invaluable in safely training students. Personally, I have taught many homeschool and FLEX students who wish to be FFA members. They enroll in an Agriculture course at our local school for 1-3 periods of the day. This qualifies them for FFA activities and allows them to receive the necessary safety training. The remainder of the day, the student completes other coursework at home virtually or through homeschooling. I strongly feel FFA is a intra-curricular program with necessary training and study occurring in the classroom. I would imagine all my colleagues in Career and Technical Education would also feel the same way about other Career and Technical Student Organizations: SkillsUSA, DECA, Educator's Rising, HOSA. Thank you for your time and thoughtful consideration of the potential impacts this bill could have on all students.

My opposition comes from the portion of the bill where it states "homeschool or FLEX students cannot be prohibited from participating in ANY school activities". I would like to see language that addresses the instructional areas of Career and Technical Education (CTE) where seated time in those areas is an integral and often required portion of participation in Career and Technical Student Organizations (CTSOs). Classroom instruction is part of the integral curriculum that aligns students with membership in the in CTSOs. By not attending class and not receiving seated instruction, the students would not have the knowledge needed for successful membership of the CTSO program. Curriculum taught in class is expanded on through involvement in CTSO events and activities. Due to the nature of the intra-curricular instruction, students must be present during the class period to learn prior to participating in competitions and Leadership events. CTSOs are not extra-curricular. Instead, they are extensions of knowledge attained during class time and enhanced through active learning in the classroom and CTSO involvement. I would like to see an exemption for CTSO organizations due to the dynamic nature of the classroom instruction combined with CTSO membership. An addition of such language would eliminate any misinterpretation of the bill therefore eliminating my concerns. Many school activities are co- or inter-curricular, which means they extend classroom learning experiences. Some examples of these activities are Career and Technical Student Organizations, or CTSOs. These activities have curricular requirements, meaning specific coursework is required before any student in the school is eligible for membership. Allowing students without this curriculum to participate puts the student at a disadvantage and creates an atmosphere that is detrimental to student success. Additionally, allowing someone without the coursework to participate when students attending that school are required to complete coursework creates a disadvantage to the students following nationwide, established participation requirements. I would like to see an exemption for CTSO organizations due to the relationship of the classroom instruction to membership in a CTSO.
