Missouri, like much of the country, is experiencing a shortage of highly qualified teachers. Low salaries and even lower morale are causing teachers to leave the field for better career opportunities. This bill will certainly drive even more teachers out of Missouri.

The Jewish Community Relations Council (JCRC), guided by Jewish values, advocates, educates, collaborates, and mobilizes action on issues important to the Jewish community, 60,000 strong in St. Louis. We are committed to pursuing religious tolerance, civic discourse and social justice in St. Louis and beyond. Jewish tradition teaches about the act of t'shuvah, or making amends. When we begin the process of repentance, there are five steps we are required to make in order to successfully achieve the process, including the act of "desisting from sin." But in order to desist from sin, we must be knowledgeable about the issue, how it began and why it was a problem. If we stop teaching our children the sins of our past, how will we prevent those sins from occurring in the future? There are some things about history on which we can all agree. Two examples: slavery was a horrific part of our nation's history and that no one could fathom it happening again; and the Holocaust was devastating and also difficult to comprehend how something like that could happen. How do we ensure that horrors like the Holocaust, are not repeated? By educating the next generation. We tell the stories of the efforts by a few in power to systemically dehumanize one group, the Jews of Germany. We describe how the government stripped this group of their rights, then removed them from their homes, inhumanly transported them to concentration camps and killed, starved or worked 6 million or more people to death. We repeat the rally cry, Never Again. And we ensure that the stories are never forgotten so that they are never repeated. And there are stories of our American history that we want never to be repeated. In the 1800's, as part of the U.S. belief in Manifest Destiny, our government removed native american peoples from their lands, marched them inhumanly to far away reservations - away from their own lands and traditions. During WWII, the U.S. gathered its own citizens of Japanese American origins, and placed them in internment camps for the duration of the war, ruining lives, reputations and never providing restitution. And then there were the race riots that occurred on either side of our state - in East St. Louis, IL and in Tulsa, OK, where entire black communities were burned to the ground. SB 4 creates the requirements to develop training to teach principles of American civics and Patriotism. So what if a parent disagrees with a specific aspect of history or objects to the way history is taught, or if they view that history as unpatriotic? How do we teach comprehensive history without talking about times when our country missed the mark? I love this country. The premise of religious freedom, enshrined in our founding document, has enabled the Jewish people to live and thrive in the United state for nearly 400 years. When I learned about the Trail of Tears, the intentional slaughter of the buffalo, the rise of Jim Crow laws, the intentional displacement of US Citzens into camps, race riots, lynching, and I could go on, I do feel discomfort. Not because of my race or sex or my religion, but because I am a human being. It is only through a full accounting of our American History, and our faith in our children to be critical thinkers, that they can understand the past and stand up and say Never Again.

This bill goes against everything that the Missouri Republican Party says they stand for, which is small government. This bill in its current state would expand the role of government exponentially and here is why: if you are going to have a legal precedent, you are going to need to have parameters that the law pertains to. If you are going to say in this law that a man cannot wear women's clothes, you are going to need legally define what a man is, which means you are going to need to legally define how long a man's genetalia has to be for someone to be legally considered a man under this law. Intersex people exist, it is impossible to eliminate them from this law. If, for example, the Senator from St Charles County wanted to go to Comic-Con or a cosplay convention as Joan of Arc or Lara Croft (for example), is he going to be arrested for wearing women's clothing just because he loved the character and wanted to express himself? I stand in opposition to Senator Koenig's SB4 on the ground that it is a blatant effort to introduce conservative biases into the public Missouri classroom, to bully our excellent and beleaguered local educators into promoting said conservative worldview, to sacrifice both the truth and the history of many marginalized populations at the altar of conservative comfort. and to provide the children of this great state with a patently inferior education in order to placate regressive, overbearing parents who would rather see diversity stamped out entirely than be challenged on their views. The text of Senator Koenia's bill makes it clear that he aims to impose upon all Missouri students an untrue, revisionist version of the world. Rather than challenging themselves to confront hard truths and listen to folks whose voices are traditionally silenced, people like the Senator would rather see racism, oppression and genocide simply be ignored in our schools. They seek to blindly promote an ignorant worldview of "colorblindness" that disadvantages all Americans, but most of all people of color who have already suffered under racism. It is disgusting that Senator Koenig would look to erase the historic oppression of so many Missourians. Does the Senator believe that the historic difficulties faced by nonwhite Missourians don't matter? Does he think the comfort of avoidant, overbearing and reactionary parents like him is more important than their history? He would likely tell us all that he does not feel this way, but his submission of SB4 proves otherwise.Our state in particular maintains a shameful, complex racial history that all of our students must explore in order to be upstanding, justice-minded citizens of our democracy. I am proud to say that I was first able to explore the American history of racism through the hard work of some excellent Missouri educators, first during my time at Hickman High School and later at the University of Missouri. I was never shamed, or pitted against my fellow students; I was merely given (and took) a chance to learn from the words and histories of people who do not look like me or experience the world the way I do. I believe I came out the other side of that experience a more empathetic, effective citizen with the skills and understanding to fight oppression anywhere I may find it in this great country. My only wish is that I had been given an opportunity to see this information earlier in my time as a student, and I am appalled to see that some in our Senate aim instead to remove these opportunities from our students entirely. I find it demeaning, as a white man, that Senator Koenig seems all of us are as weak, coddled and spineless as he is. The wonderful young people of our public education system are more than capable of learning about and understanding their role in combating racism, and they certainly don't need to be protected from these truths with lies and erasure. I find it so ironic that Senator Koenig also seeks to use this bill as a means of ramming more "patriotism and civics training" onto our students and educators while actively removing such a central part of the American experience for so many from the toolkits of our state educators. What kind of civic-minded individual would choose to look away from the oppression of their fellow citizens instead of working to eradicate it? Clearly Senator Koenig, but I

like to think most Missourians are bolder in spirit than that.And given the Missouri Republican Party's fondness for targeting our educators with abuse and scorn at even the slightest hint that they might use their lessons to acknowledge racism, I can only suspect that this poorly-defined "registry" of "accountability report cards" will be used to terrorize our educators. This will invariably drive more of them out of the state, out of the field of education, and perhaps most tragically, out of our children's lives and classrooms. And all because the Senator and his constituents are scared to acknowledge racism. Our state can do so much more than this. Our students are so much smarter than this. And our citizens of color deserve so, so much better than this. I hope any legislator that reads this can find it in their heart to recognize the atrocity being committed here and that they will be compelled to fight the passage of SB4 with their whole heart.Shame on you, Senator Koenig.

It is hurtful to children, SB 4 establishes prescriptions for a parent's right to review district resources, curriculum, books, financial statement, names of presenters, salaries, school board member information, accountability report cards and more. ALL of these are currently accessible to parents in Missouri. SB 4 places restrictions on uses of electronic devices. These are safeguards already written in Acceptable Use policies and protection through internet filters which notifies administrators immediately of misuse, "language," or situations about to occur. SB 4 begins by portraying a perception of mistrust and disrespect for professionals and establishing a parents right to complain about many potential, grey, subjective actions by a teacher. Why not begin with the positive, trusting position. A PARENT HAD A CONCERN, RAISED IT, REPORTED IT. Are there data to support the need cite rights that parents already have? Are there cases of teachers professing a position of superiority or instilling guilt regarding a person's race, ethnicity, color, or national origin?OR IS THIS A "BUT-IT-COULD-HAPPEN TACTIC? Teachers leave their politics at the door. We want students to "figure it out" when positions on issues come up. If they do not, there are means to complain. The language of this bill will silence teachers. Have you seen the staggering teacher exodus in Florida? This bill states "No school or school employee shall compel teachers to teach a position regarding statements of inferiority, collective guilt, or treated advantageously based on race, ethnicity, color, or national origin. There are many items I have concerns with in this bill. One of the main concerns I have is the increase of power and oversite by DESE and the lack of local control. School districts are locally controlled. Page 5, the creation of an advisory group to review local schools and monitor the report cards will create an increase of DESE's power over local school districts. This violates the Constitutional principle of limited government. Page 10, 161.852, the posting of every school's curriculum, materials and syllabi. Yet again, increasing DESE's power. The intent is to monitor what is being taught. However, we know from history that once government is given authority to monitor what is being taught the next step is to dictate what we will teach. This opens a door to standard curriculum that will be government controlled. Page 14, DESE hiring a third party to assist in the uploading of information into the portal that is to contain so much information about each district that it will be a challenge for many schools to comply to the requirements. This is another expansion of government, enlarging DESE (a department many of you say should be eliminated, yet you are increasing its powers) and expanding DESE's budget. Yet again, a violation of limited government and fiscal responsibility. The Report Card is an issue. I believe schools should be accountable to the local community. The information in the report card is intrusive. One of my main concerns is the recording of suspensions/expulsions or any discipline item on a report card. The main concern is when discipline is used to determine a school's effectiveness (funding, AYP, etc) then the districts that discipline their students will have a negative report card and the districts that do not discipline will have a positive report card. This will encourage schools to refrain from suspending students (this is used as a last resort) thus leading to a lack of discipline and increase trauma for staff and students in these districts. Therefore the data will be skewed/taken out of context. We have already seen this happen in schools across the state as a result of the seclusion and restraint bill that was passed last year. My last concern is the on page 30, the lawsuit. Why are parents being encouraged to sue the district through DESE? Increase of DESE's power, yet again. Why are parents not being encouraged to resolve conflicts/concerns with the local district. Contact the administration with concerns first. Then look to other methods to resolve issues. All issues should be local. There are no provisions in the bill to prevent from frivolous lawsuits. I foresee massive lawsuits and districts having to use precious resources to protect themselves legally. This will cause many responsible educators to leave the profession. Is this really the plan? Time to rethink this issue. When your solution to the problem is increase of government spending and power then you have the wrong solution. Go back to the Constitution, limited government, local control.

In general, Missouri's schools invite parental involvement and work cooperatively with students and their families to meet the needs of each learner to help them succeed.1. Amendments which may be considered, which would require permission slips from parents for students to attend school assemblies may be logistically challenging, overburdening an already stressed system. As written, this legislation could apply to any assembly, including school "pep" assemblies before a game, school concert assemblies, school award assemblies and any gathering of any group which might be labeled an "assembly." If the intent is to protect from "outside entities" perhaps that should be clarified. 2. prohibitions on the collection of biometric data - might extend to audio recordings of a student's changing voice and analysis of the student's vocal range and pitch frequencies. 3. there are several areas of the pending legislation which appear to not be clearly defined, or the means for determining compliance is unclear.4. the directive to prominently post curricular information for a large number of subjects on a website's "home" page offers a number of challenges, such as determining the level of prominence with a large quantity of information to publish.5.
