I oppose Senate Concurrent Resolution 4. I testified against the resolution when it was heard in the Senate. It is a strange and unnecessary thing for the State of Missouri to commend a foreign nation state and make a statement on what is and is not the capitol of that foreign nation state. It is inaccurate history to claim that a modern nation state founded in 1948 is actually the continuation of a biblical entity that existed and ceased to exist long before our modern conception of a nation state came into being.Israel is an Apartheid State. This has been shown to be the case and well documented by the most respected human rights organizations on earth - Amnesty International and Human Rights Watch, as well as Israel's own B'Tselem. In practice this means that Jews in Israel have more rights than Palestinians, based on their religion and ethnicity. It is an explicitly racist state. It's recently elected government is the most explicitly racist in its history. To give one important example, its present Minister of National Security Itamar Ben-Gvir comes from the extremist racist Kahnist movement, for years designated by the United States State Department as a Foreign Terrorist Organization. He has been convicted in Israel of exciting terrorism and has advocated for the expulsion of Palestinians from Israel for being Palestinian and existing. Ben-Gvir made threatening statements about former Israeli Prime Minister Yitzhak Rabin just a few weeks before Rabin was assassinated by Yigdal Amir, who presently in prison receives support from Ben-Gvir's top advisor. This week the State of Israel raided the ancient city of Nablus, killing multiple Palestinian people through indiscriminate gunfire. This is part of a process of Jewish colonization of Palestinian land in the occupied West Bank that began in
