5 said lines and inserting in lieu thereof the following:

7 "483.083. 1. Each circuit clerk shall annually receive as compensation the following  
8 amounts as base salary:

9 (1) In counties of the first classification, thirty-six thousand one hundred forty-five dollars;  
10 beginning January 1, 2026, eighty-nine thousand sixty dollars; and beginning January 1, 2027,  
11 ninety-one thousand five hundred sixty dollars. Except in those counties where court is held in two  
12 cities, in which instance an additional four thousand dollars shall be added to the base salary;

13 (2) In all counties of the second or fourth classification, thirty-one thousand nine hundred  
14 seventy-eight dollars; beginning January 1, 2026, eighty-three thousand seventy-five dollars; and  
15 beginning January 1, 2027, eighty-eight thousand seventy-five dollar. Except in those counties  
16 where court is held in two cities, [~~thirty-five thousand five hundred forty-nine~~] in which instance an  
17 additional six thousand dollars shall be added to the base salary;

18 (3) In the counties of the third classification, twenty-seven thousand two hundred eighteen  
19 dollars; beginning January 1, 2026, seventy-five thousand eight hundred seventy-six dollars; and  
20 beginning January 1, 2027, eighty-three thousand three hundred seventy-six dollars. Except in those  
21 counties where court is held in two cities; [~~thirty thousand three hundred eight dollars; except~~  
22 ~~Marion County circuit clerks, district one and district two in Hannibal, thirty-one thousand three~~  
23 ~~hundred eighty-three~~], in which instance an additional four thousand dollars shall be added to the  
24 base salary;

25 (4) In the city of St. Louis, sixty-seven thousand three hundred sixty dollars;

26 (5) The compensation of circuit clerks provided by this subsection shall annually be  
27 increased by an amount equivalent to the annual salary adjustment approved pursuant to section  
28 476.405 for employees of the judicial department.

29 2. [~~Such circuit clerks shall receive in addition to any salary provided by this section any~~  
30 ~~salary adjustment provided pursuant to section 476.405]~~ The annual salary for a county  
31 classification under subsection 1 of this section shall not be decreased to comply with the provisions  
32 this section.

33 3. In the event the judge orders child support payments in Marion County to be made  
34 through the clerk, the clerk shall annually, on or before February first of each year, charge ten
