1 AMEND House Committee Substitute for Senate Substitute for Senate Bill No. 900, Page 8, Section
2 221.523, Line 20, by inserting after all of said section and line the following:
3

4 "332.081. 1. Notwithstanding any other provision of law to the contrary, hospitals licensed
5 under chapter 197 shall be authorized to employ any or all of the following oral health providers:

6 (1) A dentist licensed under this chapter for the purpose of treating on hospital premises
7 those patients who present with a dental condition and such treatment is necessary to ameliorate the
8 condition for which they presented such as severe pain or tooth abscesses;

9 (2) An oral and maxillofacial surgeon licensed under this chapter for the purpose of treating
10 oral conditions that need to be ameliorated as part of treating the underlying cause of the patient's
11 medical needs including, but not limited to, head and neck cancer, HIV or AIDS, severe trauma
12 resulting in admission to the hospital, organ transplant, diabetes, or seizure disorders. It shall be a
13 condition of treatment that such patients are admitted to the hospital on either an in- or out-patient
14 basis; and

15 (3) A maxillofacial prosthodontist licensed under this chapter for the purpose of treating and
16 supporting patients of a head and neck cancer team or other complex care or surgical team for the
17 fabrication of appliances following ablative surgery, surgery to correct birth anomalies, extensive
18 radiation treatment of the head or neck, or trauma-related surgery.

19 2. No person or other entity shall practice dentistry in Missouri or provide dental services as
20 defined in section 332.071 unless and until the board has issued to the person a certificate certifying
21 that the person has been duly registered as a dentist in Missouri or the board has issued such
22 certificate to an entity that has been duly registered to provide dental services by licensed dentists
23 and dental hygienists and unless and until the board has issued to the person a license, to be renewed
24 each period, as provided in this chapter, to practice dentistry or as a dental hygienist, or has issued to
25 the person or entity a permit, to be renewed each period, to provide dental services in Missouri.

26 Nothing in this chapter shall be so construed as to make it unlawful for:

27 (1) A legally qualified physician or surgeon, who does not practice dentistry as a specialty,
28 from extracting teeth;

29 (2) A dentist licensed in a state other than Missouri from making a clinical demonstration
30 before a meeting of dentists in Missouri;

1 (3) Dental students in any accredited dental school to practice dentistry under the personal
2 direction of instructors;

3 (4) Dental hygiene students in any accredited dental hygiene school to practice dental
4 hygiene under the personal direction of instructors;

5 (5) A duly registered and licensed dental hygienist in Missouri to practice dental hygiene as
6 defined in section 332.091;

7 (6) A dental assistant, certified dental assistant, or expanded functions dental assistant to be
8 delegated duties as defined in section 332.093;

9 (7) A duly registered dentist or dental hygienist to teach in an accredited dental or dental
10 hygiene school;

11 (8) A person who has been granted a dental faculty permit under section 332.183 to practice
12 dentistry in the scope of his or her employment at an accredited dental school, college, or program
13 in Missouri;

14 (9) A duly qualified anesthesiologist or nurse anesthetist to administer an anesthetic in
15 connection with dental services or dental surgery;

16 (10) A person to practice dentistry in or for:

17 (a) The United States Armed Forces;

18 (b) The United States Public Health Service;

19 (c) Migrant, community, or health care for the homeless health centers provided in Section
20 330 of the Public Health Service Act (42 U.S.C. Section 254b);

21 (d) Federally qualified health centers as defined in Section 1905(l) (42 U.S.C. Section
22 1396d(l)) of the Social Security Act;

23 (e) Governmental entities, including county health departments; or

24 (f) The United States Veterans Bureau; or

25 (11) A dentist licensed in a state other than Missouri to evaluate a patient or render an oral,
26 written, or otherwise documented dental opinion when providing testimony or records for the
27 purpose of a civil or criminal action before any judicial or administrative proceeding of this state or
28 other forum in this state.

29 3. No corporation shall practice dentistry as defined in section 332.071 unless that
30 corporation is organized under the provisions of chapter 355 or 356 provided that a corporation
31 organized under the provisions of chapter 355 and qualifying as an organization under 26 U.S.C.
32 Section 501(c)(3) may only employ dentists and dental hygienists licensed in this state to render
33 dental services to Medicaid recipients, low-income individuals who have available income below
34 two hundred percent of the federal poverty level, and all participants in the SCHIP program, unless
35 such limitation is contrary to or inconsistent with federal or state law or regulation. This subsection
36 shall not apply to:

37 (1) A hospital licensed under chapter 197 that provides care and treatment only to children
38 under the age of eighteen at which a person regulated under this chapter provides dental care within
39 the scope of his or her license or registration;

1 (2) A federally qualified health center as defined in Section 1905(l) of the Social Security
 2 Act (42 U.S.C. Section 1396d(l)), or a migrant, community, or health care for the homeless health
 3 center provided for in Section 330 of the Public Health Services Act (42 U.S.C. Section 254b) at
 4 which a person regulated under this chapter provides dental care within the scope of his or her
 5 license or registration;

6 (3) A city or county health department organized under chapter 192 or chapter 205 at which
 7 a person regulated under this chapter provides dental care within the scope of his or her license or
 8 registration;

9 (4) A social welfare board organized under section 205.770, a city health department
 10 operating under a city charter, or a city-county health department at which a person regulated under
 11 this chapter provides dental care within the scope of his or her license or registration;

12 (5) Any entity that has received a permit from the dental board and does not receive
 13 compensation from the patient or from any third party on the patient's behalf at which a person
 14 regulated under this chapter provides dental care within the scope of his or her license or
 15 registration;

16 (6) Any hospital nonprofit corporation exempt from taxation under Section 501(c)(3) of the
 17 Internal Revenue Code, as amended, that engages in its operations and provides dental services at
 18 facilities owned by a city, county, or other political subdivision of the state, or any entity contracted
 19 with the state to provide care in a correctional center, as such term is defined in section 217.010, at
 20 which a person regulated under this chapter provides dental care within the scope of his or her
 21 license or registration.

 23 If any of the entities exempted from the requirements of this subsection are unable to provide
 24 services to a patient due to the lack of a qualified provider and a referral to another entity is made,
 25 the exemption shall extend to the person or entity that subsequently provides services to the patient.

26 4. No unincorporated organization shall practice dentistry as defined in section 332.071
 27 unless such organization is exempt from federal taxation under Section 501(c)(3) of the Internal
 28 Revenue Code of 1986, as amended, and provides dental treatment without compensation from the
 29 patient or any third party on their behalf as a part of a broader program of social services including
 30 food distribution. Nothing in this chapter shall prohibit organizations under this subsection from
 31 employing any person regulated by this chapter.

32 5. A dentist shall not enter into a contract that allows a person who is not a dentist to
 33 influence or interfere with the exercise of the dentist's independent professional judgment.

34 6. A not-for-profit corporation organized under the provisions of chapter 355 and qualifying
 35 as an organization under 26 U.S.C. Section 501(c)(3), an unincorporated organization operating
 36 pursuant to subsection 4 of this section, or any other person should not direct or interfere or attempt
 37 to direct or interfere with a licensed dentist's professional judgment and competent practice of
 38 dentistry. Nothing in this subsection shall be so construed as to make it unlawful for not-for-profit

1 organizations to enforce employment contracts, corporate policy and procedure manuals, or quality
2 improvement or assurance requirements.

3 7. All entities defined in subsection 3 of this section and those exempted under subsection 4
4 of this section shall apply for a permit to employ dentists and dental hygienists licensed in this state
5 to render dental services, and the entity shall apply for the permit in writing on forms provided by
6 the Missouri dental board. The board shall not charge a fee of any kind for the issuance or renewal
7 of such permit. The provisions of this subsection shall not apply to a federally qualified health
8 center as defined in Section 1905(l) of the Social Security Act (42 U.S.C. Section 1396d(l)).

9 8. Any entity that obtains a permit to render dental services in this state is subject to
10 discipline pursuant to section 332.321. If the board concludes that the person or entity has
11 committed an act or is engaging in a course of conduct that would be grounds for disciplinary
12 action, the board may file a complaint before the administrative hearing commission. The board
13 may refuse to issue or renew the permit of any entity for one or any combination of causes stated in
14 subsection 2 of section 332.321. The board shall notify the applicant in writing of the reasons for
15 the refusal and shall advise the applicant of his or her right to file a complaint with the
16 administrative hearing commission as provided by chapter 621.

17 9. A federally qualified health center as defined in Section 1905(l) of the Social Security
18 Act (42 U.S.C. Section 1396d(l)) shall register with the board. The information provided to the
19 board as part of the registration shall include the name of the health center, the nonprofit status of
20 the health center, sites where dental services will be provided, and the names of all persons
21 employed by, or contracting with, the health center who are required to hold a license pursuant to
22 this chapter. The registration shall be renewed every twenty-four months. The board shall not
23 charge a fee of any kind for the issuance or renewal of the registration. The registration of the
24 health center shall not be subject to discipline pursuant to section 332.321. Nothing in this
25 subsection shall prohibit disciplinary action against a licensee of this chapter who is employed by, or
26 contracts with, such health center for the actions of the licensee in connection with such
27 employment or contract.

28 10. The board may promulgate rules and regulations to ensure not-for-profit corporations
29 are rendering care to the patient populations as set forth herein, including requirements for covered
30 not-for-profit corporations to report patient census data to the board. The provisions of this
31 subsection shall not apply to a federally qualified health center as defined in Section 1905(l) of the
32 Social Security Act (42 U.S.C. Section 1396d(l)).

33 11. All not-for-profit corporations organized or operated pursuant to the provisions of
34 chapter 355 and qualifying as an organization under 26 U.S.C. Section 501(c)(3), or the
35 requirements relating to migrant, community, or health care for the homeless health centers provided
36 in Section 330 of the Public Health Service Act (42 U.S.C. Section 254b) and federally qualified
37 health centers as defined in Section 1905(l) (42 U.S.C. Section 1396d(l)) of the Social Security Act,
38 that employ persons who practice dentistry or dental hygiene in this state shall do so in accordance

1 with the relevant laws of this state except to the extent that such laws are contrary to, or inconsistent
2 with, federal statute or regulation."; and

4 Further amend said bill by amending the title, enacting clause, and intersectional references
5 accordingly.
