2 inserting after said section and line the following:

4 "64.009. 1. As used in this section, the following terms mean:

5 (1) "Federal firearms licensee", a person who is duly licensed by the federal Bureau of
6 Alcohol, Tobacco, Firearms, and Explosives under 18 U.S.C. Section 923, as amended;

7 (2) "Firearms business", a person engaged in the business of importing, manufacturing,
8 selling, shipping, receiving, or dealing in federally regulated firearms, ammunition, or destructive
9 devices, as such terms are defined in 18 U.S.C. Section 921, as amended;

10 (3) "Person", any of the following:

11 (a) An individual who is twenty-one years of age or older;

12 (b) A company, association, organization, partnership, business trust, or corporation; or

13 (c) Any other form of legal entity.

14 2. No county or board or commission thereof shall grant a license to a federal firearms
15 licensee to establish or operate a firearms business within one thousand feet of any of the following
16 entities in existence on and after August 28, 2024:

17 (1) A charter school, as defined in section 160.400;

18 (2) A child care facility, as defined in section 210.201;

19 (3) A parochial school;

20 (4) A private school, as defined in section 166.700;

21 (5) A public school, as defined in section 160.011; or

22 (6) A religious organization, as defined in section 210.201.

23 3. For purposes of this section, measurements shall be made in a straight line, without
24 regard to intervening structures or objects, from the closest portion of the real property parcel
25 containing the firearms business to the closest portion of the real property parcel containing the
26 child care facility, parochial school, private school, public school, or religious organization.

27 4. This section shall not apply to any firearms business lawfully established before August

9 devices, as such terms are defined in 18 U.S.C. Section 921, as amended;

10 (3) "Municipality", a city, town, or village that is incorporated in accordance with the laws
11 of this state;

14 (b) A company, association, organization, partnership, business trust, or corporation; or

15 (c) Any other form of legal entity.

16 2. No municipality or board, council, or commission thereof shall grant a license to a federal
