1 AMEND House Amendment No. _____ to House Committee Substitute for House Bill No. 2058,
2 Page 1, Line 1, by deleting the words "Pages 2-6, Section 67.1421, Lines" and inserting in lieu
3 thereof the following:

5 "Page 2, Section 67.007, Line 20, by inserting the following after all of said line:

7 "67.1013. 1. The governing body of any city with more than ten thousand but fewer than
8 eleven thousand inhabitants and that is the county seat of a county with more than one hundred
9 thousand but fewer than one hundred twenty thousand inhabitants may impose a tax as provided in
10 this section.

11 2. The governing body of any city described in subsection 1 of this section may impose a
12 tax on the charges for all sleeping rooms paid by the transient guests of hotels or motels situated in
13 the city or a portion thereof, which shall be not more than six percent per occupied room per night.
14 Such tax shall not become effective unless the governing body of the city submits to the voters of
15 the city at a state, municipal, general or primary election a proposal to authorize the governing body
16 of the city to impose the tax under this section. The tax authorized by this section shall be in
17 addition to the charge for the sleeping room and shall be in addition to any and all other taxes. Such
18 tax shall be stated separately from all other charges and taxes.

19 3. (1) The question submitted for the tax authorized in this section shall be in substantially
20 the following form: "Shall _____ (insert city name) impose a tax on the charges for all sleeping
21 rooms paid by the transient guests of hotels and motels situated in _____ (insert city name) at a
22 rate of _____ (insert percentage) percent?".

23 (2) If a majority of the votes cast on the question by the qualified voters voting thereon are
24 in favor of the question, the tax shall become effective on the first day of the second calendar
25 quarter following the calendar quarter in which the election was held. If a majority of the votes cast
26 on the question by the qualified voters voting thereon are opposed to the question, the tax shall not
27 become effective unless and until the question is resubmitted under this section to the qualified
28 voters of the city and such question is approved by a majority of the qualified voters of the city
29 voting on the question.
