 care providers shall be fully licensed to practice in this state and shall be subject to regulation by
 their respective professional boards.

4. Nothing in subsection 3 of this section shall apply to:

5 (1) Informal consultation performed by a health care provider licensed in another state, 6 outside of the context of a contractual relationship, and on an irregular or infrequent basis without 7 the expectation or exchange of direct or indirect compensation;

8 (2) Furnishing of health care services by a health care provider licensed and located in 9 another state in case of an emergency or disaster; provided that, no charge is made for the medical 10 assistance; or

(3) Episodic consultation by a health care provider licensed and located in another state who
 provides such consultation services on request to a physician in this state.

5. Nothing in this section shall be construed to alter the scope of practice of any health care
provider or to authorize the delivery of health care services in a setting or in a manner not otherwise
