1 AMEND House Committee Substitute for House Bill No. 2413, Page 2, Section 192.2521, Line 5,  
2 by inserting after all of said section and line the following:

4 "205.160. The county commissions of the several counties of this state, both within and  
5 outside such counties, except in counties of the third or fourth classification (other than the county  
6 in which the hospital is located) where there already exists a hospital organized pursuant to  
7 [~~chapters 96,~~ chapter 205 ~~or 206~~]; provided, however, that this exception shall not prohibit the  
8 continuation of existing activities otherwise allowed by law, are hereby authorized, as provided in  
9 sections 205.160 to 205.340, to establish, construct, equip, improve, extend, repair and maintain  
10 public hospitals and engage in health care activities, and may issue bonds therefor as authorized by  
11 the general law governing the incurring of indebtedness by counties.

12 205.190. 1. The trustees shall, within ten days after their appointment or election, qualify  
13 by taking the oath of civil officers and organize as a board of hospital trustees by the election of one  
14 of their number as chairman, one as secretary, one as treasurer, and by the election of such other  
15 officers as they may deem necessary.

16 2. No trustee shall receive any compensation for his or her services performed, but a trustee  
17 may receive reimbursement for any cash expenditures actually made for personal expenses incurred  
18 as such trustee, and an itemized statement of all such expenses and money paid out shall be made  
19 under oath by each of such trustees and filed with the secretary and allowed only by the affirmative  
20 vote of all of the trustees present at a meeting of the board.

21 3. The board of hospital trustees shall make and adopt such bylaws, rules and regulations for  
22 its own guidance and for the government of the hospital as may be deemed expedient for the  
23 economic and equitable conduct thereof, not inconsistent with sections 205.160 to 205.340 and the  
24 ordinances of the city or town wherein such public hospital is located. The board shall provide by  
25 regulation for the bonding of the chief executive officer and may require a bond of the treasurer of  
26 the board and of any employee of the hospital as it deems necessary. The costs of all bonds required  
27 shall be paid out of the hospital fund. Except as provided in subsection 4 of this section, it shall  
28 have the exclusive control of the deposit, investment, and expenditure of all moneys collected to the  
29 credit of the hospital fund, and of the purchase of site or sites, the purchase or construction of any  
30 hospital buildings, and of the supervision, care and custody of the grounds, rooms or buildings

1 purchased, constructed, leased or set apart for that purpose; provided, that all moneys received for  
2 such hospital shall be credited to the hospital and deposited into the depository thereof for the sole  
3 use of such hospital in accordance with the provisions of sections 205.160 to 205.340. All funds  
4 received by each such hospital shall be paid out only upon warrants ordered drawn by the treasurer  
5 of the board of trustees of said county upon the properly authenticated vouchers of the hospital  
6 board.

7 4. The trustees shall have authority, both within and outside the county, except in counties of  
8 the third or fourth classification (other than the county in which the hospital is located) where there  
9 already exists a hospital organized pursuant to [~~chapters 96,~~ chapter 205 ~~or 206~~]; provided that this  
10 exception shall not prohibit the continuation of existing activities otherwise allowed by law, to  
11 operate, maintain and manage a hospital and hospital facilities, and to make and enter into contracts,  
12 for the use, operation or management of a hospital or hospital facilities; to engage in health care  
13 activities; to make and enter into leases of equipment and real property, a hospital or hospital  
14 facilities, as lessor or lessee, regardless of the duration of such lease; provided that any lease of  
15 substantially all of the hospital, as the term "hospital" is defined in section 197.020, wherein the  
16 board of trustees is lessor shall be entered into only with the approval of the county commission  
17 wherein such hospital is located and provided that in a county of the second, third or fourth  
18 classification, the income to such county from such lease of substantially all of the hospital shall be  
19 appropriated to provide health care services in the county; and further to provide rules and  
20 regulations for the operation, management or use of a hospital or hospital facilities. Any agreement  
21 entered into pursuant to this subsection pertaining to the lease of the hospital, as herein defined,  
22 shall have a definite termination date as negotiated by the parties, but this shall not preclude the  
23 trustees from entering into a renewal of the agreement with the same or other parties pertaining to  
24 the same or other subjects upon such terms and conditions as the parties may agree.

25 Notwithstanding any other law to the contrary, the county commission in any noncharter county of  
26 the first classification wherein such hospital is located may separately negotiate and enter into  
27 contractual agreements with the lessee as a condition of approval of any lease authorized pursuant to  
28 this subsection.

29 5. The board of hospital trustees shall have power to appoint a suitable chief executive  
30 officer and necessary assistants and fix their compensation, and shall also have power to remove  
31 such appointees; and shall in general carry out the spirit and intent of sections 205.160 to 205.340 in  
32 establishing and maintaining a county public hospital.

33 6. The board of hospital trustees may establish and operate a day care center to provide care  
34 exclusively for the children of the hospital's employees. A day care center established by the board  
35 shall be licensed pursuant to the provisions of sections 210.201 to 210.245. The operation of a day  
36 care center shall be paid for by fees or charges, established by the board, and collected from the  
37 hospital employees who use its services. The board, however, is authorized to receive any private  
38 donations or grants from agencies of the federal government intended for the support of the day care  
39 center.

1           7. The board of hospital trustees shall hold meetings at least once each month, shall keep a  
2 complete record of all its proceedings; and three members of the board shall constitute a quorum for  
3 the transaction of business.

4           8. One of the trustees shall visit and examine the hospital at least twice each month and the  
5 board shall, during the first week in January of each year, file with the county commission of the  
6 county a report of its proceedings with reference to such hospital and a statement of all receipts and  
7 expenditures during the year; and shall at such time certify the amount necessary to maintain and  
8 improve the hospital for the ensuing year."; and

10 Further amend said bill by amending the title, enacting clause, and intersectional references  
11 accordingly.
