§§191.1720 - "Missouri Save Adolescents from Experimentation (SAFE) Act" and gender transition procedures

Officials from the Attorney General's Office, the Office of Administration - Administrative Hearing Commission, the Department of Commerce and Insurance, the Department of Elementary and Secondary Education, the Department of Social Services, the Missouri Department of Conservation, the Missouri Department of Transportation and the Missouri Consolidated Health Care Plan each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Department of Public Safety - Missouri Highway Patrol** defer to the Missouri Department of Transportation for the potential fiscal impact of this proposal.
