**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Office of Administration**, the **State Auditor’s Office**, the **State Treasurer’s Office**, the **House of Representatives**, the **Missouri Senate** and the **Office of the Secretary of State** each assume the proposal would not fiscally impact their respective agencies.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

**Oversight** only reflects the responses that we have received from state agencies and statewide elected officials; however, other statewide elected officials were requested to respond to this proposed legislation but did not. Oversight assumes the proposal will not create a material fiscal impact.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
