§523.010 – Eminent Domain for Utility Purposes

Officials from the Office of the State Courts Administrator, the Missouri Department of Transportation, the Attorney General's Office, the Department of Commerce and Insurance, the Department of Economic Development, the Department of Natural Resources, the Missouri Department of Conservation, the Office of Administration, the City of Kansas City and the City of Springfield each assume the proposal will have no fiscal impact on their respective organizations.
