## FISCAL ANALYSIS

## ASSUMPTION

Sections 227.842, 227.843, 227.844, 227.845, 227.846, 227.847, 227.848, 227.849, 227.851, and 227.852 – Road Naming

Officials from the **Missouri Department of Transportation (MoDOT)** state HB 1662 is estimated to have a total negative impact on the State Road Fund of \$40,000. This would be a one-time expense as the language requires MoDOT to fund these designations with no costs for sign fabrication and installation recouped through participation fees. The estimated cost is \$2,000 per sign, 2 signs per designation (\$4,000), with 10 designations within this bill (\$40,000).

**Oversight** has no information to the contrary. Therefore, Oversight will present the fiscal impact of this proposal as provided by MoDOT.
